Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of Plan

The following description of Ideal Impact, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan was established on January 1, 2013 by Ideal Impact, Inc. (the “Plan Sponsor”) to provide retirement income for its employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is a defined contribution plan covering all eligible employees of the Plan Sponsor who have elected to participate. The Plan has been amended throughout the years to comply with tax legislation. The Plan’s trustee and recordkeeper is Ascensus Trust Company (the “Trustee”).

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”) was passed by Congress. The CARES Act contained several provisions that temporarily impact 401(k) plans, including the waiver of required minimum distributions, a new hardship withdrawal option, increased loan limits, and a pause option for loan payments. The provisions of the CARES Act were effective and operationalized immediately, prior to amending the Plan document. The Company has adopted certain relief provisions included in the CARES Act, and an official amendment is expected to be signed on or before December 31, 2025.

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act (“Secure 2.0 Act”) was passed by Congress. The Secure 2.0 Act contains numerous provisions that impact employee benefit plans. Generally, the deadline for formally adopting any required plan amendments made pursuant to the Secure 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effective dates of each new provision. The Plan has administratively complied with and adopted all applicable provisions of the Secure 2.0 Act for the years ended December 31, 2024 and 2023. Plan Sponsor expects the Plan to be formally amended prior to the Secure Act 2.0 deadline.

#### *Eligibility*

Employees are eligible to participate in the Plan after attaining the age of 18 and completion of four consecutive months of service. The employee enters the Plan on the first day of the month following the completion of the eligibility requirements.

#### *Participant Contributions*

The Plan is a contributory plan whereby participants may make pre-tax and/or Roth 401(k) contributions up to a maximum of 100% of eligible compensation, not to exceed the dollar limit set by law of \$23,000 for 2024. Participants age 50 or older may elect to defer up to an additional \$7,500 of “catch up” contributions to the Plan. In addition, participants may also contribute amounts representing distributions from other qualified plans described in Code section 401(a) or 403(a), excluding after-tax employee contributions.

The Plan Sponsor may, at its discretion, elect to make a matching contribution or profit-sharing contribution to the Plan. There were no matching contributions made by the Plan Sponsor for the year ended 2024.

### 1. Description of Plan (Continued)

#### *Participant Accounts*

Each participant's account is credited with participant contributions, the Plan Sponsor's contributions and profit-sharing contribution, and Plan investment earnings and losses and an allocation of administrative expenses, if applicable. Participants may choose to have their account balance deposited in various investment programs. Allocation of Plan investment earnings is based on the participant's account balance, as defined.

#### *Investment Options*

Participants may self-direct contributions into various investment options with differing risk and growth characteristics. The investment options include mixes of mutual funds and a group annuity contract. Participants may change their investment options at any time.

#### *Vesting*

Participants are immediately vested in their contributions and actual earnings thereon upon entering the Plan.

Each participant attains a vested and nonforfeitable right in the Plan Sponsor's matching and profit-sharing contributions according to the following schedule:

<u>Years of Service</u>	<u>Percentage Vested</u>
Less than 1 year	0%
1 year	20%
2 years	40%
3 years	60%
4 years	80%
5 years or more	100%

Notwithstanding the above, a participant becomes fully vested upon reaching normal retirement age of 65, death or disabled (medically determined and expected to last at least 12 months), or upon the termination of the Plan.

#### *Participant Notes Receivable*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Sponsor. Loans can be used for many purposes, such as purchase of a principal residence or medical expenses, among others listed in the plan document. The loans are secured by the balance in the participant's account. Interest rates on participant loans range between 4.25% and 8.75% as of 2024. Principal and interest are paid ratably through payroll deductions or participant payments. The unpaid balance of any loan is immediately payable upon termination of employment and maybe offset against the participant's vested account.

#### *Payments of Benefits*

Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the Plan agreement. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment.

##### *Payments of Benefits (Continued)*

Participants experiencing financial hardship may withdraw a portion of this account balance as defined in the Plan. The Plan allows for in-service distributions subject to Plan provisions. If a participant terminates employment and the participant's account does not exceed \$1,000, the Plan Sponsor will authorize the benefit payment without the participants' consent.

##### *Forfeited Accounts*

Forfeited non-vested accounts may be used to pay plan expenses or reduce future Plan Sponsor contributions. As of December 31, 2024 and 2023, there were no forfeiture balances.

#### 2. Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

##### *Use of Estimates*

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates which estimates may require revision in future periods.

##### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. The average cost basis is used to determine gains or losses on dispositions of securities. Interest income is accrued as earned and dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments consists of realized gains and losses and the change in unrealized gains and losses in the Plan's investments.

Realized gains and losses from the sale of investments are computed using the participant's cost basis in the investment aggregated at the Plan level. Net changes in unrealized appreciation/depreciation in investments represent the difference between the fair value of investments held at year-end and the cost of investments purchased in the current fiscal year or the fair value of investments held at the end of the preceding year.

##### *Participant Notes Receivable*

Participant notes receivable are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on participant notes receivable is recorded when earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### 2. Summary of Significant Accounting Policies (Continued)

##### *Participant Notes Receivable (Continued)*

Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Related fees are charged against the account balance of each active participant responsible for the expense.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Administrative Expenses*

The Plan's expenses are paid either by the Plan or the Plan Sponsor, as provided by the Plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Amounts paid by the Plan for certain administrative fees were \$1,960 for the year ended December 31, 2024.

##### *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as excess contributions owed to participants. As of December 31, 2024 and 2023, the Plan had \$24,522 and \$5,743 recorded as excess contributions payable, respectively.

#### 3. Information Certified by the Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and supplemental schedule is complete and accurate: investments in the statements of net assets available for benefits as of December 31, 2024 and 2023; net appreciation in value of investments and interest and dividends in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and the investment information included in the supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

#### 4. Fair Value Measurements

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the following fair value measurement.

#### 4. Fair Value Measurements (Continued)

*Level 1* – quoted prices in active markets for identical assets or liabilities;

*Level 2* – inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

*Level 3* – unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Money market funds* – Valued using fair value based on the outstanding balance.

*Mutual funds* – Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. **Related-Party and Party-In-Interest Transactions**

Participant loan and distribution processing fees, and participant administration fees are paid to the Trustee by participants. The Plan paid for third party administrator fees which qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules under ERISA.

#### 6. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### 7. **Plan Termination**

Although they have not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time by resolution of its Board of Directors subject to the provisions of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan shall become fully vested and non-forfeitable.

#### 8. **Tax Status**

The Plan uses a prototype plan document sponsored by Ascensus, LLC. Ascensus, LLC received an opinion letter from the IRS, dated June 30, 2020, which states that prototype document, as then designed, satisfies the applicable provisions of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the date of the opinion letter, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 9. **Non-Exempt Prohibited Transactions**

During 2024, the Plan Sponsor failed to timely remit to the Plan withheld employee contributions in the aggregate amount of \$4,622 in accordance with the plan asset provision of the Department of Labor Regulation 2519.3-102, resulting in prohibited, or nonexempt, transactions. The accompanying schedule of delinquent participant contributions discloses these transactions with the Department of Labor's Rule and Regulations for Reporting and Disclosure under ERISA.

### **10. Subsequent Events**

The Plan's management has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued. No event has occurred subsequent to December 31, 2024 requiring recording or disclosure in these financial statements.
