Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Ampler Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 – Plan Description

The following description of Ampler Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of various entities within the Ampler Restaurant Group (the "Company") who have completed 60 days of service and are age 21 or older. The Plan does not cover employees under a collective bargaining agreement or residents of Puerto Rico. Effective November 15, 2024, the Plan was amended to include hourly maintenance staff in addition to the hourly managers that were previously eligible under the March 1, 2022 amendment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 are eligible to make catch-up contributions, which are also subject to IRS limitations. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company is authorized under the Plan to make discretionary matching contributions on behalf of all eligible participants. If the Company elects to contribute a discretionary matching contribution, it will equal a percentage of salary deferrals each eligible participant made. The Company currently provides employer matching contributions of 50 percent of the participant's contribution up to 10 percent, with a maximum of 5 percent of the participant's compensation. The Company match does not apply to catch-up contributions. The employer matching contributions for the year ended December 31, 2024 were \$531,333.

The Company may make additional annual discretionary contributions, as approved by the management of the Company. No such amounts were contributed in 2024.

Certain participant contributions made in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions along with lost earnings in 2025.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balances or \$50,000 reduced by the highest outstanding loan balance during the preceding 12-month period as of the date of the new loan. Loan terms generally range from one to five years, unless used for the purchase of a principal residence. The maximum number of loans that may be outstanding at one time is two. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate. Principal and interest are paid ratably through monthly payroll deductions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested on employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service.

Participants who leave the Plan because of death, early or normal retirement, or disability retirement, as defined in the plan document, are considered 100 percent vested.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the value of the vested balance of a participant's account. The Plan also allows for in-service withdrawals after a participant has reached 59½ years of age. Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$38,294 and \$53,343, respectively.

The Plan used \$25,215 for the year ended December 31, 2024 to reduce employer contributions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Lincoln Financial Group Trust Company, Inc., Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, or their affiliates. Lincoln Financial Group Trust Company, Inc., Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, or their affiliates are the trustees of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 – Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except as noted below. The mutual funds are valued at quoted prices reported in active markets.

The Plan allows participants to invest in a self-directed brokerage account. The self-directed brokerage account includes various investments in publicly traded securities and interest-bearing cash. The investments in publicly traded securities are valued at quoted prices reported in active markets. The interest-bearing cash is valued at fair value based on its outstanding balance.

The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. See Note 6 for additional information.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized gains and losses on investments include gains and losses on investments bought and sold, as well as held, during the year.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 9, 2025, which is the date the financial statements were available to be issued.

Note 3 – Certified Information

Effective November 20, 2024, the Plan changed its trustees from Lincoln Financial Group Trust Company Inc. to Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (collectively, the "Trustees"). The Trustees of the Plan hold certain of the Plan's investments and participant notes receivable and executes all related transactions. The investment balances (other than the self-directed brokerage accounts) and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustees. Self-directed brokerage account balances at December 31, 2024 and 2023 and related investment gain of \$75,637 for the year ended December 31, 2024 were not certified.

Note 4 – Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax- exempt status. The Plan has not individually sought its own determination letter.

Note 5 – Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 6 – Investment Contract

The Plan held a benefit-responsive investment contract with Lincoln Financial Group (Lincoln) during 2023 and for the period from January 1, 2024 through November 21, 2024. This contract was liquidated during November 2024 at contract value. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a quarterly basis for resetting but will be between 1.00 percent and 3.00 percent. When establishing interest crediting rates for this product, Lincoln considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

For the period from November 21, 2024 through December 31, 2024, the Plan has a benefit-responsive investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but will be between 0.15 percent and 3.00 percent. When establishing interest crediting rates for this product, Principal considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable.

There are certain events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value. Such events include the following: (i) breach of material obligation under the contract, (ii) violation of the Plan's investment guidelines, (iii) misrepresentation of material information or failure to furnish information, or (iv) material amendment to the agreement without the consent of the issuer.
