NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of Claxton-Hepburn Medical Center 403(b) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Claxton-Hepburn Medical Center (the Hospital or Employer) who have elected to participate. Management administers the Plan in accordance with its terms and applicable laws and has all necessary and appropriate powers to carry out the provisions of the Plan. Hand Benefits & Trust Company (Hand) and Lincoln Life and Annuity Company of New York (Lincoln) are custodians of the Plan's assets. Hand provides record-keeping services to the Plan.

Eligibility

Participants that are New York State Nurses Association (NYSNA) union members become eligible for employer matching and qualified non-elective contributions on the closest January 1st or July 1st after 1,000 hours of service over a 12 month period. Participants that are Service Employees International Union (SEIU) 1199 union members become eligible for employer matching on the closest January 1st or July 1st after 750 hours of service over a 12 month period. SEIU 1199 union members are not eligible for qualified non-elective contributions. Non-union members become eligible for employer and qualified non-elective contributions immediately upon hire. Participants become eligible for employee contributions immediately upon hire. There is no age requirement for employee or employer contributions.

Contributions

Participants may make voluntary contributions subject to certain limitations of the Plan and Internal Revenue Code (the Code). The Plan provides for matching contributions up to 1%, 2% or 3% of eligible compensation and makes an additional fixed contribution to the Plan amounting to 3% of eligible compensation provided the employee meets the service requirement and was employed on the last day of the Plan year. The level of each participant's match percentage and additional fixed contribution is based on whether the participant is a union or non-union employee, and which union the employee belongs to if the participant is a union employee.

Investments

The Plan currently offers mutual funds and fully benefit responsive guaranteed investment contracts. A portion of investments are held in pooled separate accounts held with Lincoln, but participants are no longer able to direct contributions to those funds. Participants may change their investment options daily.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer contributions, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their voluntary contributions plus earnings and losses thereon. Union members employed under collective bargaining agreement are also immediately vested in the organization's matching contributions and qualified non-elective contributions made by the organization and the actual earnings or losses thereon. Non-union members become 100% vested after three years of service. The Hospital does not have an incremental vesting schedule therefore participants are fully vested after they complete the minimum years of service.

Forfeitures

Forfeited accounts can be used to pay Plan expenses or offset future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$43,913 and \$27,789, respectively. There were no reductions of plan expenses or employer contributions from forfeited nonvested accounts during the years ended December 31, 2024 and 2023. The balance of forfeited nonvested accounts at December 31, 2024 has been applied against the payment of the employer contribution receivable paid to the Plan in 2025.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at prime rate, as defined. Principal and interest is paid ratably through bi-weekly payroll deductions or directly by participants.

Payment of Benefits

Upon termination of service due to death, retirement or other reasons, a participant or beneficiary will receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment. A participant may also request a withdrawal upon attainment of age 59 1/2. Participants may request a withdrawal from their rollover funds at any time.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from participant accounts. All hardship withdrawals must comply with rules relating to hardships, which are uniformly applicable to all participants.

Administrative Expenses

Administrative expenses of the Plan for the years ended December 31, 2024 and 2023 were paid by the Plan participants as a reduction of investment income.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

The Plan's investment in registered investment companies and pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's investments in fixed annuity contracts and a stable value fund are fully benefit-responsive and are stated at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. All investments are participant directed.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Allowance for Credit Losses

The Plan records a receivable for the employer contribution that is remitted to the Plan subsequent to the Plan's year-end. The Plan considers an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. The Plan has not experienced any historical credit losses relative to contributions receivable and future economic conditions are not expected to change relative to historical financial information, therefore management has determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023.

Benefits Paid to Participants

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan that are paid directly by the Hospital are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses presented on the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented on the accompanying statements of changes in net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan provides for various investment options in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amount reported in the statements of assets available for benefits.

Fair Value Measurement

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC Section 820 are described below:

- Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded. (Level 1)

Pooled separate accounts: Units of pooled separate accounts are valued at each accounts NAV as determined by Lincoln as a practical expedient to estimate fair value.

There have been no changes to the valuation techniques used during 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan custodians, Hand and Lincoln.

(a) In accordance with the FASB authoritative guidance regarding fair value measurement, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

The Plan invests in pooled separate accounts of Lincoln which are designed to mimic the investment returns of traditional equity and fixed-income markets. The fair value of these investments has been estimated using the net asset value per share of the investments as provided by Lincoln.

5. GUARANTEED INVESTMENT CONTRACTS

The Plan invests in a MetLife Stable Value Fund (the Fund) and a group annuity contract held by Lincoln which hold fully benefit responsive investment contracts provided with guaranteed principal and accrued interest, based on credited interest rates, for participant-initiated withdrawals as long as the contracts remain active.

Because the Plan's investment in guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Therefore, the guaranteed investment contracts are presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

5. GUARANTEED INVESTMENT CONTRACTS (Continued)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents, including complete or partial Plan termination or merger with another plan or (2) bankruptcy of the plan sponsor. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

6. PARTY-IN-INTEREST TRANSACTIONS

Lincoln and Hand are custodians of the Plan's assets; Benefit Plans Administrative Services, LLC (BPAS) is the Plan recordkeeper; and the Hospital is the Plan sponsor. As such, transactions between Lincoln, Hand, the Hospital, and the Plan qualify as party-in-interest transactions. Additionally, certain plan assets consist of notes receivables from participants, which qualify as party-in-interest transactions.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the trustees of the Plan have the right to terminate the plan at any time, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants would become fully vested and nonforfeitable. All distributions would be made in accordance with any applicable requirements of ERISA and the Internal Revenue Code (the Code).

8. TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the IRC. A prototype document was used by the Plan to obtain its latest opinion letter on March 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

9. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
