INDEPENDENT AUDITORS' REPORT

To the Board of Trustees of

Opinion

1. Description of the Plan

The following description of the Bio-Rad Laboratories Health and Welfare Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established by Bio-Rad Laboratories, Inc. (the “Company”) on May 1, 1978, to provide health and welfare benefits to employees of the Company. In updating certain provisions of the Plan document and ensuring continued compliance with applicable law, the Plan was most recently restated effective September 1, 2014. The Plan, as restated, is intended to comply with Sections 79, 105, 106, 125, and 129 of the Internal Revenue Code (“IRC”) and Section 3(1) of the Employee Retirement Income Security Act of 1974 (“ERISA”).

As a result of a provider change beginning in 2024, the contract with Delta Dental was terminated starting January 1, 2024, and the contract with Standard was amended starting January 1, 2024, to terminate all lines of coverages except the Plan’s guarantee issue coverage that continues to be provided through Standard. The carrier that now provides these benefits is Sun Life, effective January 1, 2024.

Plan Administration

The Company is the administrator of the Plan. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. The Company pays for all necessary and proper expenses incurred in the administration of the Plan by making additional contributions to the Plan or paying directly to vendors. Such expenses primarily comprise consulting fees, auditing fees, and expenses relating to the maintenance of the Plan’s records.

Administrative Expenses

Some administrative expenses are paid from Plan assets, provided that such expenses meet the laws and regulations relating to the Plan. For the year ended December 31, 2024, the amount of \$1,096,082 was paid in administrative, consulting and auditing fees to the Plan’s third-party service providers.

Eligibility and Enrollment

All active, regular status employees working at least 20 hours per week are eligible to participate in the Plan. The following individuals are ineligible for coverage: leased and temporary employees, independent contractors, and dependents who are full-time members of the armed forces. Employees classified as “casual” are eligible for medical insurance only. Dependent family members are eligible for medical, dental, vision, employee assistant program (“EAP”), additional life insurance, additional accidental death and dismemberment (“AD&D”) insurance, disability insurance, voluntary hospital indemnity insurance, critical illness insurance. Eligible dependents are a legal spouse or qualified domestic partner and children to age 26. Newly hired employees must make their benefit elections within 31 days of their hire date. Coverage begins on the hire date.

The Plan provides medical (both insured and self-insured), dental (both insured and self-insured), vision insurance, EAP, family planning, legal insurance, life insurance, AD&D insurance, disability insurance, business travel accident (“BTA”) insurance, voluntary hospital indemnity insurance, critical illness insurance, and accident insurance.

1. Description of the Plan, continued

Benefits

Premiums for insured benefits are paid to the insurance company from the general assets of the Company. Claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative service only arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payment to providers and participants is retained by the Plan.

The Plan also provides for the continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

Contributions

The Plan funding is provided by both the Company and its eligible employees, depending upon the coverage requested.

Employee contributions toward the cost of health care coverage are determined from a schedule of deductions from payroll depending on the participant's coverage elections. Employees make their coverage elections from a variety of options detailed in the benefits handbook. Currently, the Company offers four medical plans in most locations: the Anthem \$750 Preferred Provider Organization ("PPO") Plan, the \$2,000 Anthem Health Savings Account ("HSA") Plan, the \$2,000 Kaiser HSA Plan and the Kaiser Health Maintenance Organization ("HMO") Plan. In addition, employee contributions include their cost for dental and vision coverage.

The \$2,000 Anthem HSA Plan and the \$2,000 Kaiser HSA Plan are high-deductible plans paired with an HSA. HSA contributions are used to pay medical expenses. These accounts are employee owned, roll over each year and never expire.

Medical insurance, dental insurance, vision insurance, legal insurance, additional life insurance, voluntary AD&D insurance, hospital indemnity insurance, critical illness insurance, and accident insurance are available to eligible participants at a low cost.

The Company pays the entire cost for EAP, family planning, basic life insurance, AD&D insurance, disability insurance, and BTA insurance. Legal insurance, hospital indemnity insurance, critical illness insurance, and accident insurance are paid by employees.

The Company offers a before tax health flexible spending account and a dependent care flexible spending account. under the scope of an IRC Section 125 cafeteria plan. within 90 days of the Plan year end are forfeited to the Company. These are fully funded by participant pre-tax contributions. Any of these funds unclaimed by participants. Forfeitures totaling \$44,623 were returned to the Company for the year ended December 31, 2024.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured medical benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan maintains its books and records on the cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. The Plan reports additions to net assets when cash is received and deductions from net assets when cash is expended.

The Company remits weekly lump-sum payments to Anthem, who assumes responsibility for issuing individual claim disbursements.

Investment Valuation and Income Recognition

The Plan has no investments as of December 31, 2024 and 2023.

Interest income is recorded and added to the cash balance as earned. No interest income was earned for the year ended December 31, 2024.

3. Related-Party Transactions and Party-in-Interest Transactions

During the normal course of the Plan's activity, hundreds of transactions take place on a monthly basis. These transactions are related to claims submission, payment, reimbursements, employee and Company contributions, and transfers of funds between certain bank accounts, among others. During this process, various third-party administrators participate in the Plan's functions and transactions execution. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

4. Benefits Paid and Insurance Premiums

The Company's PPO option is partially self-insured up to a predetermined stop-loss amount. Benefits paid in the excess of the stop-loss amount are subject to insurance reimbursement to the Plan by the insurer. Reimbursements in the amount of \$652,602 were received for the year ended December 31, 2024.

In addition to the PPO plans, employees in certain locations have another medical coverage option, HMO. The HMO has a low out-of-pocket cost, and most eligible services are covered at 100% after a co-pay.

Medical, dental and flexible spending account claims incurred but not reported and claims reported but not paid at December 31, 2024 was approximately \$6.5 million.

5. Tax Status

The voluntary employees' beneficiary association ("VEBA") trust of the Plan received an exemption letter from the Internal Revenue Service dated February 25, 1980, stating that the VEBA trust is tax-exempt under the provisions of Section 501(c)9 of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded for the years ended December 31, 2024 and 2023 for unrelated business taxable income.

5. Tax Status, continued

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan's administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax year in progress.

6. Plan Termination

The Company has established the Plan with the intention and expectation that the Plan will continue indefinitely. However, the Company reserves the right at any time to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, all assets, if any, remaining in the Plan after payment of all its obligations will be paid or used for the continuance of one or more of the benefits offered by the Plan until such assets are exhausted.

7. Risks and Uncertainties

All Plan contributions are based on certain cost assumptions pertaining to interest rates, health care inflation, and health care system regulatory environment and employee demographics. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these costs and assumptions in the near-term would-be material to the Plan's financial statements.

8. Subsequent Events

The Plan evaluated subsequent events for recognition and disclosure through October 13, 2025, the date which these financial statements were available to be issued. Management concluded that, other than disclosed below, no material subsequent events have occurred since December 31, 2024 that would require recognition or disclosure in these financial statements.

Effective January 1, 2025, the Kaiser HMO medical plan in California was terminated.


