To the Trustees

Murfreesboro Medical Clinic, P.A. Restated Employee Savings and Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Murfreesboro Medical Clinic, P.A. Restated Employee Savings and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A - DESCRIPTION OF PLAN

The following description of the Murfreesboro Medical Clinic, P.A. Restated Employee Savings and Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which was established on April 1, 1984 and most recently amended or restated in January 2022. The Plan provides retirement benefits for employees of Murfreesboro Medical Clinic, P.A. (the "Plan Sponsor"). The Plan covers all employees who are age twenty-one or older and have completed 1,000 hours of service ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may make a minimum contribution of 1% to a maximum of 100% of their total annual compensation, as defined in the plan agreement, subject to certain IRC limits. Participants may designate all or a portion of their contributions as Roth deferral contributions at the time their deferral election is made.

The Plan is designed as a safe harbor 401K plan that makes matching contributions in an amount equal to 100% of the first 3% and 50% of the next 2% of the participant's contributions.

The Plan also provides that the Plan Sponsor may contribute each year a discretionary profit sharing contribution in an amount authorized by the Plan Sponsor's Board of Directors; however, an annual discretionary profit sharing contribution is not required. To be eligible for the discretionary profit sharing contribution, a participant must be employed on the last day of the plan year and must have completed 1,000 hours of service during the plan year, unless the participant became permanently disabled, retired, or died during the plan year. During 2024, the Plan Sponsor contributed 2% of a participant's compensation (subject to IRS wage limitations) plus 2% of the amount that exceeded 80% of the social security wage base. During 2023, the Plan Sponsor did not contribute a discretionary profit sharing contribution.

As the Plan is considered top heavy in each plan year, the employer made the additional required contributions for non key employees equal to 3% of compensation.

Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

Participant Accounts

Each participant's account is credited or charged with the participant's contributions, allocations Plan Sponsor contributions, investment earnings or losses, and administrative expenses. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their elective salary deferral contributions and Plan Sponsor matching contributions plus actual earnings or losses thereon. Vesting in the Plan Sponsor's discretionary profit sharing contributions plus earnings or losses thereon is based on years of continuous service. Participants vest ratably at 20% after two years of service and each year thereafter until fully vested after six years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balances in the participants' accounts and bear interest at a stated rate of prime plus 1%, ranging from 4.25% to 9.50% at December 31, 2024, which is commensurate with local prevailing rates. Principal and interest are collected ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, permanent disability, or retirement, a participant with an account balance that exceeds \$5,000 may receive a lump-sum payment in cash equal to his or her entire account. For termination of service due to other reasons, a participant with an account balance that exceeds \$5,000 will be entitled to receive only the vested interest in his or her account. If the vested value of a participant's account is less than \$5,000, the total vested balance is distributed as an automatic lump-sum payment in cash. Participants who have any portion of their account balance that was transferred from the Murfreesboro Medical Clinic, P.A. Restated Money Purchase Plan may elect to receive a lump-sum payment in cash or a joint and survivor annuity in monthly installments over a specified period equal to his or her entire account balance.

Forfeited Accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor discretionary profit sharing contribution portion of their accounts. Such forfeitures may first reduce Plan expenses or reduce the Plan Sponsor's contributions to the Plan. During 2024 \$91,179 and \$4,858 was used to reduce the Plan Sponsor's contributions to the Plan and reduce Plan expenses, respectively. During 2023, \$1,580 was used to reduce Plan expenses. Forfeited nonvested amounts available for use at December 31, 2024 and 2023 amounted to \$96,366 and \$78,597, respectively.

Hardship Withdrawals

The Plan permits distributions in the event of a financial hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59 1/2. Hardship withdrawals are limited to the participant's elective account balance.

Administrative expenses

Certain expenses for maintaining the Plan are paid by the Plan or the Plan Sponsor. Administrative fees incurred are netted with credits received from revenue sharing. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value. The Plan's investments in the stable value fund are stated at contract value which approximates fair value. Refer to Note D for additional information about fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based on the terms of the plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America which requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE D – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

(i) *Mutual funds*: Valued at the net asset value of shares held by the Plan at year end based on a quoted price in an active market.

(ii) *Stable value fund*: Valued at contract value, which approximates fair value, based on the amount the Plan Sponsor would receive if they terminated the contract at the reporting date, which is book value less an early withdrawal charge, discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. The stable value fund provides for daily redemptions by the Plan at contract value with no advance notice requirement. See Note E for additional contract provisions of the stable value fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan is party to a benefit-responsive investment contract with an insurance company, John Hancock Trust Company, LLC. The insurance company maintains the stable value fund in a pooled account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract is included in the financial statements at contract value, which approximates fair value, as reported to the Plan by the custodian. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment without restrictions.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. As of December 31, 2024, the contract value of this investment was \$2,547,174. The average yield and interest rate credited to participants was approximately 3.70% and 4.00% for the years ended December 31, 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on an annual basis for resetting.

Generally, there are no events which would limit the Plan's ability to transact at contract value with participants.

The stable value fund does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. At contract termination, the Plan may receive a book value distribution of the Plan's interest in the fund once the Plan Sponsor provides a twelve month advance written notice.

NOTE F - TAX STATUS

The Plan adopted a preapproved non standardized plan sponsored by John Hancock Life Insurance Company effective January 1, 2022. The non standardized plan sponsored by John Hancock Life Insurance Company received a favorable opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020. The Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G – RELATED PARTY TRANSACTIONS

Plan investments in the mutual funds and stable value fund are held with John Hancock Trust Company, LLC, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan also holds notes receivable from participants which qualify as party-in-interest transactions.
