The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Lincoln Technical Institute, Inc. (the “Company”) 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

***General***

The Plan, which was established on January 1, 1995, is a defined contribution plan covering all eligible employees of the Company who are age 18 or older for the purpose of elective deferrals and employer matching contributions. The Company controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

***Contributions***

Each year, participants may contribute up to 75% of pretax annual compensation, as defined, in the Plan subject to certain Internal Revenue Code (“IRC”) limitations. Participants may also contribute amounts representing distributions from other qualified defined contributions plans. The Company will make matching contributions for employees who are governed by a collective bargaining agreement in Mahwah, Allentown and Philadelphia locations equal to 30% of the employee’s contributions up to a maximum of 6% of eligible compensation not to exceed \$3,000 per year and for employees who are governed by a collective bargaining agreement in Nashville and Queens locations, 30% of their contribution up to 6% of eligible compensation. During 2024 and 2023, the Company made matching contributions for employees not governed by a collective bargaining agreement equal to 15% of the employee’s eligible compensation not to exceed 6% of the employee’s total eligible compensation. New employees that do not make an official election to participate or not to participate in the Plan are automatically enrolled in the Plan at a 3% contribution rate.

***Automatic Re-Enrollment***

Effective January 1, 2023, the Plan was amended to re-enroll to a 3% deferral election any participant who had a pre-tax deferral election of less than 3% in effect on January 1, 2023 to be withheld from a participant’s compensation on or after March 1, 2023. This 3% of eligible pay will be automatically deducted, each pay period, beginning with first paycheck in March 2023, and contributed to the Plan, unless a participant elects otherwise.

***Participant Accounts***

Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, and allocations of Company discretionary contributions, participant forfeitures and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Investments***

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan currently offers one collective trust fund, which is the Morley Stable Value Fund, and 13 other investment options for participants. Participants also have the option to invest using Investmap. Participants who have not made an investment election will default to using Investmap. Investmap is a tool that enables the Plan sponsor to deploy an age-based, asset-allocation strategy for the core funds held within the Plan.

***Vesting***

Participants are vested immediately in their contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts is prorated in approximately 33% increments based on years of continuous service. A participant is 100% vested after three years of credited service.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of the \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any time. The loans are secured by vested balance in the participant's account and bear interest at rates 1% above the prime rate, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through semi-monthly and bi-weekly payroll deductions and the balance of the loan must be repaid within five years unless the loan is used to purchase a principal residence. As of December 31, 2024, participant loans have maturities through 2029.

***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant's (or beneficiary's as applicable) vested account balance is generally payable in the form of a lump sum distribution into another qualified plan or to an individual retirement account. The Plan provides for normal retirement at the age of age 65. The participant can take an in-service withdrawal while still employed if they have attained age 59½. Minimum required distributions apply per IRS regulations. Effective January 1, 2020, the minimum required distribution age varies based on employee's date of birth: age 70 ½ (if born before July 1, 1949), age 72 (if born after June 30, 1949 but before 1951), age 73 (if born after 1950 but before 1960), or age 75 (if born in 1960 or later).

***Forfeited Accounts***

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. The Plan document permits the use of forfeitures to either reduce future employer contributions or plan administrative expenses for the Plan year. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,908 and \$1,640, respectively. During the years ended December 31, 2024, and 2023, Company contributions were reduced by \$59,717 and \$41,987, respectively from forfeited non-vested accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities, including mutual funds and collective trust. Investment securities are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such change could materially affect the value of the participants' account balances, and the amounts reported in the financial statements.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

***Administrative Expenses***

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided by the Plan document. Management fees and operating expenses charged to the Plan for investments in the mutual funds and collective trust are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of participants who had elected to withdraw from the Plan, but had not yet been paid, as of December 31, 2024 and 2023.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. There have been no changes in the methodologies used at December 31, 2024 and 2023.

A description of the valuation techniques applied to the Plan's major categories of assets measured at fair value is as follows:

*Mutual Funds* valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Cash and Cash Equivalents* cash equivalents consist of money market fund which is valued at daily closing price as reported by the fund and is considered Level 1.

*Stable Value Fund* the stable value fund is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The Morley Stable Value Fund (the "Fund") is a collective trust fund sponsored by Principal Financial Group, Inc. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund's constant NAV of \$24 per unit. Distribution to the Fund's unit holders are declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid. It is the policy of the Fund to use its best efforts to maintain a stable NAV of \$24 per unit; although there is no guarantee that the Fund will be able to maintain this value.

**NOTE 4 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Fees paid by the Plan to Milliman, Inc. and the Charles Schwab Bank for recordkeeping and trustee services for the years ended December 31, 2024 and 2023 were \$299,521 and \$266,191, respectively.

The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

Certain administrative functions are performed by officers and employees of the Company (who may also be participants in the Plan) at no cost to the Plan.

Milliman, Inc. provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MSA") between the Company and Milliman, Inc. Some of the mutual funds that the Plan is invested in have revenue sharing agreements. Revenue from revenue sharing arrangements are remitted to the Plan and applied to pay the Plan's administrative expenses. Revenues applied to administrative expenses for the years ended December 31, 2024 and 2023 were \$139,380 and \$128,475, respectively.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their Company contributions and related earnings thereon.

**NOTE 6 - FEDERAL INCOME TAX STATUS**

The IRS has determined and informed the volume submitter sponsor by an advisory letter dated March 31, 2014 and the Company's individual determination letter dated September 27, 2016, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended and restated since receiving that determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax- exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:
