Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of CNY Fertility 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of CNY Fertility 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

Note 1 – Description of the Plan

General

The Plan is a defined contribution 401(k) savings/profit-sharing plan covering substantially all employees of CNY Fertility, PLLC (the Company). The Plan was adopted by the Company effective January 1, 1998, and is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA) as amended. The Plan is administered by the Company.

Eligibility

An employee will be eligible to become a participant in the Plan for elective deferrals after attaining the age of 21. An employee will be eligible for the matching, and profit-sharing contributions after attaining the age of 21 and completing one year of service or 1,000 hours, prior to the enrollment date. The eligibility computation period is the twelve-consecutive month period beginning on an employee's employment commencement date.

Contributions

Each year participants may contribute up to the maximum allowable pre-tax contribution as well as after tax Roth contributions as defined in the Plan. Each year the Company can elect to make a discretionary matching contribution with the approval of the Board of Directors.

Participant Accounts

A participant's account is credited with the participant's deferral contribution when funds are received from the Company after the payroll is paid. Dividends and interest are credited to participant's accounts on the payment date. Realized and unrealized gains and losses are recorded daily. Participants are provided statements of their accounts quarterly.

Vesting

Participant contributions are 100% vested at all times.

Employer discretionary matching contributions vest according to the following schedule:

Participants will be 100% vested in matching contributions if they are employed on or after their Normal Retirement Age (65) or if they die.

Note 1 – Description of the Plan (continued)

Notes Receivable from Participants

Loans to participants shall be permitted. The minimum amount of any loan shall be \$1,000. Loans cannot exceed the lesser of \$50,000 or one-half of the vested portion of the participant account balance. The term of the loan cannot be longer than five years, unless the loan qualifies as a home loan, in which case the repayment period cannot exceed 10 years. The loans are secured by the balance in the participant's account. The loan interest rate is prime plus 1%. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Upon death, total and permanent disability, retirement or termination, the participant's vested benefits are paid in a lump sum or distributed in the form of an annuity. Payment of a terminated participant's vested benefits may be deferred until his or her normal retirement date (age 65) if their account balance is over \$5,000. The Plan has a cash out provision if a participant has a vested account balance of less than \$5,000. Hardship withdrawals can be made for qualifying expenses listed in the Plan document. Benefits are recorded when paid.

Forfeitures

If a participant stops working before they are 100% vested, the part of their account that is not vested is forfeited. All forfeitures shall be used to reduce Employer contributions or to pay Plan expenses otherwise payable for the Plan year in which such forfeitures arise, and for each succeeding Plan year, if necessary, until such forfeitures are exhausted. The amount of forfeitures available at December 31, 2024 and 2023 was \$73,200 and \$44,821, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements included herein have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles and are in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Note 2 – Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments in the Plan are reported at current value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends income are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid by CNY Fertility, PLLC. Participant loan and termination fees are paid out of participant accounts.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Note 3 – Fair Value Measurements (continued)

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which a fair measurement falls is based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest bearing deposits – Valued at carrying value, which approximates fair value.

Note 4 – Related Party Transactions

The CNY Fertility, PLLC pays for administration and record keeping expenses of the Plan. Participant loan and termination fees are paid out of participant accounts. These transactions qualify as party-in-interest transactions. Some mutual funds of the Plan are investment products of Fidelity which is the asset custodian of the Plan.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will receive the total balance in their individual account.

Note 6 – Income Taxes

The Internal Revenue Service has determined by a letter dated June 30, 2020, that the Plan, Non-Standardized Pre-Approved Profit-Sharing Plan with CODA, is designed in accordance with applicable section 401 of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more than likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to tax examinations for years prior to 2021.

Note 7 – Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
