AVANGRID 401(K) PLAN

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following is a brief description of the Avangrid 401(k) Plan (the Plan) provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (IRC), covering eligible employees of Avangrid Management Company (the Company), and any of its subsidiaries or affiliates which have adopted the Plan as "Participating Employers" under the Plan provisions. At December 31, 2024 and 2023, the assets of the Plan are maintained in investment funds held by Fidelity Management Trust Company (Fidelity). The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

The Plan Administrator is the Avangrid & Subsidiaries Joint Plan Administration and Fiduciary Committee (the Plan Administrator). Avangrid, Inc. (Avangrid), the parent corporation of the Company, through its subsidiaries, delivers electricity and natural gas to retail customers and provides electricity, natural gas, energy management and other services to retail and wholesale customers in the Northeast. Avangrid was formed effective December 16, 2015 via a merger between Iberdrola USA and UIL Holdings Corporation.

Eligibility

Eligible employees shall become a Participant as soon as administratively feasible.

Contributions

Participants may authorize a pre-tax or Roth elective deferral contribution up to 75% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum additional contribution was \$7,500 in 2024 and 2023. The Plan provides that participants may deposit payments that they receive from other qualified retirement plans. Such contributions are referred to as employee rollover contributions.

Participants direct the investment of employee and employer contributions into various investment options offered by the Plan. All participants have access to additional mutual funds and ETF's through Fidelity's brokerage platform. Participants may change their investment allocation on a daily basis.

1. DESCRIPTION OF PLAN (Continued)

Contributions (Continued)

Non-Union provisions

Effective January 1, 2023, non-union employees hired on or after January 1, 2023 are automatically enrolled in the Plan at 8% of eligible compensation with an auto escalation of 1% annually. Additionally, an after-tax (non-Roth) option was added to the Plan for employee contributions.

The Company contributes to all non-union employees an amount equal to 150% of the first 8% of eligible compensation.

Union provisions

Effective January 1, 2023, certain participants, as defined, are automatically enrolled in the Plan at various rates, ranging from 6% - 7% of eligible compensation. Additionally, an after-tax (non-Roth) option was added to the Plan for employee contributions. Prior to January 1, 2023, certain participants as defined, were automatically enrolled at various rates, ranging from 4% - 7% of eligible compensation. Certain participants, as defined, also have an auto-escalation provision of 1% annually.

For eligible participants of Central Maine Power Company who are collectively bargained employees of Local No. 1837 International Brotherhood of Electrical Workers that were hired prior to May 1, 2000, the Company contributes to the Plan an amount equal to 60% of the first 5% of eligible compensation plus 50% of the next 2% of eligible compensation for a possible total match of 4% on a 7% pay reduction amount. For eligible participants hired on or after May 1, 2000, and prior to September 1, 2009, the Company contributes to the Plan a matching contribution in an amount equal to 100% of each participant's contribution up to 4% of eligible compensation. Any employee hired on or after September 1, 2009, will receive a matching contribution to the Plan equal to 150% of each participant's contribution up to 6% of eligible compensation.

For eligible participants of Central Maine Power Company who are collectively bargained employees of Local No. 1837 International Brotherhood of Electrical Workers hired on or after July 1, 2011, who are members of the Administrative and Technical Support Bargaining Unit, the Company contributes a matching contribution to the Plan equal to 150% of each participant's contribution up to 6% of eligible compensation. Such employees hired prior to July 1, 2011, receive a matching contribution of 60% of the first 5% of eligible compensation plus 50% of the next 2% for a possible total match of 4% on a 7% pay reduction.

For eligible employees of Central Maine Power Company who are collectively bargained employees of Local No. 1837 International Brotherhood of Electrical Workers who are members of the Customer Relations Center Bargaining Unit and Fiber Technicians Bargaining Unit hired on or after January 1, 2015, the Company contributes to the Plan an amount equal to 50% of the first 6% of eligible compensation. For eligible employees hired prior to January 1, 2015, the Company contributes to the Plan an amount equal to 60% of the first 5% of eligible compensation plus 50% of the next 2% for a possible total match of 4% on a 7% pay reduction.

For eligible employees of Central Maine Power Company who are collectively bargained employees of Local No. 1837 International Brotherhood of Electrical Workers who are members of the Dispatchers Bargaining Unit hired on or after January 1, 2014, the Company contributes to the Plan an amount equal to 50% of the first 6% of eligible compensation. Such employees hired prior to January 1, 2014, receive a matching contribution of 60% of the first 5% of eligible compensation plus 50% of the next 2% for a possible total match of 4% on a 7% pay reduction.

1. DESCRIPTION OF PLAN (Continued)

Contributions (Continued)

Union provisions (Continued)

Employees of Central Maine Power Company, who are collectively bargained employees of Local No. 1837 International Brotherhood of Electrical Workers, who are members of the Customer Relations Center Bargaining Unit, Fiber Technicians Bargaining Unit, and Dispatchers Bargaining Unit, and who are not accruing a pension benefit, receive a profit-sharing contribution of 6% of eligible compensation which is referred to as "Core Contributions".

Effective October 1, 2024, the contribution for employees of New York State Electric and Gas Corporation eligible for a traditional retirement benefit is 150% on the first 7% of eligible compensation. The contribution for all employees eligible for cash balance retirement benefit hired on or after January 1, 2001 and before July 1, 2010 and employees covered under the collective bargaining unit but not eligible for a pension is 150% of the first 6% of eligible compensation. Prior to October 1, 2024 employees hired prior to January 1, 2001, the Company contributed to the Plan an amount equal to 25% of the participant's contributions, up to 6% of the participant's eligible compensation as of January 1 of the Plan year. For employees hired on or after January 1, 2001, and before July 1, 2010, the Company contributes to the Plan an amount equal to 50% of the participant's contributions, up to 5% of the participant's eligible compensation. For employees hired on or after July 1, 2010, the Company contributes to the Plan an amount equal to 150% of the participant's contributions, up to 6% of the participant's eligible compensation.

Employees of New York State Electric and Gas Corporation hired on or after January 1, 2001, and before July 1, 2010, receive a profit-sharing contribution in an amount equal to \$291.67 each month during the Plan year in which the participant is credited with an hour of service, not to exceed \$3,500. These contributions are referred to as "Core Contributions."

For all eligible Pension Equity Formula participants of Rochester Gas and Electric Corporation, the Company contributes to the Plan an amount equal to 150% of the first 7% of eligible compensation. For all other employees who are not eligible Pension Equity Plan Formula participants, the Company contributes to the Plan an amount equal to 150% of the first 6% of eligible compensation.

For United Illuminating Company (UI) and UIL Holdings Corporation (UIL Holdings) participants that are members of Local 470-1 of Utility Workers Union of America, AFL-CIO Bargaining Unit No. 1, hired before April 1, 2005, and eligible for a pension benefit, the matching contribution is 150% of the first 7% of eligible compensation that is contributed to the Plan. For UI and UIL Holdings participants that are members of Local 470-1 of Utility Workers Union of America, AFL-CIO Bargaining Unit No. 1, hired on or after April 1, 2005, and not eligible for a pension benefit, the matching contribution is 150% of the first 6% of eligible compensation that is contributed to the Plan.

Effective January 1, 2023, for SCG, UI and UIL Holdings participants who are members of Local 470 1-2 of the Utility Workers Union of America, AFL-CIO Bargaining Unit No. 2, the matching contribution is 150% of the first 6% or 7% (as defined) of eligible compensation. Prior to January 1, 2023, the matching contribution was 100% of the first 2% of eligible compensation deferred and 50% of the next 2%, for a maximum employer matching contribution of 3% of compensation.

Union provisions (Continued)

Prior to January 1, 2023, the Company made discretionary enhanced employer contributions for United Illuminating Company Union participants who are members of Local 470-2 of the Utilities Workers Union of America, AFL-CIO, and SCG Union participants who are members of the SCG Milford Gas Controllers bargaining unit hired on or after July 17, 2015. These participants received an annual plan year contribution to their account equal to 4% of their total eligible compensation (referred to as "Core Contributions"). SCG Union participants who are members of the SCG Milford Gas Controllers bargaining unit hired on or after June 28, 2015, United Illuminating Company Union participants who are members of Local 470-2 of the Utilities Workers Union of America, AFL-CIO, SCG Union participants who are members of the Local 470-2 of the Utilities Workers Union of America, AFL-CIO who were hired on or after July 17, 2015 also receive an additional \$1,200 contribution prorated over the year, regardless of whether they were contributing to the Plan. Effective January 1, 2023, there are no longer Core Contributions.

For employees who are members of Local 470-1 of the Utilities Workers Union of America, AFL-CIO and who (a) are eligible for a pension, (b) were born before January 1, 1980, and (c) were hired on or after January 1, 2001, the Company makes a nonelective employer contribution to the Plan accounts of eligible participants in the amount of \$26,000 in the 2023 plan year subject to IRS limits. Any contributions limited due to IRS limits in 2023 were made in 2024.

For SCG participants who are members of Local 12000 and Local 12000-1, The United Steelworkers, AFL-CIO-CLC, the matching contribution is 150% of the first 7% of eligible compensation that is contributed to the Plan.

Effective August 1, 2024, Berkshire Gas Company participants eligible for traditional retirement benefit and all other Berkshire union employees the matching contribution is 150% of the first 6% of eligible compensation. Prior to August 1, 2024 Berkshire Gas Company employees hired on or after March 5, 2010, the matching contribution is 150% of the participant's deferral up to a maximum of 6%. For employees of Berkshire Gas Company hired prior to March 5, 2010, the matching contribution is 100% of the first 1% and 50% of the next 5% for a maximum matching contribution of 3.5% of eligible compensation.

Effective April 1, 2023, for Connecticut Independent Utility Workers Local 12924 Berkshire Gas Union participants, the matching contribution is 100% of the first 7% of compensation. Prior to April 1, 2023, for Connecticut Independent Utility Workers Local 12924 Berkshire Gas Union participants, the matching contribution was 100% of the first 1% of eligible compensation deferred and 50% of the next 5%, for a maximum employer matching contribution of 3.5% of compensation. In addition, Connecticut Independent Utility Workers Local 12924 participants hired on or after January 1, 2018, receive a discretionary enhanced employer contribution of 6% of eligible compensation, regardless of whether they are contributing to the Plan.

Effective April 1, 2023, the matching contribution for eligible Hartford Union participants is 150% of the first 6% of compensation. Prior to April 1, 2023, the matching contribution for eligible Hartford Union participants that were hired prior to December 1, 2009, was 100% of the participant's deferral up to a maximum of 5%. The matching contribution for Hartford Union participants that were hired on or after December 1, 2009, is 150% of the participant's deferral up to a maximum of 6%.

Contributions (Continued)

Union provisions (Continued)

Eligible employees of Connecticut Natural Gas Corporation are entitled to begin receiving employer matching contributions as soon as they begin making employee contributions. UWUA Local 380 employees hired after January 1, 2015, are entitled to begin receiving employer matching contributions as soon as they begin making employee contributions.

In general, employees of Connecticut Natural Gas Corporation receive a matching contribution of 100% of the participant's deferral up to a maximum which is dependent on age or years of continuous service as shown below unless otherwise specified by the Plan agreement:

The Company contributes to the Plan an amount equal to 150% of the first 7% of eligible compensation for participants subject to the collective bargaining agreement between the Company and its UWUA Local 380 (Greenwich Union) that were hired prior to January 1, 2005, and 150% of the first 6% of eligible compensation for Greenwich Union participants that were hired after January 1, 2005.

Forfeited Accounts

Forfeitures of non-vested separated participants are available to be applied toward future employer contributions only after being applied to pay administrative expenses under the plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$739,175 and \$768,149, respectively. Forfeitures in the amount of \$245,281 and \$190,008 were used to reduce administrative expenses for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contributions (b) Plan earnings and losses, and (c) administrative expenses. Allocations are based on participant earnings/losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their funds up to a maximum amount, which is the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years but may exceed five years for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account and bear interest at a rate equal to the prime rate plus 1% or 2% depending on the employee's company. The prime rate is adjusted in an overnight cycle when there are changes driven by the Federal Reserve. Principal and interest are paid ratably through payroll deductions.

Withdrawals and Distributions

Unless a participant elects otherwise, distributions are made as soon as practical after the participant's normal retirement date or actual retirement date occurs. Participants may also receive hardship withdrawals and in-service distributions under certain circumstances, as defined in the Plan Document.

Participants may receive their accumulated vested benefits held by the Plan's trustee upon termination, death or disability.

1. DESCRIPTION OF PLAN (Continued)

Administrative Expenses

Participants pay a quarterly fee to cover the cost to administer the Plan as well as investment management fees based on their investment allocation.

Vesting

Non-Union provisions

Participants are immediately 100% vested in their elective deferral contributions and employer contributions. For participants with assets transferred to the Avangrid 401(k) Plan, employer contributions made prior to the transfer continue to follow the same vesting schedule they had in place when contributed.

Union provisions

All participants are immediately 100% vested in their elective deferral contributions. Employer Core Contributions are 100% vested after 3 years of service, based on the employee's date of hire, with any forfeitures applied to reduce subsequent employer contributions. Employer matching contributions are 100% vested immediately and non-elective employer contributions are based on years of continuous service, and 100% vested after 3 years, unless otherwise stated.

Employees who are collectively bargained employees of Local 12000 The United Steelworkers, AFL-CIO-CLC or Local 12000-1 The United Steelworkers, AFL-CIO-CLC are immediately 100% vested in fixed profit sharing contributions.

Participants who had assets transferred to the Plan from the Connecticut Natural Gas Corporation 401(k) Union Plan and the UIL Holdings Corporation 401(k) Union Plan on August 2, 2021 were 100% vested in prior Company contributions when the plans merged and will continue to be 100% vested in these assets at all times.

Vesting in the Company's non-elective contributions for the Local 470-1 of the Utilities Workers Union of America, AFL-CIO (prior to January 1, 2021), Local 470 2 of the Utilities Workers Union of America (prior to January 1, 2023), and AFL-CIO participants is based on years of continuous service and in accordance with the following schedule:

For employees of Connecticut Natural Gas Corporation who are Hartford Union participants, vesting in the Company's matching contributions is equal to thirty-three and one third percent (33 1/3%) per year, with full vesting after three years. Effective April 1, 2023, the Company match is 100% vested.

Prior to April 1, 2023, for employees of Connecticut Natural Gas Corporation who were Hartford Union participants, vesting in the Company's matching contributions was equal to thirty-three and one third percent (33 1/3%) per year, with full vesting after three years.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become fully vested in their account balances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold or held during the year.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Transfers To/From Other Avangrid Qualified Plans

Prior to the plan merger on January 1, 2023, transfers were routinely made between Avangrid qualified plans as employees move between departments and union status.

Income Taxes

The Plan has received a volume submitter profit sharing plan with CODA letter response from the Internal Revenue Service (the "IRS") dated June 30, 2020, stating that the IRS does not have a ruling or determination on whether the Company's Plan qualifies under Code Section 401(a) but an employer who adopts the Plan qualifies under Section 401(a) of the Internal Revenue Code (the "IRC"), and therefore, the related trust is exempt from taxation. Subsequent to this determination by the Internal Revenue Service, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

Risks and Uncertainties

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the accompanying financial statements.

3. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2024 and 2023, as well as investment income and investment transactions for the years ended December 31, 2024 and 2023, has been derived from information provided by Fidelity Management Trust Company, the trustee of the Plan, and has been certified by them as complete and accurate.

4. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. ASC Topic 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes to valuation methodologies in 2023 or 2024.

4. FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at net asset value (NAV) of shares held by the Plan at year end. The shares of the funds trade in active markets.

Company stock: Valued at quoted market prices.

Brokerage account: Brokerage account consists mainly of mutual funds and common stock, the values of which are determined based on quoted market prices in active markets.

Common trust funds: Valued at the NAV of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no other restrictions or unfunded commitments, other than what is documented below.

The following funds classified as common trust funds do not file a 5500 as a direct filing entity (DFE), therefore, the fund's investment strategies are disclosed. The FIAM Select Emerging Markets Equity Fund seeks to provide excess returns relative to the MSCI Emerging Markets Index while maintaining similar fundamental characteristics. The Select Emerging Markets Equity strategy utilizes a disciplined investment approach that seeks to capitalize on Fidelity's fundamental research by combining qualitative stock selection with quantitative risk control. The available investment universe is comprised of emerging markets stocks rated highly by Fidelity's analysts. The discipline uses a quantitative model to constrain the magnitude of portfolio weights at a country, sector, and stock level.

This approach is designed to diversify specific risk, reduce tracking error and factor risk, and control transaction costs. The FIAM Small/Mid Cap Core strategy seeks to provide 4.0% annualized excess return relative to the Russell 2500 over a full market cycle. The portfolio is constructed to ensure that active return is primarily generated through stock selection.

The FIAM Select Emerging Markets Equity Fund and the FIAM Small/Mid Cap Core Fund are comprised primarily of common stock. Equity securities for which market quotations are readily available, are valued at the last reported sale price or official closing price as reported by a third-party pricing vendor on the primary market or exchange on which they are traded. In the event there were no sales during the day or closing prices are not available, securities are valued at the last quoted bid price or may be valued using the last available price. For foreign equity securities, when market or security specific events arise, comparisons to the valuation of American Depositary Receipts (ADRs), futures contracts, Exchange-Traded Funds (ETFs) and certain indexes as well as quoted prices for similar securities are used.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
