## INDEPENDENT AUDITOR'S REPORT

NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023

Note 1 - Description of Plan:

The following description of the I.D. Booth, Inc. Profit Sharing 401(K) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(A) General:

The Plan is a defined contribution profit-sharing 401(K) Plan covering all full-time employees of the Company who have completed three months of service and are twenty-one or older. Employees are eligible to participate in the employer profit sharing contribution after completing one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

(B) Contributions:

Each year, participants may contribute up to the maximum percentage of compensation and dollar amount permissible under Code Sections 402(g) and 414(v) not to exceed the limits of Code Sections 401(k), 404 and 415. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan does not accept rollover contributions. As of January 1, 2023, the Plan implemented an eligible automatic contribution arrangement (EACA). Effective January 1, 2023, all new hires were automatically enrolled with a 3% pre-tax deferral upon reaching eligibility (following all pre-existing eligibility requirements). All existing employees who contributed less than 3% prior to the effective date, were subject to the Plan's automatic enrollment of 3%. On the first date of each plan year, participants who did not make an affirmative election will have an automatic increase of 1% up to a maximum of 8% of compensation.

The Plan added a Safe Harbor Non-Elective Contribution beginning with the 2023 plan year. The Company is required to contribute 3% of each participant's eligible compensation. The Company may make a profit-sharing contribution percentage at the option of the Company's Board of Directors. There was no profit-sharing contribution in 2024. In 2023, the Company made a profit sharing contribution equaling to 2% of eligible compensation, and amounted to \$162,810.

(C) Participant Accounts:

Participants direct the investment of their contributions into various mutual funds offered by the Plan. As of December 2022, all assets are participant directed in mutual funds, managed by Chemung Canal Trust Company (CCTC). Each participant's account is credited with the participant's contribution and allocations of the Company's contribution, plan earnings (losses) and forfeitures of terminated participant's non-vested accounts. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(D) Vesting:

Participants are immediately vested in their contributions and employer safe harbor contribution plus actual earnings thereon. Vesting in the employer profit sharing contributions plus earnings thereon is based on years of continuous service. The Plan utilizes a six-year vesting scale, which is shown below. A participant is 100% vested after six years of credited service. On termination of service due to death, disability or retirement, a participant becomes 100% vested in employer contributions and earnings.

(E) Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows for hardship withdrawals and in-service withdrawals for participants that have attained the age of sixty-five.

(F) Forfeited Accounts:

At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$4,106 and \$10,351 respectively. These accounts are reallocated to participants in the same manner as employer contributions.

Note 2 - Summary of Significant Accounting Policies:

(A) Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting.

(B) Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

(C) Investment Valuation and Income Recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(D) Payment of Benefits:

Benefits are recorded when paid except when a benefit claim has been approved prior to year-end but paid after year-end.

(E) Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(F) Tax Status:

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Trustees believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

(F) Tax Status (continued):

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No uncertain positions requiring accrual have been taken in 2024 or 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

(G) Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(H) Administrative Expenses:

All administrative expenses are paid by the Plan sponsor, I.D. Booth, Inc., therefore there are no administrative expenses recognized by the Plan.

(I) Date of Management's Review:

Subsequent events were evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements:

Financial Accounting Standard Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets.
  - Quoted prices for identical or similar assets or liabilities in inactive markets.
  - Inputs other than quoted prices that are observable for the asset or liability.
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  - If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Cash* - The carrying amounts of cash (both interest-bearing and non-interest-bearing) and cash equivalents approximate fair value due to short-term maturity. Interest-bearing cash is classified as a Level 1 investment.

Note 3 - Fair Value Measurements (continued):

*Mutual Funds* - Valued at the net asset value NAV of shares held by the Plan at year-end. The NAV is the closing price reported on the active market on which the securities are traded. Registered Investment Companies are classified as Level 1 investments.
