Independent Auditors' Report

To the Plan Administrator, Trustees, and Participants West Coast Prime Meats LLC, Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the West Coast Prime Meats LLC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - SUMMARY OF THE PLAN

Plan Description

The following description of the West Coast Prime Meats LLC Retirement Plan (the “Plan”) provides only general information about the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was adopted on January 1, 2017 and qualifies as a defined contribution retirement plan covering substantially all eligible employees of West Coast Prime Meats, LLC, (the “Company”). This Plan was established for the purpose of providing retirement benefits to eligible employees. The Plan is intended to satisfy the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) of 1986, as amended. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was amended and restated effective March 23, 2018.

Plan Administration

The Plan is administered by the Company. American United Life Insurance Company (“AUL”) is the custodian (the “Custodian”) of the Plan’s assets.

Participant Eligibility

Company employees who are at least 21 years of age and have completed three months of service are eligible to participate in the Plan. Once the eligibility requirements have been met, employees auto enroll in the Plan on the first day of the following Plan quarter (January 1st, April 1st, July 1st, October 1st) unless they affirmatively elect not to participate.

Contributions

Each year participants may elect to contribute up to 100% of their eligible compensation to the Plan up to the maximum allowed by the IRC, which was \$23,000 for 2024. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan up to the IRC limit, which was \$7,500 for the year ended December 31, 2024. Participants may designate all or part of his or her contribution as Roth Contributions (as defined). The Plan includes automatic contribution provisions, adopted in May 2017, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 5% of their eligible compensation. The Plan also permits participants to make rollover contributions from other qualified plans.

The Plan does not permit employer contributions except for Qualified Nonelective Contributions (“QNEC Contributions”) used to satisfy certain compliance tests or correct certain compliance matters or operational errors.

Vesting

Participants are immediately vested in their contributions and QNEC contributions allocated to their account.

NOTE 1 - SUMMARY OF THE PLAN (Continued)

Investment Options

All accounts are invested in accordance with the terms of the Plan document and investment options elected by participants. Participants direct the investment of their contributions and Company contributions to their accounts into various investments offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations earnings thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes Receivable from Participants

Participant may borrow up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. The notes must be repaid within 5 years, unless for the purchase of a primary residence. The notes are secured by the vested portion of the participant's account. Principal and interest are paid ratably through payroll deductions. Participant notes bear interest at a fixed rate which is based upon the U.S. Prime rate on the date the loan is processed plus 1%.

Payment of Benefits

In the event of retirement, hardship, death, disability or termination, a participant may elect to receive a lump-sum payment or a partial withdrawal. In addition, the Plan provides for in-service distributions for participants who are at least age 59½. Any distribution received prior to the participant attaining age 59½ that is not rolled over into another qualified retirement plan is subject to a 10% federal excise tax.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("US GAAP").

Investment Valuation and Income Recognition

Investments are stated at fair value, except for investments in the AUL Stable Value Account ("Stable Value Account"), which are stated at contract value. Fair value is the price that that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value for the Plan's investments in pooled separate accounts are measured using net asset value per share ("NAV") as a practical expedient. In accordance with Financial Accounting Standards Board Accounting Standards Codification 820-10, since the Plan's investments in pooled separate accounts are measured using NAV as a practical expedient, the disclosure of the fair value hierarchy information of these investments is not applicable.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition (Continued)

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held at year-end.

The Plan offers the Stable Value Account as an investment option through the Plan's group annuity contract with AUL. The Plan's investments in the Stable Value Account are considered to be fully benefit-responsive, and therefore, are reported at contract value. See Note 5 for further information regarding the investments in the Stable Value Account.

Payment of Benefits

Benefits payments are recorded when paid.

Administrative Expenses

Certain administrative expenses related to operating and maintaining the Plan are paid by the Plan; however, other administrative expenses are absorbed by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Non-Discrimination for Employee and Employer Contributions

The Plan, as required by the IRC, performs annual compliance tests to determine that highly compensated participants are not disproportionately favored under the Plan. If the Plan fails the tests, it must either refund excess deferral contributions from highly compensated employees or make a Qualified Nonelective Contribution ("QNEC") to the Plan on behalf the non-highly compensated employees. Excess contributions are accrued as a liability on the statements of net assets available for benefits with a corresponding decrease to contributions. At December 31, 2024 and 2023, the Plan had refundable excess distributions payable of \$0 and \$39,451, respectively.

Accounting Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and deductions during the reporting period. Actual results could differ from estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Loan related fees are recorded as administrative expenses and are expensed when they are incurred. At December 31, 2024 and 2023, outstanding participants notes receivable totaled \$114,326 and \$110,747, respectively, and interest rates on the notes receivable ranged from 5% to 9.25% per annum.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S ASSET CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all of information related to investments presented or disclosed in the accompanying financial statements and supplemental schedule, held at December 31, 2024, and net depreciation in fair value of investment, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan's Custodian.

NOTE 4 - INVESTMENTS MEASURED USING NET ASSET PER SHARE

The fair value of the Plan's investments in pooled separate accounts is measured using NAV as a practical expedient. NAV of these investments is based on the value of the funds underlying assets less its liabilities, divided by the number of units outstanding. The fair value of the investments pooled separate accounts at December 31, 2024 and 2023, totaled \$4,503,067 and \$3,301,123, respectively. Generally, these investments are redeemed daily, do not have any redemption restrictions, or require any funding commitments.

NOTE 5 - INVESTMENTS IN STABLE VALUE ACCOUNT

The Plan offers the Stable Value Account as an investment option for plan participants under the Plan's group annuity contract with AUL. The Stable Value Account is held in the general account of AUL, and plan management considers it to be fully benefit-responsive. The Stable Value Account invests in a diversified portfolio consisting predominately of fixed-income investments in which the objective is to maximize long-term, risk-adjusted returns.

For fully benefit-responsive investment contracts, contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Contract value, as reported by AUL, is the beginning balance plus any deposits and credited interest, less any withdrawals, charges or expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Termination of the Plan's group annuity agreement may limit the Plan's and participant's ability to execute transactions involving the Stable Value Account at contract value as the Plan's group annuity agreement includes a provision for a market value adjustment and a surrender charge for the Stable Value Account in the event of contract termination.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants will be 100% vested in their account balances.

NOTE 7 - TAX STATUS

The Internal Revenue Service made a favorable determination in a letter dated June 30, 2020 stating that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan's trustee and sponsor are not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Plan. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 7 - TAX STATUS (CONTINUED)

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by AUL, the Plan's custodian. In addition, the Plan has notes receivable with participants. However, these transactions qualify as party-in-interest transactions for which there is statutory exemption under ERISA.

NOTE 10 – PROHIBITED TRANSACTIONS

For the year ended December 31, 2024, the Company submitted late employee contributions totaling \$209,785, to the Plan. These late remittances are considered prohibited transactions by the Internal Revenue Service ("IRS") and Department of Labor ("DOL") and may be subject to penalties and interest.

NOTE 11 - SUBSEQUENT EVENTS
