## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Miles & Stockbridge Retirement Plan

### SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Miles & Stockbridge Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### OPINION

- The information in the financial statements referred to above related to assets held and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **BASIS FOR OPINION**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

## **SUPPLEMENTAL SCHEDULE REQUIRED BY ERISA**

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and to certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1** DESCRIPTION OF PLAN

The following description of the Miles & Stockbridge Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document or the Summary Plan Description for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined-contribution plan covering substantially all employees of Miles & Stockbridge P.C. (Firm), except for temporary employees and summer associates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**CONTRIBUTIONS**

Participants may make pre-tax and Roth contributions up to 75% of their pre-tax annual compensation up to a maximum amount permitted each year by Internal Revenue Service (IRS) rules. The Firm may provide discretionary contributions. The Firm may change the amount contributed or choose to make no contributions in any year without a Plan amendment. Persons classified as Law Graduates, Associates, Associate Counsel, Counsel, Of Counsel, Non-Voting Shareholders, and persons who are not credited with at least one year of eligibility service, as defined, are not entitled to share in the Firm's contributions. The Firm consistently contributes the following amounts annually for each eligible active member in the form of basic contributions, discretionary contributions, or both:

*For Eligible Voting Shareholders and Highly Compensated Employees*

A discretionary contribution to be determined by the Firm each year and allocated to eligible participants' accounts in proportion to their compensation, not to exceed a maximum allocation equal to the IRS limit on annual additions for that year.

*For All Eligible Participants Other Than Voting Shareholders and Highly Compensated Employees*

5% of the participant's pay plus 5% of the participant's pay in excess of the Social Security taxable wage base up to the IRS compensation limits.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution and allocations of (a) the Firm's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is subject to the vesting provisions for any of the Firm's basic and discretionary contributions.

**RETIREMENT**

Normal retirement age is 65. Upon retirement, a participant can receive the participant's vested Plan account balance in a lump-sum payment.

**INVESTMENT OPTIONS**

Upon enrollment in the Plan, a participant may direct all of the participant's salary-deferral contributions and Firm contributions to various investment options offered by the Plan.

**VESTING**

The Firm's basic or discretionary contribution is fully forfeitable until the participant completes three years of vesting service credit as defined in the Plan. Upon completing three years of vesting service credit, the participant's entire Firm contribution becomes fully vested and nonforfeitable. The total account of an active participant also becomes fully vested upon the participant turning 65 years old, becoming totally and permanently disabled, or upon death of the participant while employed by the Firm. Except for the Firm's contributions, all participant contributions are fully vested.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow against the balances in their accounts, up to a maximum of the lesser of 50% of their vested balances or \$50,000. Note terms require amortization of principal and interest over a period not to exceed 30 years in the case of a purchase of principal residence, or five years otherwise. The notes receivable are collateralized by the balance in the participant's account and bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Notes receivable are repaid through payroll deductions and may be repaid in full at any time.

**ADMINISTRATIVE EXPENSES**

Certain Plan expenses are paid by the Firm. The Firm provides certain services to the Plan at no cost.

**PLAN TERMINATION**

Although the Firm has not expressed any intent to do so, the Firm has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the value of the interests of all affected participants will be determined as soon as possible and will become fully vested. A lump-sum payment of each affected participant's undistributed Plan account will be made.

**PAYMENT OF BENEFITS**

Generally, benefits are payable to participants or beneficiaries upon termination, death, turning 59½ years old, or turning 55 years old and completing at least 10 years of service, or earlier in the case of financial hardship, as defined by the Plan. Benefits from the Plan for terminated employees whose vested account balance is \$7,000 or less and who do not make payment elections shall be payable in a lump sum. Penalties may apply if payments are made prior to retirement age.

**FORFEITED ACCOUNTS**

At December 31, 2024 and 2023, the Plan's forfeited non-vested account totaled \$30,352 and \$34,806, respectively. These accounts will be used to reduce Firm contributions or restore participants' accounts previously forfeited, as necessary, in accordance with the Plan document. During the year ended December 31, 2024, the Firm's contributions were reduced by \$19,670 for forfeited non-vested amounts.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**ACCOUNTING STANDARDS CODIFICATION**

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

**BASIS OF PRESENTATION**

The financial statements are prepared on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**VALUATION OF INVESTMENTS**

Investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion of fully benefit responsive investment contracts.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**RISK AND UNCERTAINTIES**

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**SUBSEQUENT EVENTS**

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through September 17, 2025, the date the financial statements were available to be issued.

**NOTE 3 INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The Plan's investments were held by the Trustee, Principal Trust Company, at December 31, 2024 and 2023. Financial information related to those investments at December 31, 2024 and 2023 is included in the accompanying financial statements based on information certified as complete and accurate by the Trustee. The information, which was not audited by the Plan's independent auditors, is as follows:

**NOTE 4 VALUATION OF INVESTMENTS**

The Fair Value Measurements and Disclosures Topic of the Codification establishes a hierarchal disclosure framework, which prioritizes and ranks the level of market price observability used in measuring investments and other financial instruments at fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2     Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Money Market and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Collective Trusts: Valued at NAV of shares held by the Plan at year end. Collective trusts may be redeemed on a daily basis. There are no redemption notification requirements, redemption restrictions, or unfunded commitments.

Self-Directed Brokerage Accounts: Common stocks and mutual funds valued based on readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5**    **GUARANTEED INVESTMENT CONTRACT**

The Plan has an investment in the Principal Guaranteed Income Fund Account (Prudential), which is a fully benefit responsive investment contract and, therefore, reported at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with the issuers. Such events include the following: (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6**    **TAX STATUS**

The Plan obtained its latest determination letter in June 2012 wherein the IRS stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan was amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

**NOTE 7**    **RELATED-PARTY TRANSACTIONS**

Certain Plan investments were managed by the Trustee of the Plan. The Plan pays investment management, administrative, and custodial fees to parties in interest. The Plan paid \$83,380 to parties in interest for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.
