We have performed audits of the accompanying financial statements of In-Q-Tel 401(k) Safe Harbor Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1—Description of the Plan

The following description of the In-Q-Tel 401(k) Safe Harbor Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

*General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of In-Q-Tel, Inc. (the “Company”, the “Plan Sponsor”), immediately upon employment, with the exception of interns, seasonal employees, and temporary employees. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2023, the Plan was amended to redefine eligible compensation, and effective January 1, 2024, the Plan was amended to exclude student loan repayments from eligible compensation.

The Plan is administered by the Plan Sponsor. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform these responsibilities. The Plan’s assets are held in the custody of Fidelity Management Trust Company (the “qualified institution”).

*Participant Contributions* – Participants may contribute a percentage of their eligible compensation, as defined in the Plan, on a pre-tax basis subject to statutory limitations of the Internal Revenue Code (“IRC”). In addition, participants 50 years of age or older may elect to make a catch-up deferral contribution of up to \$7,500 for the year ended December 31, 2024. Distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution.

*Employer Contributions* – The Company makes a safe harbor non-elective contribution to the account of each eligible participant in an amount equal to 4% of their eligible compensation, up to an annual maximum compensation of \$345,000. Additional discretionary employer profit-sharing amounts may be contributed to employees who are employed on the last day of the Plan year. Discretionary contributions vary among different categories of employees. The Company made discretionary profit-sharing contributions and safe harbor non-elective contributions to eligible participants in the amount of \$3,663,823 for the year ended December 31, 2024. As of December 31, 2024 and 2023, \$1,947,460 and \$1,374,334, respectively, had not yet been funded.

*Participant Accounts* – Individual accounts are maintained for each participant and include participants’ salary deferral contributions, rollover contributions, matching contributions, plus an allocation of the Plan Sponsor’s discretionary profit-sharing contribution, if any, and Plan earnings (losses), including realized and unrealized gains and losses on investments, and charged with the participants distributions and the allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in all contributions, plus actual earnings thereon.

*Investment Options* – Participants may direct the qualified institution as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at the beginning of each quarter. Transfers of account balances between elected investment options may be made at the beginning of each quarter.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum amount that is equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loan terms range from one to five years (or up to 10 years for the purchase of a primary residence). All loans are secured by the balance in the participant’s account and bear interest available for similar loans from commercial lending institutions, as determined by the Plan administrator. The interest shall remain fixed throughout the duration of the loans. At December 31, 2024, interest rates ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

### Note 1—Description of the Plan (continued)

*Benefits Paid to Participants* – Upon termination of service, a participant may receive the value of his or her account as a lump-sum distribution. Participants who are required to commence receiving a distribution as a result of attaining age 72 shall receive their benefits in installment payments. In-service withdrawals may be taken at any time from a participant's rollover contribution account.

*Administrative Expenses* – The Plan is administered by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses are either paid directly by the Plan, Plan Sponsor or by the account of the participant.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Investment Valuation and Income Recognition* – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

*Benefits Paid to Participants* – Benefits paid to participants are recorded when paid.

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

*Risks and Uncertainties* – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

*Fair Value Measurement* – U.S. GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

**Note 2—Summary of significant accounting policies (continued)**

The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

*Money Market Fund* – This investment is valued at the closing price reported on the active market on which the individual security is traded and is classified within Level 1 of the valuation hierarchy.

*Mutual Funds* – These investments are public investment vehicles valued using the Net Asset Value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common Collective Trust* – This investment is a collective trust valued using NAV as a practical expedient to estimate fair value provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. In accordance with Subtopic 820-10, this investment has not been classified under the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5—Parties-in-interest**

Certain Plan assets at December 31, 2024 are invested in funds sponsored by the qualified institution. Transactions involving these investments are considered party-in-interest transactions for which statutory exemption exists under DOL Regulations. For the year ended December 31, 2024, fees paid by the Plan to the qualified institution totaled \$14,001. Notes receivable from participants also qualify as party-in-interest transactions.

**Note 6—Tax status**

The Plan utilizes a prototype Volume Submitter plan document sponsored by Fidelity Management & Research Co. Fidelity Management & Research Co. received an opinion letter on June 30, 2020, in which the Internal Revenue Service (“IRS”) stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7—Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the assets of the Plan will be distributed to the participants in accordance with the Plan provisions.

**Note 8—Revenue-sharing agreement**

The Plan has a revenue-sharing agreement with Fidelity Investments Institutional Operations Company, Inc., which is related to the qualified institution. The Plan will receive funds based on the mutual fund's balances held by Fidelity Investments Institutional Operations Company, Inc. These funds shall be placed into a "fee recapture" account, plus investments earnings and losses, to be used for Plan purposes.

During 2024, the Plan received income of \$13,018 for the fee recapture account and paid Plan expenses of \$13,018. As of December 31, 2024 and 2023, the fee recapture account balance totaled \$36,730 and is included in investments, at fair value, as shown on the statements of net assets available for benefits.
