1. PLAN DESCRIPTION

The following description of Monument Academy, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a voluntary retirement savings plan covering substantially all employees of Monument Academy Public Charter School (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees. Most recent adoption agreement dated June 17, 2022.

Recent Legislation

The Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was signed into the 2023 Consolidations Appropriations Act under the Securing a Strong Retirement Act on December 29, 2022, with retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers' cost of offering and funding retirement plans. The Plan's management and those charged with governance have a policy to incorporate these legislative changes in its Plan document by the prescribed deadlines.

Eligibility

An employee is eligible to participate in the elective deferral portion of the Plan on his or her date of hire. The Plan also offer participation to long-term part-time employees who have at least 3 consecutive years, with at least 500 hours of service in each year and attained age 21.

There is no minimum age an employee must attain to become a participant in the Plan for purposes of making voluntary deferrals. An employee must provide one year of service (1,000 hours) to be eligible for employer contributions.

1. PLAN DESCRIPTION (continued)

Contributions

Participants may elect to contribute portions of their annual compensation to the Plan, subject to certain limitations established by the Internal Revenue Code and Plan document.

Contributions are limited from 0% to 92% with increments increase by 1%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover distributions from other qualified defined benefit or defined contribution plans. Employer matching contributions equal 100% of the first 3% of contributions plus 50% of the deferral that exceeds 3% but does not exceed 6%. The Organization may contribute to the Plan a discretionary contribution determined by its board of directors. Employer profit sharing contributions are allocated based on each participant's qualifying compensation compared to total qualifying compensation. Contributions are subject to certain limitations.

Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan automatically enrolls eligible employees hired on or after January 1, 2015, who do not affirmatively elect not to participate. Participant contributions are made on a tax deferred basis, pursuant to a deemed salary reduction agreement, in which contributions total 3% of compensation during the first 2 years of participation and increase by 1% each following year up to a maximum of 6% of compensation, unless otherwise affirmatively elected by the participant.

Participants' Accounts

Each participant's account is credited with the participant's contributions and an allocation of Plan earnings and is charged with an allocation of investment management fees. Allocations of earnings and expenses are based on the participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their elective deferral and employer contributions plus earnings on those contributions.

Notes Receivable from Participants

Participants may borrow from the Plan a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balances. The Plan only allows one outstanding loan at a time. Each note receivable is secured by the balance in the participant's account and bears interest at a fixed rate. Principal and interest are paid ratably through monthly payroll deductions.

1. PLAN DESCRIPTION (continued)

Contributions

Employer and participant contributions are recorded in the period that the Plan makes payroll deductions from the participant's earnings.

Payment of Benefits

Distributions from amounts attributable to salary deferrals are not permitted before the age of 59½ except in the event of death, disability, termination of employment, or reasons of proven financial hardship. In service distributions can only be made if the participant is 100% vested.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments of the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees of Monument Academy, Inc. determines the Plan's valuation utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements.

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan administrator has evaluated subsequent events and transactions through October 6, 2025, the date these financial statements were available for issue, and has determined that no material subsequent events have occurred that would affect the information presented or require additional disclosure.

3. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation/(depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Plan administrator and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (VOYA) serves as the recordkeeper and custodian of the Plan.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund.

Variable Annuity: Prices/unit values for variable annuity investment options are calculated daily by the annuity provider according to the methods described in the annuity contract. The underlying investments are generally valued using market quotations obtained from independent pricing services.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants would remain 100% vested in their accounts.

6. TAX STATUS

The Plan is a prototype plan and obtained its determination letter dated October 6, 2025, in which the Internal Revenue Service (IRS) stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since the prototype plan received its determination letter.

However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there is currently no audit for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by VOYA. VOYA served as the custodian for the Plan during the year, and therefore, these transactions qualify as party-in-interest transactions.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
