INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries
of the Aristotle Capital Management, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Aristotle Capital Management, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Aristotle Capital Management, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

[1] General:

The Plan is a defined contribution plan covering all employees of Aristotle Capital Management, LLC, and its affiliated entities that have adopted the Plan (the "Company"), who have completed two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan became effective on July 1, 2010 and was amended and restated effective January 1, 2024.

Fidelity Management Trust Company ("FMTC") is the trustee for the Plan.

[2] Contributions:

Participants may contribute up to 50% of their eligible compensation as a pre-tax and/or designated Roth contribution, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In no event may participant pre-tax and after-tax contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Effective January 1, 2024, the Company provides a non-discretionary matching contribution on behalf of all eligible participants that have contributed to the Plan. The matching contribution is 100% of the first 6% of eligible compensation that participants contribute to the Plan. Prior to January 1, 2024, the Company provided an employer safe harbor matching contribution on behalf of all eligible participants that have contributed to the Plan. The matching contribution is 100% of the first 3% of eligible compensation that participants contribute to the Plan; and then 50% of the next 2% of eligible compensation that participants contribute to the Plan.

Discretionary profit-sharing contributions may be made at the option of the Company's board of directors to employees who are employed at the end of the Plan year and who have 1,000 hours of service. There were no employer profit sharing contributions during the years ended December 31, 2024 and 2023.

The Company provides a true-up contribution on behalf of all eligible participants who have contributed to the Plan. Beginning January 1, 2024, the true-up calculation is based on the eligible compensation, regardless of whether or not a participant is deferring that compensation. It is based on a participant's annual deferrals as a percentage of their annual eligible compensation and applying the match formula noted above (the matching contribution is 100% of the first 6% of eligible compensation that participants contribute to the Plan). Prior to January 1, 2024, it was based on a participant's annual deferrals as a percentage of their annual eligible compensation and apply the match formula noted above (the matching contribution was 100% of the first 3% of eligible compensation that participants contributed to the Plan; and then 50% of the next 2% of eligible compensation). Such amounts are reflected as Employer Contributions in the Statements of Net Assets Available for Plan Benefits.

Participants direct the investment of participant and employer contributions.

[3] Participant accounts:

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as the allocations of the Company's profit sharing contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

NOTE A - DESCRIPTION OF THE PLAN (continued)

[4] Vesting:

Employee contributions are 100% vested immediately. Vesting for fixed employer matching contributions, is 33% starting at the end of the first year of service and increases by 33% each following year of continuous service. Participants are 100% vested after three years of credited service. Safe Harbor Match contributions, if any, are 100% vested immediately. Vesting for employer profit sharing contributions, if any, is 25% starting at the end of the second year of service and increases by 25% each following year of continuous service. Participants are 100% vested after five years of credited service.

[5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. A participant may borrow up to 50% of their vested account balance subject to a maximum amount of \$50,000 less any outstanding loan balance. These notes receivable from participants bear interest at a reasonable rate which is comparable to commercial lending institutions. Notes receivable from participants are secured by the participant's vested interest in the Plan, and must be paid back within five years unless the note is for the purchase of a principal residence, in which case, the loan must be paid back within ten years from the date of the loan. At December 31, 2024 and 2023, the interest rate on notes receivable from participants ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

[6] Payment of benefits:

On termination of service due to death, disability or retirement, a participant or the beneficiary receives a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants are eligible to make in-service distributions upon attaining age 59 ½ and are also eligible to make hardship withdrawals from their deferred contribution in the event of certain financial hardships.

[7] Forfeitures:

Forfeited nonvested accounts may be used to pay administrative expenses or to reduce matching contributions and profit sharing contributions. There were no forfeited nonvested accounts at December 31, 2024 and 2023.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

[2] Subsequent events:

The Plan has evaluated subsequent events through October 8, 2025 the date the financial statements were available to be issued.

[3] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[4] Payment of benefits:

Benefits are recorded when paid.

[5] Plan expenses:

Certain administrative expenses of maintaining the Plan (such as recordkeeping fees) are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's accounts and are included in the administrative expenses.

[6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts – Valued using the Net Asset Value ("NAV") provided by the trustee of the collective trust. The NAV is based on the fair value of the underlying investments owned by the fund, minus its liabilities. The NAV is used as a practical expedient to estimate fair value, except when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

Money market fund – Valued at quoted market prices, which represent the NAV of shares held by the Plan at year-end.

NOTE D - TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with Cash or Deferred Arrangement sponsored by Fidelity Management & Research Company. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are shares of mutual funds managed by FMTC. FMTC is the Plan trustee and recordkeeper; therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan to FMTC were \$86,488 for the year ended December 31, 2024. Additionally, certain investments are shares of mutual funds or collective investment trusts that are managed by or advised by the Company.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the financial statements.

Users of these financial statements should be aware that the financial markets' volatility may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE G- MUTUAL FUND FEES

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

NOTE H – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

In the event the Plan is terminated, the participants will become 100% vested in their accounts.

NOTE I – INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly as permitted under such election, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants, and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.
