Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.



- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Plan Description

The following description of the Shoptikal 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

Shoptikal LLC (the Company or Employer) established the Plan effective August 23, 2019. The Plan is a defined contribution 401(k) plan and is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by one or more administrators appointed by the Company. The Plan was restated effective January 1, 2023. Effective January 1, 2023, the Plan was amended to allow for employees of the Company's wholly owned subsidiary, Dirk J. Warner, Inc., to participate in the Plan. Effective December 31, 2024, the Plan was merged into Fielmann USA 401(k) Plan.

#### *Eligibility*

The Plan covers all eligible classes of employees of the Company who are 18 years of age or older. Employees are eligible to participate in the Plan after completion of six months of continuous employment. Upon meeting eligibility requirements, employees enter the Plan on the next payroll date.

#### *Contributions*

Each year, participants may contribute up to 50% of annual compensation, as defined in the Plan document, to the Plan on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Plan also includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or make an alternate deferral rate election. Automatically enrolled participants have their pre-tax deferral rate set at 3% of eligible compensation and their contributions invested in a designed balanced fund until changed by the participant.

The Company has the ability to make discretionary profit-sharing contributions to the Plan. In order to qualify for these discretionary contributions, participants must (1) be at least 20 years of age; (2) have completed at least one year of service with the Company; and (3) be employed by the Company on the last day of the Plan year. No discretionary profit-sharing contributions were made for the 2024 plan year.

The Plan has a safe-harbor matching contribution equal to 100% of the first 3% of eligible compensation that a participant contributes to the Plan, plus 50% of the next 2% of eligible compensation that a participant contributes to the Plan. Eligibility requirements to receive safe harbor matching contributions are the same as participant contributions and only paid to non-highly compensated employees.

In 2024, the Company detected that certain employees were incorrectly included as highly compensated employees and excluded from safe-harbor matching contributions during the 2023 Plan year. The Plan Administrator determined the affected participants and deposited \$77,356 into the Plan on March 22, 2024 to make the affected participants and the Plan whole, including interest.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, and allocations of (a) the Company's discretionary profit-sharing contribution and (b) Plan earnings (losses). Participant accounts are charged with the withdrawals and an allocation of administrative expenses that were paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately 100% vested in their voluntary contributions and the Company's safe harbor matching contributions plus actual earnings (losses) thereon. Participants become fully vested in the Company's discretionary profit-sharing contributions after three years of service, with no vesting prior to that time. Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service during a Plan year. In the event of permanent disability or death, participants become 100% vested.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a fixed rate of prime plus 1.00% determined at the time of issuance. The note term cannot exceed five years, unless the note proceeds are used for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions. Also, each participant may not have more than one loan outstanding at any time.

### ***Payment of Benefits***

Plan benefits are available at normal retirement (age 65), disability, death, or termination of employment. Participants can elect to receive a benefit payment for the value of the vested interest in his or her account in the form of a lump-sum distribution or a partial payment. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½. Participants are allowed to withdraw their rollover contributions at any time.

### ***Forfeitures***

Forfeited nonvested accounts totaled \$0 at both December 31, 2024 and 2023. These accounts are to be used in future years to reduce Company discretionary contributions or pay administrative expenses, at the election of the Company. During 2024, there were no forfeitures used to reduce Company discretionary contributions.

### ***Investment Options***

Participants may invest the portion of their account balances into a variety of investment options offered by the Plan. Participants may change their investment options daily.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States (GAAP).

#### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company at the Company's discretion. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in the administrative expenses. Certain investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net appreciation in fair value of investments. All other expenses paid directly by the Plan are allocated to Plan participants proportionate based on their respective balances and are included in administrative expenses.

### ***Subsequent Events***

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

### **3. Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consist of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Money Market Fund and Shares of Registered Investment Companies* - Money market fund and shares of registered investment companies are valued at the daily closing price a reported by the fund. The money market fund and shares of registered investment companies held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The money market fund and shares of registered investment companies held by the Plan are deemed to be actively traded.

### 4. Transfers and Mergers

Effective on December 31, 2024, the Shoptikal 401(k) Plan merged with Feilmann USA 401(k) Plan. After December 31, 2024, the Shoptikal 401(k) Plan no longer exists as a separate plan. The Plan recorded a payable to another qualified plan of \$49,166,803 in the statement of net assets available for benefits as of December 31, 2024.

### 5. Information Prepared and Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations and Disclosure under ERISA. Accordingly, Ascensus, LLC, as agent for Ascensus Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest income on notes receivable from participants and investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### 6. Party-in-Interest Transactions

Certain Plan investments are managed by The Vanguard Group, Inc. (Vanguard). Vanguard is the investment manager and third-party service provider for the Plan; therefore, these transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan paid Vanguard fees totaling \$89,214 for administrative services. Certain investment-related fees incurred by the Plan are included in net appreciation in fair value of investments since they are paid to Vanguard through revenue sharing rather than direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Certain employees of the Company provide administrative services to the Plan. These individuals are not paid by the Plan for their services.

### **7. Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary contributions.

### **8. Tax Status**

The Plan uses a pre-approved plan document sponsored by Ascensus, LLC. Ascensus, LLC received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of this letter, the Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon the examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

Included in investments are Vanguard Target Retirement 2030 Fund, Vanguard Target Retirement 2035 Fund, and Vanguard Total Stock Market Index Fund Adm, each of which represent 10% or more of total investments at December 31, 2024 and 2023.
