## Independent Auditor's Report

To: The Plan Administrator and Participants of Masonic Health System of Massachusetts, Inc. and Grand Lodge of Masons in Massachusetts Defined Contribution Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed an audit of the accompanying financial statements of Masonic Health System, Inc. and Grand Lodge of Masons in Massachusetts Defined Contribution Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audit need not extend to any statements or information related to assets held for investment by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In my opinion, based on my audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

I conducted my audit in accordance with auditing standards generally accepted in the United States of America. My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I am required to be independent of Masonic Health System, Inc. and Grand Lodge of Masons in Massachusetts Defined Contribution Plan and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Masonic Health System, Inc. and Grand Lodge of Masons in Massachusetts Defined Contribution Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

My audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of the Plan

The following description of Masonic Health System, Inc. and Grand Lodge of Masons in Massachusetts Defined Contribution Plan, (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2000 by The Masonic Health System of Massachusetts, Inc., Overlook Masonic Health Center, Inc., Overlook Visiting Nurse Association, Inc., Overlook Communities, Inc., and the Grand Lodge of Masons in Massachusetts (collectively referred to as the Plan Sponsor, Employer or the Company). The purpose of the Plan is to accumulate retirement income for its employees that will supplement retirement benefits provided to them by Social Security Administration. The Plan is a contributory single-employer 401(k) and profit-sharing plan, under Section 401(k) of the Internal Revenue Code (the Code) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Retirement Committee of the Plan Sponsor has overall responsibility for the operation and administration of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan Sponsor is responsible for the general administration of the Plan. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) is the trustee and recordkeeper of the Plan.

Eligibility

*Employee Elective Contributions* – All non-union, non-leased employees become eligible to participate immediately upon date of hire.

*Employer Discretionary Elective Contributions* – All non-union, non-leased employees become eligible to participate on the first day of the month immediately following the completion of one year of service. Employee elective contributions must be made for Employer discretionary elective contributions to be effective.

*Employer Discretionary Non-Elective Contributions* – All non-union, non-leased employees become eligible after completing one year of service. Participants must be employed on the last day of the Plan year to participate in the current year discretionary non-elective contribution. Participants who are not actively employed at the end of the Plan year due to death, disability, or normal retirement will be eligible to participate in the discretionary non-elective contribution regardless of the above conditions.

Contributions

Each plan year, participants may elect to contribute a portion of their eligible compensation, as defined in the Plan, up to a maximum of \$23,000 in 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, up to a maximum of \$7,500 in 2024. Contributions may be pre-tax or Roth 401(k) contributions. Participants may also roll over amounts representing distributions from other qualified defined benefit or contribution plans.

Contributions (continued)

The Company, at its discretion, may make a discretionary elective contribution, equal to an amount not to exceed 50% of each participant's first 4% of eligible compensation contributed as elective deferrals. During the year ended December 31, 2024, \$249,692 of discretionary elective contributions were made.

There were no discretionary non-elective contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the employee elective contributions and the employer's discretionary elective contributions, allocations of the Company's discretionary non-elective contributions (when applicable) and plan investment earnings and reduced by an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Investment Options

Participants must direct their contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options at any time throughout the year via direct phone or online access. As of December 31, 2024, the Plan offered a selection of mutual funds and one common collective trust fund as investment options for participants.

Vesting

Participants are immediately vested in their contributions, employer discretionary elective contributions, rollover contributions plus actual earnings thereon. The portion of the participants' accounts attributable to the Company's discretionary non-elective contributions become 20% vested after the second year of service as defined in the Plan document, 40% after the third year, 60% after the fourth year, and 100% after the fifth year. An employee will become 100% vested upon death or disability.

Notes Receivable from Participants

The Plan does not allow the issuance of notes to participants.

Payment of Benefits

The vested value of a participant's account may be distributed upon death, disability, retirement or termination of employment. Benefits less than or equal to \$5,000 must be distributed in a single lump-sum payment. Benefits over \$5,000 are payable either by a single lump-sum payment or periodic installments (subject to minimum distribution rules) over a period of not more than the participant's life expectancy. Distributions to Plan participants turning 70 ½ (72 if 70th birthday is on or after July 1, 2019) are required in accordance with the Code and the Plan document.

Payment of Benefits (continued)

The Plan elected to allow for coronavirus-related distributions made available under the CARES Act, which was signed into law on March 27, 2020. A coronavirus-related distribution is a distribution that is made from an eligible retirement plan to a qualified individual between January 1, 2020 and December 30, 2020, up to an aggregate limit of \$100,000. The Consolidated Appropriations Act of 2021 provided similar withdrawal exemptions and extended the timeline for penalty-free distributions through June 25, 2021. Participants must be 100% vested in their account balance at the time of the distribution and considered to be affected by the coronavirus pandemic in accordance with the guidelines set forth under the CARES Act.

The adoption of the provision by the Plan was effective May 15, 2020. As of December 31, 2024, the Plan has not been formally amended, as a formal amendment is not required until the plan year ending December 31, 2025. The Plan intends to formally adopt the amendment upon a future restatement of the Plan, prior to this date.

Note 2 - Summary of Accounting Policies

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions and (or) pay plan expenses. During the year ended December 31, 2024, no forfeitures were used to reduce Company contributions or pay plan expenses. There were no forfeiture balances as of December 31, 2024 and 2023 respectively.

Plan Administration

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Most administrative expenses are paid by the Company, except for the administrative costs associated with participant activity such as distributions fees.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting and in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires that Plan management make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for details on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or plan sponsor as provided by the Plan document. Expenses that are paid directly by the plan sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

Income Taxes

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 3 - Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal (the trustee of the Plan). This information has not been audited by the Plan's independent auditors.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the value hierarchy under FASB ASC 820 are described as follows:

- Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2            Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at the NAV of units of the collective trust per unit based on the underlying investments comprising the trust and based on audited financial statements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Rollover Contributions

An aggregate of \$620,546 was rolled into the Plan during the year ended December 31, 2024 and is included in rollovers on the Statement of Changes in Net Assets Available for Benefits.

Note 6 – Party-In-Interest Transactions

Principal is the trustee of the Plan and the Plan invests primarily in mutual funds and a common collective trust fund managed by Principal, which are considered to be party-in-interest transactions. In addition, the Plan Sponsor paid certain expenses related to plan operations and investment activity to the Plan, and such expenses are excluded from these financial statements.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in the company contribution of their account.

Note 8 – Income Tax Status

The Plan obtained its latest determination letter January 1, 2018 in which the IRS stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended is qualified and tax exempt.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
