Opinion

NOTES TO THE FINANCIAL STATEMENTS

NOTE A—PLAN DESCRIPTION AND BASIS OF PRESENTATION

The following brief description of the MDR Construction, Inc. Employee Stock Ownership Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

MDR Construction, Inc. (Company) established the Plan, effective January 1, 1999. As of January 1, 2023, the Plan was amended and operates, in relevant part, as a leverage employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Chief Executive Officer of the Company. An independent third-party is the Plan's trustee.

On December 21, 1999, the Plan purchased 619,195 shares of the Company's common stock with a loan of \$3,999,999. That loan has since been paid off. Subsequently, the Plan purchased 1,380,805 shares of the company's common stock using the proceeds of a bank borrowing (see note E) and holds the common stock in a trust established under the Plan. The stock was purchased at a price of \$6.88 per share, for an aggregate purchase price of \$9,500,000.

The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Company. The lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to

- a) the accounts of employees with rights in allocated common stock (allocated), and
- b) common stock not yet allocated to employees (unallocated).

Eligibility.

Employees of the Company are generally eligible to participate in the Plan after one year of service, providing they worked at least 1,000 hours and are 18 years of age, during such Plan year. Participants who do not have at least 1,000 hours or service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year. If a participant terminates, participant reenters the plan as of date of reemployment. Employee shall be treated as a new employee if a 5-year break in service occurs.

Contributions.

Each Plan Year, the Company will decide, subject to the approval of its board of directors, the amount, if any, it will contribute to the Plan. The Company's decision will depend in part on how much principal and interest is owed by the Plan on any loans obtained by the Plan to acquire MDR Construction, Inc. stock ("Company Stock"). Contributions by the Company may be made in the form of Company Stock, cash, other property, or a combination thereof. The discretionary contribution made by the Company for the Plan Year will be allocated among those eligible Participants employed by such Participating Employer in the ratio that the Compensation of each Participant employed by the Participating Employer making such contribution (while a Participant during the Plan Year) bears to the total of Compensation of all Participants employed by the Participating Employer making such contribution.

NOTE A—PLAN DESCRIPTION AND BASIS OF PRESENTATION (Continued)

The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Employees are not allowed to make contributions to the Plan.

Payment of Benefits.

Distributions on account of death or disability, or retirement are made in a lump sum in the Plan year following the event. Distributions for other separations from service commence in the fifth Plan year following the separation from service and are made in five annual installments. The amount to be distributed is based upon the immediately preceding valuation date. Exceptions for distributions \$1,000 or less – distributions can occur by end of plan year following plan year of termination and do not require participant consent.

Administrative Expenses.

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan.

Voting Rights.

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries.

Participant Accounts.

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting.

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Vesting in Company contributions and earnings of their accounts is based on years of continuous service. After 3 years of service participants vest 20% each year thereafter. Participants are 100% vested after seven years of credited service.

Put Option.

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification.

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. A participant may elect to diversify his or her account up to 25 percent of the number of shares, less any shares previously diversified. During the last ninety (90) day period occurring during the election period, the diversification election percentage changes to 50 percent. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Forfeitures.

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during December 31, 2024, totaled \$1,458,724.

NOTE B—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting.

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates.

The preparation of financial statements in accordance with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Allocations.

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition.

The shares of Company common stock are reported at fair value. See note D for discussion of fair value measurements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits.

Benefits are recorded when paid.

Subsequent Events.

The Plan has evaluated subsequent events through October 6, 2025, the date which the financial statements were available to be issued.

NOTE D—FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to un-observable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Gains and losses (realized and unrealized) included in changes in nets assets for the period above are reported in net appreciation in fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

The Plan distributed 18,040 shares valued at \$2,244,297 of the Plan’s level 3 assets for the year ended December 31, 2024.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the MDR Construction, Inc. common stock held by the Plan is valued at fair value based upon an independent appraisal. This appraisal was based upon a combination of the income and market valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, fair value of Company assets and liabilities, and the marketability of the Company. The valuation process involves plan management’s selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report, which plan management, along with the ESOP trustee reviews in detail, discusses and approves.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E—LOAN PAYABLE

In 2004, the Plan entered into a \$9,500,000 term loan agreement with MDR Construction, Inc. The proceeds to the loan were used to purchase Company common stock. Un-allocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of current year payments divided by the total of this year’s payments, plus all future years’ principal and interest payments. This resulted in 58,382 shares being released and allocated for the plan year ended December 31, 2024. The agreement provides for the loan to be repaid over 22 years. For 2024 and 2023, the loan interest rate was 4.68%.

NOTE F—RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. These are related party and party in interest transactions. As described in note A, the Company pays all plan expenses. The plan administrator is an employee of the Company and participates in the ESOP. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

NOTE G—RISKS AND UNCERTAINTIES

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the values of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H—PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE I—TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter May 30, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
