**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Northland Counseling Center, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained a certification from Hand Benefits & Trust Company as of December 31, 2024, and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Northland Counseling Center, Inc. 403(b) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Northland Counseling Center, Inc. (Company) 403(b) Plan (The Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan had a deposit contract with Hand Benefits & Trust Company as custodian for mutual fund assets and participant loans that are included in the financial statements. The accounts are credited with actual earnings on the underlying investments and charged for administrative expenses. The contract contains provisions for surrender charges and market value adjustments that could reduce the value available for withdrawal.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation within the limits imposed that year by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contributions plans. Participants direct the investment of their contributions into various investment options for participants. Effective June 1, 2022, the Company instituted matching contributions equal to 100% of elective deferrals up to 4% of compensation as defined in the plan document. The Company may also make annual contributions to the plan at its discretion.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution and, (b) Plan earnings (losses), and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Company's matching & discretionary contribution portions of their accounts plus actual earnings.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate of prime (7.50% at December 31, 2024) plus 2% at the time of the loan. Current interest rates on outstanding loans vary from 6.00% to 10.50% depending on the origination date. Principal and interest is paid ratably through regular payroll deductions.

The notes are valued at their unpaid principal balances. Related fees are charged directly to the participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Administrative Expense

Administrative expenses, except as described in Note 7, are absorbed by the Plan sponsor and not paid by the Plan.

Investment Options

The participants may direct contributions in various mutual funds and a fixed income guaranteed option managed by Hand Benefits & Trust Company as described in the Plan's provisions. Participants may change their investment options at their discretion.

Payment of Benefits

On termination of service due to death, a beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in their account paid out by the end of a five-year period, or over the life expectancy of the beneficiary. For termination of service due to any reason other than death, a participant may receive the value of the vested interest in their account as a lump-sum distribution. In addition, in the event of an immediate and heavy financial need, as described for in the plan and found eligible by the plan administrator, amounts may be withdrawn for hardship purposes.

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The statement of net assets available for benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The statement of changes in net assets available for benefits is prepared on a contract value basis.

*Fair Value Measurements*

The Plan follows the accounting standard for fair value measurements to measure fair value. The standard applies to reported balances that are required or permitted to be measured at fair value under an existing pronouncement. It emphasizes that fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined using the assumptions that market participants would use in pricing the asset or liability. The accounting standard also establishes a fair value hierarchy. The fair value hierarchy consists of three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs that utilize quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – Inputs that include quoted prices for similar assets and liabilities in active markets and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability. Fair values for these assets and liabilities are estimated using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows.

Level 3 – Inputs that are unobservable for the asset or liability, which are typically based on an entity's own assumptions, as there is little, if any, related market activity.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Quoted market prices are used to value mutual funds. Shares of the mutual funds are valued at the net asset value of the shares held by the Plan at year-end. The fair value of the fixed income guaranteed option investment contract is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Date of Management's Review*

Subsequent events were evaluated through October 2, 2025, which is the date the financial statements were available to be issued.

**NOTE 3      INVESTMENTS CERTIFIED BY THE CUSTODIANS**

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Hand Benefits & Trust Company, the custodian of the Plan, as complete and accurate, except for comparing such information certified by the custodians with information included in the plan's financial statements and supplemental schedule.

Due to the fact that the Plan's investments held at Hand Benefits & Trust Company have not been audited as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the input levels used to measure fair value have not been audited.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 6 TAX STATUS**

The Plan was restated on August 1, 2018 to adopt a prototype 403(b) volume submitter plan. This plan was designed to meet the requirements of Code section 403(b). The volume submitter plan received an opinion letter dated March 31, 2017, in which the Internal Revenue Service stated that the plan was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 6 TAX STATUS (CONTINUED)**

Generally accepted accounting principles prescribe requirements for the recognition, measurement, classification, and disclosure in the financial statements of uncertain tax positions taken or expected to be taken by the Plan. Management believes that the Plan has maintained its tax exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by the IRS and generally, the Plan's tax returns remain open for federal income tax examination for three years from the date of filing.

**NOTE 7 RELATED-PARTY TRANSACTIONS**

Hand Benefits & Trust Company, the custodian of the Plan, manages plan investments in certain mutual funds. Benefit Plan Administrative Services, Inc. provides third party administrative services to the plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for the management services amounted to \$34,662 and \$26,889 for the Plan years ended December 31, 2024 and 2023, respectively.

The Plan also has notes receivable from participants that earned interest of \$2,731 and \$1,426 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
