Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tands, Inc. & Adopting Related Employers 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The Tands, Inc. & Adopting Related Employers 401(k) Plan, as amended, (the Plan) is sponsored by Tands, Inc. (Company). The following description of the Plan is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401 of the Internal Revenue Code. The Plan covers substantially all employees of the Company who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Employees may defer up to 100% of their compensation, as defined by the Plan, up to limited amounts prescribed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company makes matching contributions of 10% of a participant's eligible compensation deferred into the Plan limited to a maximum of 6% of a participant's eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, net earnings or losses associated with their investments and an allocation of Plan expenses. Allocated earnings and expenses are based on participant account balances or earnings, as defined by the Plan. Participants may direct the investment of their account as allowed by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prime plus 1 percent, which are commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided by the participant's account. Upon termination of service, death, disability, financial hardship or retirement the participant will receive the value of the vested interest in his or her account in the form of a lump-sum distribution.

1. DESCRIPTION OF PLAN, CONCLUDED

Forfeited Accounts

Forfeited non-vested amounts are used to reduce administrative expenses or Company contributions to the Plan. There were no forfeited non-vested accounts as of December 31, 2024 and 2023. Plan fees of \$593 and Company contributions of \$96, were paid with forfeited funds during the year ended December 31, 2024.

Investment Options

Participants are afforded several investment options covering a wide range of investment objectives and risks. Participants may allocate their contributions across these options in any proportion they wish and can change this allocation at any time.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of certain contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expense during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. The interest rate on all outstanding notes at December 31, 2024 was 6.0%.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONCLUDED

Excess Contribution Payable

The plan had amounts payable to participants for contributions in excess of amounts allowed by the IRS of \$0 and \$4,756 for the years ended December 31, 2024 and 2023, respectively. The amounts are recorded as a liability with a corresponding reduction to contributions. The 2023 excess contributions were paid out to the respective employees by March 15, 2024.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through the date of the audit report, which was the date the financial statements were available to be issued.

3. INVESTMENTS

The Plan's investments were held in trust and administered by the custodian, American United Life Insurance Company for the years ended December 31, 2024 and 2023. All investment information disclosed in the accompanying financial statements and supplemental schedules was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the custodian.

4. PLAN TAX STATUS

The Company adopted a non-standardized plan prototype. This prototype plan obtained an opinion letter dated March 31, 2014, in which the Internal Revenue Service states that the Plan as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC), and is therefore, not subject to tax under present income tax laws. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if it has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator feels the Plan had no such positions at December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FAIR VALUE MEASUREMENTS

The Plan categorizes its assets and liabilities measured at fair value into a three-level hierarchy based on the priority of the inputs to the valuation technique used to determine fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

5. FAIR VALUE MEASUREMENTS, CONTINUED

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset and liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Guaranteed Investment Contract

At December 31, 2024 and 2023, the Plan has a guaranteed investment contract ("GIC") that is group annuity contract, backed by the assets of the general account of American United Life Insurance Company. This GIC, the AUL Fixed Account and the AUL Stable Value Fund, are considered to be a fully benefit responsive investment contract and are measured, presented and disclosed at contract value within the Statement of Net Assets Available for Benefits. Participant transactions are executed using contract value without adjustment. The earnings of the contract are based on an interest rate applied to each participant's outstanding balance. The interest rates are analyzed and may be reset by the issuer quarterly for the contract. The interest credited to participants in the contract for the year ended December 31, 2024 was 1.75%. The interest credited to participants in the contract for the year ending December 31, 2023, was 2.64%. The contract has a minimum crediting interest rate of 1%. There are no restrictions on the use of Plan assets and there is no valuation reserves recorded to adjust contract amounts. Fund performance, net cash flows of the Plan investments, and duration of assets are factors that could influence the average interest credited rate.

Contract value is calculated as contributions, plus earnings, less withdrawals and administrative expenses. Participant transactions are executed at contract value less surrender charges, if applicable, which is the relevant measure for fully benefit-responsive investment contracts. The Plan's ability to meet its contractual obligations to settle amounts due is dependent on the issuer, which could be impacted by economic and regulatory changes. Currently, there is no probability of the issuer not being able to fulfill its contractual obligations at contract value.

Mutual Funds

Investments in mutual funds are valued using the NAV of units, as determined by the insurance company. Mutual funds are carried at fair value using net asset value practical expedient. Therefore, they are not categorized within the fair value hierarchy.

The funds had no unfunded commitments at December 31, 2024 and 2023. Participant level transactions take place daily; typically, the liquidation would be processed one business day after requested.

6. PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. PARTY-IN-INTEREST TRANSACTIONS

The investments are managed by American United Life Insurance Company, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest. Fees paid to the custodian in 2024 was \$809, net of payment from forfeitures of \$593.

The Plan sponsor provides the Plan with certain accounting and administrative services for which no fees are charged. The Plan sponsor also pays for some administrative expenses for the Plan for which no reimbursement is received from the Plan.

These party-in-interest are exempt from prohibited transaction rules of ERISA.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Revenue Sharing Formula:

The investment options of the Plan include various portfolios within an AUL separate account. The separate account in turn invests in investment portfolios of certain open-end management investment companies. AUL receives indirect compensation from these investment companies for the services provided by AUL.

The compensation received by AUL is computed by each investment company by multiplying the daily account balance of the AUL separate account's interest in a particular portfolio by a predetermined percentage rate negotiated with the investment company. This indirect compensation is not charged to the plan or participants accounts but is paid directly by the investment company.
