

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

(1) DESCRIPTION OF THE PLAN

The following description of the Hammer-Williams Company 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions. Empower Trust Company, LLC and Empower Trust Company of America (collectively, “Empower”) are the custodians of the Plan.

General and Eligibility

The Plan is a volume submitter plan that operates as a defined contribution 401(k) plan. The Plan was adopted effective April 1, 2002, amended and restated effective January 1, 2022, and subsequently amended effective July 21, 2023, and January 1, 2024, and is subject to the applicable regulations of the Internal Revenue Code of 1986, as amended (the “Code”) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers employees of the Hammer-Williams Company and the following entities (collectively, the “Company”) that have also adopted the provisions of the Plan:

- Williams Broadcasting, LLC
- Williams Capital Corp.
- Flagship Resources, Inc.
- Jack’s General Stores, LLC
- Lamunyon Drilling
- Venture Enid 2013, LLC (ceased participating effective January 1, 2023)
- Quick Movers (ceased participating effective January 1, 2023)

The Plan covers all employees, excluding union and nonresident alien employees, who are at least 18 years of age, and has no service requirement. Eligible employees may enroll in the Plan on the date the eligibility requirement is satisfied.

Hammer-Williams Company is the administrator of the Plan and has employed a third-party administrator to assist with managing the Plan. Empower processes and maintains the records of the participant data and is the custodian of the Plan assets.

Contributions

The Plan allows participants the option of making pre-tax and Roth 401(k) after-tax contributions. The total pre-tax and Roth after-tax contributions by the employees may not exceed federal statutory limits on 401(k) contributions. Employees who are eligible to make elective deferrals under the Plan and who have attained the age of 50 before the close of the plan year are also eligible to make catch-up contributions. These contributions are subject to certain limitations established by the Code.

(1) **DESCRIPTION OF THE PLAN, CONTINUED**

Contributions, Continued

Effective January 1, 2024, the Plan was amended to permit Qualified Automatic Contribution Arrangement (QACA) safe harbor contributions. Participants make QACA deferrals to the plan at 6%, unless the participant has made an alternative affirmative salary deferral election. The Company makes employer QACA safe harbor contributions equal to 100% of the participant's elective deferrals that do not exceed 1% of the participants eligible compensation, plus 50% of the participants deferrals that exceed 1% but do not exceed 6% of the participants eligible compensation. In addition, the amendment lifts the allocation conditions for the employer match requiring participants to be employed on the last day of the plan year to be eligible to receive the employer matching contributions.

Prior to January 1, 2024, the Plan had an automatic enrollment feature. Upon eligibility, employees were automatically enrolled into the Plan with a 2% deferral percentage, unless the employee declined enrollment before eligibility was reached.

The Company may make discretionary matching contributions to the Plan. In 2023, the Company made discretionary matching contributions of 35% of a participant's contributions to the Plan. Additionally, the Company, at its discretion, may elect to make a profit-sharing contribution to the Plan. In 2024 and 2023, the Company did not make discretionary profit-sharing contributions. Prior to January 1, 2024, employees must have been employed by the Company at December 31 to receive Company contributions.

Participant Accounts/Investment Options

Each participant's account is credited with the participant's contributions, the Company's discretionary matching and profit-sharing contributions, and the allocation of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants' earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants may direct their contributions and employer contributions among various investment options offered through the Plan's custodian. Participants may change their investment options at any time.

(1) **DESCRIPTION OF THE PLAN, CONTINUED**

Vesting

Participants are fully vested in their salary deferral contributions, rollover contributions, and applicable earnings thereon at all times. Participants vest in employer QACA safe harbor contributions 100% after 2 years. Participants vest in the Company's discretionary matching and profit-sharing contributions as follows:

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000, reduced by the excess of the highest outstanding loan balance during the preceding 12-month period ending on the date of the loan over the current outstanding loan balance on the date of the loan, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which is based on the Prime rate plus 1% on the date of origination. Participants are only allowed to have one outstanding participant loan at any one time. Principal and interest are paid ratably through payroll deductions.

Effective July 21, 2023, the Plan was amended to allow participants to have up to two participant loans outstanding at any one time.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, the participant (or beneficiary, as applicable) may elect to receive a lump sum distribution in an amount equal to the current value of his or her contributions to the Plan and vested Company contributions. Additionally, participants may take in-service distributions upon reaching age 59½. Hardship distributions may be made to participants under certain conditions. Upon termination, the Plan allows automatic distributions for balances of less than \$5,000. Automatic distributions above \$200 made without the participant's consent are rolled into an individual retirement account. As of December 31, 2024 and 2023, there was approximately \$360,000 and \$452,000, respectively, of deferred vested benefits unpaid to participants who are no longer participating in the Plan.

As of December 31, 2024, there were no unpaid vested benefits to participants who had requested withdrawal of his/her account.

(1) **DESCRIPTION OF THE PLAN, CONTINUED**

Forfeitures

Employer contributions and earnings thereon which become forfeited as a result of any of the benefit payment or withdrawal provisions of the Plan may be used to pay any administrative expenses, and any excess may be used to reduce the contribution of the employer. Forfeitures of nonvested portions of participants' accounts that occurred during 2024 were \$35,028 and during 2023 were \$6,523. As of December 31, 2024 and 2023, there was \$29,063 and \$55,326, respectively, of unallocated forfeitures in the Plan.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Administrative Costs

All reasonable expenses for administration of the Plan may be paid out of the Plan's assets unless paid by the Company. In addition, fees are assessed on employee-directed transactions within the Plan and are netted against earnings in the individual's account.

(2) **SIGNIFICANT ACCOUNTING POLICIES, CONTINUED**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in registered investment companies and collective investment funds are stated at fair value, and the Plan's investment in a fully-benefit responsive guaranteed investment contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements, and see Note 5 for a discussion of the guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

(2) **SIGNIFICANT ACCOUNTING POLICIES, CONTINUED**

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid. There were no benefits requested before year-end that were not paid.

Excess Contributions Payable

The Plan is required to return contributions received during the plan year in excess of limits established by the Code. There were not any excess contributions payable as of December 31, 2024 or 2023.

Date of Management's Review of Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued, and determined that no subsequent events occurred that require adjustment to or disclosure in the financial statements.

(4) **FAIR VALUE MEASUREMENTS**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. In estimating fair value, the Plan utilizes valuation techniques that are consistent with the market approach, the income approach, and/or the cost approach. Such valuation techniques are consistently applied. Inputs to valuation techniques include the assumptions that market participants would use in pricing an asset or liability. Fair values may not represent actual values of assets and liabilities that could have been realized on the measurement date or that will be realized in the future. The use of different market assumptions and/or estimation methodologies may have a material effect on the estimated fair value amounts.

Accounting Standards Codification Topic 820, "Fair Value Measurement," establishes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1 inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset and liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 inputs consist of unobservable inputs which are used when observable inputs are unavailable and reflect an entity's own assumptions about the assumptions that market participants would use in pricing the assets or liabilities.

The Plan uses appropriate valuation methods based on the available inputs to measure the fair value of its assets and liabilities.

(4) FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for plan benefits as well as the general classification of such assets pursuant to the valuation hierarchy.

Registered Investment Companies

Shares of registered investment companies are valued at quoted market prices obtained from nationally recognized securities exchanges.

Stable Value Collective Investment Fund

The Morley Stable Value Fund (the "Fund") is a collective investment fund that is considered to be a stable value fund with underlying investments in fully benefit responsive investment contracts. The Fund is stated at fair value as determined by the issuer of the collective investment fund, based on the fair market value of the underlying investments, which is valued at the net asset value (NAV) as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Fund will sell the investment for an amount different from the reported NAV. Participant transactions may occur daily. If the Plan initiates a full redemption of the Fund, the issuer reserves the right to delay withdrawal in order to ensure that securities liquidations will be carried out in an orderly business manner.

Small Cap Value Collective Investment Fund

The State Street Russell Small Cap Value Index Fund (the "Index Fund") is a collective investment fund that is considered to be a small value fund that seeks an investment return that approximates as closely as practicable, before expenses, the performance of the Russell 2000 (R) Value Index over the long term. The Index Fund is stated at fair value as determined by the issuer of the collective investment fund, based on the fair market value of the underlying investments, which is valued at NAV as a practical expedient, to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Index Fund will sell the investment for an amount different from the reported NAV. Participant transactions may occur daily. If the Plan initiates a full redemption of the Index Fund, the issuer reserves the right to delay withdrawal in order to ensure that securities liquidation will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) GUARANTEED INVESTMENT CONTRACT

At December 31, 2024 and 2023, the Plan had a fully benefit-responsive guaranteed investment contract with Empower totaling \$89,284 and \$109,542, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed rate is reset quarterly. The investment contract had a minimum guaranteed rate of 1.41% and 1.23% as of December 31, 2024 and 2023, respectively. Average yield on the contract was 1.41% in 2024. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

(5) **GUARANTEED INVESTMENT CONTRACT, CONTINUED**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, or (3) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan. As of December 31, 2024 and 2023, no events were probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

(6) **TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services. The Company does not expect to be reimbursed by the Plan for these services.

Certain plan investments are managed by the Plan's custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than a direct payment. The Company pays directly any other fees related to the Plan's operations.

(7) **STABLE VALUE COLLECTIVE INVESTMENT FUND**

The Morley Stable Value Fund is a collective trust fund offered by the Principal Global Investors Trust Company, whose objective is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive payments. The Fund invests primarily in a variety of high-quality stable value investment contracts (the performance of which may be predicted on underlying fixed income securities), as well as cash and cash equivalents.

Participants ordinarily may direct either the withdrawal or the transfer of all or a portion of their investment at contract value. The Fund imposes certain restrictions on the Plan, and the Fund itself may be subject to circumstances that affect its ability to transact at contract value. Plan management believes that the occurrence of events that would cause the Fund to transact at less than contract value is not probable.

Redemption is generally permitted daily. Individual participant redemptions for benefit payments and redemptions by participants to reinvest in options that do not compete with the common collective trust are generally permitted without restriction. Were the Plan to initiate a full redemption of the common collective trust, a 12-month advance written notice is required.

(8) INFORMATION CERTIFIED BY PLAN CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(9) TAX STATUS

The Plan is a volume submitter plan offered through the Plan's third-party administrator. The Internal Revenue Service has determined and informed the third-party administrator that the volume submitter plan under which the Plan operates is designed in accordance with applicable sections of the Code. Such determination was received June 30, 2020. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the date of the financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

(10) RISKS AND UNCERTAINTIES

Plan participants may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
