Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Gritman Medical Center Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Gritman Medical Center Employee Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Gritman Medical Center Employee Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, line 4i – Schedule of Assets (Held at End of Year) and supplemental schedule of Schedule H, line 4a – Schedule of Delinquent Participant Contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the

financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS
December 31, 2024 and 2023

NOTE 1 Description of Plan

The following description of the Gritman Medical Center Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligibility - The Plan is a defined contribution plan. All employees (except union employees, leased employees, independent contractors and nonresident aliens) of Gritman Medical Center (the Sponsor) become eligible to participate in the plan following the later of one year of service and attainment of age 18. One year of service means 1,000 hours in an employee's first twelve months of employment or in any twelve-month period beginning January 1 following the employee's hire date. Effective July 1, 2018, for the 401(k) portion of the plan, eligible employees become participants immediately upon date of hire provided the participant is at least age 18. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Eligible employees may contribute from 1% to 75% of considered earnings to the Plan. Contributions are on a pre-tax basis or, effective July 1, 2014, on an after-tax (Roth) basis. Effective January 1, 2007, the Plan will automatically withhold 4% on a pretax basis from participant compensation unless a negative election is submitted.

At year-end, Gritman Medical Center may make matching contributions to the Plan. In addition, a profit sharing contribution may be made at the end of the Plan year. Only employees who are employed at December 31 (the last day of the plan year) and perform 1,000 hours of service during the Plan year receive these employer contributions. The hours of service and employment requirements are waived if termination is due to death, disability or normal retirement. Considered compensation includes only compensation while eligible to participate in the Plan.

Participants' Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's profit-sharing and matching contribution, and (b) Plan earnings (losses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting - Rollover and 401(k) accounts are always 100% vested. In the event of termination from service by a participant for any reason other than death, disability or normal retirement (age 55 with 5 years of participation), each participant shall be entitled to his or her profit sharing and matching accounts as determined by the following vesting schedule: 0% until after three years of service, at which point, employees become 100% vested. A year of service is a plan year in which an employee completes 1,000 hours of service.

NOTE 1 Description of Plan (Continued)

Notes Receivable from Participants - Active participants may borrow from the plan with their vested balance in the plan as collateral under the following rules: (1) Maximum loan amount is the lesser of: (a) 50% of the participant's vested balance and (b) \$50,000 reduced by the participant's highest outstanding loan balance in the preceding 12 months; (2) Loans will be made at the commercial rate charged by lenders for similar loans (currently, the prime rate); (3) The maximum loan term is five years (30 years for purchase of primary residence); (4) The minimum loan amount is \$1,000; (5) Loan repayments are made through payroll deduction; (6) A participant may have up to two outstanding loans at a time; and (7) A participant will be charged a \$150 loan initiation fee.

Payment of Benefits - Participants are eligible to receive benefits as soon as administratively feasible following termination of employment and the proper completion of a Benefit Election Form.

Terminated participants whose vested balances are \$5,000 or less may be subject to automatic rollover of their vested balances to Matrix Trust Company.

In-service Withdrawals - Hardship withdrawals are allowed from the Plan and may be taken from employee deferrals and employer accounts that are 100% vested. Employee deferrals may also be taken after a participant reaches age 59-1/2. Employer money that is 100% vested may be taken by participants who have attained Normal Retirement Age. Rollover money may be taken out of the Plan at any time (restricted to once a year).

Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$72,266 and \$48,476, respectively. These accounts will be used to reduce future employer contributions.

Fees and Expenses - General Plan expenses are paid by the Plan Sponsor and include recordkeeping fees and legal fees. "Per Event" individual expenses are charge per event to individual participant's accounts and include short-term redemption fees (per prospectus), QDRO processing fees (\$250), loan fees (\$150), and distribution fees (\$70).

Revenue sharing is used to offset general plan expenses such as investment advisor fees.

Administration of Assets - All funds received by the Plan are deposited to an Investment Fund with Matrix Trust Company, the Plan custodian. Amounts held in the Investment Fund are allocated among a variety of investment options selected by the Plan trustees. Each participant may direct the allocation of the amounts received by the Plan on his or her behalf among these investment options. The Plan is administered by Northwest Plan Services, Inc.

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

NOTE 2 Summary of Accounting Policies

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Operating and Administrative Expenses - All expenses of maintaining the Plan are paid by the Sponsor.

Date of Management's Review - Subsequent events were evaluated through the date of the auditor's report, which is the date the financial statements were available to be issued. Plan management has concluded that no material subsequent events have occurred.

NOTE 3 Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

NOTE 3 Fair Value Measurements (Continued)

- Level 2** Inputs to the valuation methodology include
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Units held in collective trusts (CT) are valued using the net asset value practical expedient (NAV practical expedient) of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding.

NOTE 4 Information Certified by the Plan's Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation (depreciation) in fair value of investments, dividend income, capital gain income, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

NOTE 5 Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 Tax Status

The Internal Revenue Service has determined and informed the Sponsor by letter dated September 1, 2006 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

NOTE 7 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 Related-Party Transactions and Party in Interest Transactions

Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.
