## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of The Savings and Growth Plan for Ports America Group and Affiliates (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by the qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to the participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audit.

#### **Other Matter—Supplemental Schedules Required by ERISA**

The supplemental schedules included in the accompanying table of contents are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### 1. Description of Plan

The Savings and Growth Plan for Ports America Group and Affiliates (the Plan) was established by Ports America (the Company and Employer) on December 31, 1952 to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General:*

The Plan is a defined contribution plan under Sections 401(a) and 401(k) and related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan's trustee for shares of mutual funds held in a qualified trust is Delaware Charter Guarantee & Trust Company (Delaware Charter), a wholly-owned affiliate of Principal Life Insurance Company (Principal). Principal is the investment custodian of pooled separate accounts, and a common/collective trust held under a group annuity contract (the Contract) and is the Plan's record keeper. Company employees serve as trustees for assets held under the Contract.

An administrative committee, consisting of Company employees, helps administer the Plan and is responsible for selecting investment options offered under the Plan and monitoring investment performance.

#### *Eligible Participants:*

Employees of the Employer covered by a collective bargaining agreement are not eligible for participation unless otherwise indicated in the collective bargaining agreement. Leased employees are excluded from participation under the Plan agreement. All other employees are eligible to participate in the Plan on the first day of the month following their hire date.

#### *Contributions:*

Participants are permitted to make voluntary pre-tax salary deferrals and Roth post-tax contributions up to 100% of their annual eligible compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), excluding rollovers of after-tax contributions, subject to Code regulations.

##### *Contributions:* (continued)

The Plan has an automatic enrollment feature under which all eligible employees hired or rehired are automatically enrolled in the Plan and have 6% of their pre-tax compensation deferred and contributed to the Plan, unless they request a different amount to be contributed or formally decline participation. Participants may adjust their salary deferral rate or discontinue their contributions at any time.

The Company has elected to operate the Plan as a safe harbor plan. Under the safe harbor provision, the Employer is required to make matching contributions equal to 100% of a participant's salary reduction contributions, up to 4% of participant compensation. Additional matching contributions made by the Employer are discretionary. However, certain participating affiliated companies are required to make matching or other non-elective contributions based on collective bargaining agreements. The Company made safe harbor matching contributions of \$6,071,688 to the Plan in 2024. Additional Employer matching contributions totaled \$28,000 in 2024.

Contributions are subject to certain limitations under the Code.

##### *Participant Accounts:*

Participant accounts are credited with participant contributions, Company contributions, rollovers, and an allocation of the Plan's net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

##### *Vesting:*

Participants are immediately vested in their contributions, plus actual earnings thereon, less administrative expenses charged by the Plan. The Employer safe harbor contribution portion of a participant's account is also fully vested. Vesting in additional Employer matching contributions is based on years of service with full vesting occurring after three years of service.

##### *Forfeitures:*

The forfeited non-vested portion of terminated participant account balances may either be used to pay administrative expenses or to reduce future Employer contributions. As of December 31, 2024, the amount of available forfeited non-vested accounts was \$98,000 (\$16,000 as of December 31, 2023). Forfeitures of \$17,000 were used to pay administrative expenses and \$85,000 were used to reduce Employer contributions in 2024.

##### *Notes Receivable from Participants:*

Participants may borrow up to one-half of their account balance, for a minimum of \$1,000 and a maximum of \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which terms of up to 30 years are permitted. Participant notes are evidenced by a written note, secured by the balance in the participant's account, and bear interest at the prime rate published in The Wall Street Journal, plus 1%. The interest rates on the notes outstanding at December 31, 2024 ranged from 5.25% to 9.75%. Repayment of principal and interest is generally made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

##### *Payment of Benefits:*

On termination of service, participants may elect to leave their account balances in the Plan or receive benefits. Benefits are paid in a lump-sum cash distribution equal to the value of the participant vested account balances. Upon termination, the Plan may immediately elect to distribute participant account balances without participant consent if the balance is \$7,000 or less. For distributions between \$1,000 and \$7,000, account balances are rolled into individual retirement accounts on behalf of the participants without participant consent. Distributions will be in the form of a check for account balances less than \$1,000. Benefits are recorded when paid.

##### *Administrative Expenses:*

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the financial statements. Certain administrative expenses are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

##### *Risks and Uncertainties:*

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risks in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

##### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue Employer contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

#### 2. Summary of Significant Accounting Policies

##### *Funding:*

The Plan is funded under a qualified trust. Delaware Charter is responsible to hold, invest and reinvest trust assets in the interest of, and as directed by, the participants and their beneficiaries. Plan assets with Principal are held under the fiduciary guidance of the Company trustees on behalf of the participants and their beneficiaries.

##### *Basis of Accounting:*

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Investments:*

The Plan's investments consist of mutual funds, pooled separate accounts and a common/collective trust. These investments are accounted for as follows:

*Mutual Funds:* Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted prices in an active market.

*Pooled Separate Accounts:* These accounts are separate from Principal's general fund account and consist of shares in various mutual funds. The investment in each separate account is expressed in 'units'. The value of each separate account is recorded at the close of each business day at fair value based on unit value reported by Principal. The 'unit value' is calculated by dividing the value of the entire account by the total number of units in the account. The value of the Plan's investment in each separate account on any date is determined by multiplying the number of units held by the unit value.

*Common/Collective Trust (CCT):* The Principal Stable Value Preferred Fund is a CCT and stable value fund that is composed primarily of fully benefit-responsive investment contracts. Units held in the CCT are valued using the NAV practical expedient as an estimate of the CCT's fair value, as determined by the CCT manager. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV of the CCT is calculated based on the compilation of primarily observable market information.

The NAV practical expedient would not be used if it is determined to be probable the Plan will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidated will be carried out in an orderly business manner. The Plan has no unfunded commitments with the CCT.

##### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement to value investments at fair value, based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three levels of the fair value hierarchy are as follows:

**Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

**Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

**Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The CCT, valued based on the NAV practical expedient, is excluded from the fair value hierarchy under GAAP.

#### *Income Recognition:*

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on the Plan's investments bought, sold or held during the year.

### 3. Information Prepared and Certified by the Qualified Institutions

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter and Principal, the qualified institutions of the Plan, have certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### 4. Party-In-Interest Transactions

Certain Plan assets are invested in funds offered by Principal. Principal, as the Plan's investment custodian, is a party-in-interest of the Plan. As a result, transactions related to these investments are considered party-in-interest transactions. Notes receivable transactions with participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### 5. Nonexempt Prohibited Transactions

In 2022, the Employer did not remit participant contributions and note repayments totaling \$11,786 to the Plan timely, as required by the Department of Labor (DOL). The Company intends to remit lost earnings on the delinquent remittances in 2025. The DOL considers delinquent contributions to be nonexempt prohibited transactions with the Plan sponsor that can jeopardize the Plan's tax-exempt status.

#### 6. Income Tax Status

The Plan has obtained a favorable tax determination letter dated June 30, 2020 from the Internal Revenue Service (IRS) stating the Plan, as designed, was in compliance with the applicable requirements of the Code. The Plan has been amended and restated since receipt of the letter. However, the Company believes the Plan is being operated in substantial compliance with the applicable requirements of the Code and related state statutes and, is therefore, qualified and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP require Plan management to evaluate tax positions taken by the Plan and recognize an income tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed the income tax positions taken by the Plan and has concluded, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Company believes the Plan is no longer subject to income tax examinations for years prior to 2021.

#### 7. Subsequent Events

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
