NOTES TO FINANCIAL STATEMENTS
FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the ContiTech USA, Inc. Supplemental Unemployment Benefits Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan, as stated in the plan agreement dated August 1, 2007, on supplemental unemployment benefits between the ContiTech AG (the "Employer") and The United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union, AFL-CIO-CLC ("USW") and the Loan Unions (the "Union"), is a supplemental unemployment benefit plan covering hourly employees who are members of the Union at designated locations. The Employer contributes to the Plan at rates specified in the plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan provides benefits to participants for regular layoffs and short work weeks, provided they have accumulated in the current year, or in prior years, credit units in excess of the credit units required for payment at the time the request is filed. Accumulated credit units are based on years of service and may be carried forward. Credit units shall have no fixed value in terms of money, but shall be a means of determining eligibility for and duration of benefits.

Allowable expenses paid by the Plan include expenses of PNC Bank, the Trustee of the Plan, incurred in the administration of the Plan. All other administrative costs are paid by the Employer. If terminated, the Plan assets shall be used until exhausted to pay benefits to eligible employees and administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accounts of the Plan are maintained on a modified cash basis, which reflects actual cash receipts and disbursements, accruals for interest income and increases or decreases in the fair value of investments which are recognized currently. The accounts do not include accruals for contributions, benefits due, or expenses incurred but not paid. The modified cash basis is a comprehensive basis of accounting other than generally accepted accounting principles in the United States of America.

Use of Accounting Estimates - The preparation of financial statements on the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. See Note 4 for disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Financial Data Certified by Trustee - All investment related information in the statements of net assets available for benefits and the changes in net assets available for benefits has been certified as complete and accurate or derived from information certified as complete and accurate by the Trustee in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Subsequent Events - Management has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

3. BENEFIT OBLIGATION

As stipulated in the plan agreement, the maximum liability of the Plan shall be no more than the fair market value of the trust fund.

4. FAIR VALUE MEASUREMENTS

The plan agreement specifies that investments shall be held only in general obligations of the United States Government or in other investments fully secured by such obligations.

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money market fund: Valued under the amortized cost method which approximates current market value. The fund seeks to maintain the net asset value (“NAV”) per share at \$1.00.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes the Plan’s valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

5. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain investments of the Plan are managed by the Trustee, and therefore, these transactions qualify as exempt party in interest transactions. Certain administrative expenses related to the administration of the Plan were paid by the Plan. Certain other third-party administrative expenses were paid by the Employer on behalf of the Plan. These transactions qualify as exempt party in interest transactions.

6. TAX STATUS

The Internal Revenue Service has determined and informed the Employer by a letter dated November 6, 2009, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, management and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

FASB ASC 740, *Income Taxes*, requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).
