Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of The Early Learning Coalition of Hillsborough County 401(k) Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Note 1. Description of Plan

General

The following description of Hillsborough County School Readiness Coalition, Inc. d/b/a The Early Learning Coalition of Hillsborough County (the “Company”/“Employer”) 401(k) Plan (the “Plan”), as amended, is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan was established effective January 1, 2013.

The Plan is a defined-contribution plan covering all full-time employees of the Company, excluding union employees, non-resident aliens, leased employees and other part-time, temporary, or seasonal employees hired on or after November 16, 2018, who are regularly scheduled to work less than 1,000 hours of service, as defined in the Plan, and are 18 years of age or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). Plan assets were held in the custody of America United Life Insurance Company, a OneAmerica company (“OneAmerica”/the “Plan Trustee”).

Contributions

Participants are permitted to make contributions to the plan on a pre-tax or after-tax (Roth) basis, as defined in the Plan and subject to Internal Revenue Service (“IRS”) limitations. The Company makes a safe harbor matching contribution equal to 100% of participants’ elective contributions up to 4% of their annual compensation. In addition to the matching contributions, the Company may make qualified non-elective contributions for the benefit of all eligible participants. The Company contributed a discretionary contribution of 6% of eligible compensation during the year ended December 31, 2024.

Participant Accounts

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, (b) Plan earnings, and (c) administrative expenses charged to the Plan. Allocations are based on participant contributions, earnings, or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Description of Plan (Continued)

Vesting

Participants are immediately vested in their voluntary employee contributions, safe harbor contributions, and earnings thereon. Vesting in any discretionary contributions, plus earnings thereon, is based upon years of continuous service, as follows:

Investment Options

Upon enrollment in the Plan, a participant may direct their account balances among any of the Plan's investment options offered by the Plan. Participants may change their investment options and move their investments from one fund to another in accordance with rules established by the Plan administrator.

Forfeitures

Forfeitures of terminated participants' nonvested accounts are used to pay administrative expenses of the Plan or to reduce Employer contributions made to the Plan. There were no forfeiture balances available to reduce future administrative expenses and Employer contributions at December 31, 2024 and 2023. No forfeitures were used during the year ended December 31, 2024 to reduce Plan expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the prior 12-month period, or 50% of their vested account balance. Loan transactions are treated as a transfer between the investment fund(s) and the participant loans fund. Loans bear interest at a rate similar to loans from financial institutions set by the Plan's administrator. Loan terms range from one to five years and are granted for hardship reasons or specified financial needs. The loan term can be up to 30 years if it is for the purchase of a principal residence. A participant may have no more than three loans outstanding during the Plan year. Principal and interest are repaid through payroll deduction. Participant notes receivable are recorded at their unpaid principal balance, plus accrued but unpaid interest. If collection of participant notes receivable is deemed doubtful, the amount is recognized as a distribution in the period the determination is made.

Payment of Benefits

Upon termination of employment, disability, retirement at age 65, attainment of age 59 ½, or loan for reason of hardship, a participant may elect a lump sum distribution of his/her vested account. Upon death, the participant's beneficiary may also make a withdrawal in lump-sum or installment method. At age 70 ½ or when employment is terminated, whichever is later, the participant will receive an automatic distribution to their account. If a participant account balance does not exceed \$1,000, a distribution of their vested balance will be made as soon as administratively feasible. There were no unpaid amounts allocated to participants who elected to withdraw from the Plan but were not paid as of December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Administrative Expenses

Certain administrative expenses are paid directly by the Company and will not be reimbursed by the Plan. Certain investment expenses are netted against net change in the fair value of investments.

Investment Valuation and Income Recognition

As of December 31, 2024 and 2023, the Plan's funds were invested in registered investment companies, and a fully benefit-responsive contract. The Plan's registered investment company investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts (see Note 5). The Plan's investments in guaranteed investment funds are stated at contract value. Contract value is deemed to be the relevant measurement attribute for those contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions and reinvested income, less any withdrawals, plus accrued interest.

Purchases and sales of marketable securities are reflected on a trade-date basis, and interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Registered investment companies are valued at the reported net asset value ("NAV") of shares held by the Plan at year end. The NAV is based on the fair value of the underlying assets owned less any fund liabilities. In accordance with the Plan's policy of stating marketable securities at fair value, the appreciation or depreciation for each year is reflected in the Plan's statement of changes in net assets available for benefits as a net change in fair value of investments.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment Risk

The Plan's investments are not insured and are subject to credit and market risks. Financial information relating to those investments is included in these financial statements based on information provided by the Plan Trustee.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and due to market volatility, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

In preparing these financial statements, the Employer has evaluated events and transactions for potential recognition through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, OneAmerica, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurement

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritizes the inputs to valuation techniques used to measure fair value in accordance with authoritative accounting literature. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 5. Fully Benefit Responsive Investment Contracts

The Plan has entered into a fixed interest contract with OneAmerica, the AUL Stable Value Account ("SVA"). This account is deemed fully benefit-responsive. SVA is an interest-earning investment option, backed by American United Life Insurance Company's ("AUL") general account assets. Interest is credited to all SVA monies at the current rate declared by AUL. New contributions and transfers to the SVA earn the interest rate in effect at the time of the contribution or transfer. AUL may declare a new interest rate for the SVA that becomes effective on January 1 of each calendar year; however, any increase in the interest rate will never be greater than 1.00% above the previously declared rate. The minimum interest rate guarantee is 0%. For those group variable annuity contracts subject to SEC registration, AUL maintains a Guaranteed SVA Account Value equal to the greater of the participant's or the contract holder's SVA Account Value or an amount equal to the total of all contributions, transfers, and reallocations to the SVA for the participant or the contract holder that have not been withdrawn previously, at a rate of interest guaranteed in the group variable annuity contract. These guarantees are based on the continued claims-paying ability of AUL. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. If a participating plan terminates participation in the fixed interest contracts, the lesser of the guaranteed value or the fair value will be received. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value.

The crediting interest rates for the SVA were stated at 2.85% during fiscal year 2024.

Note 6. Related Party Transactions

Certain Plan investments are managed by OneAmerica. OneAmerica is the trustee as defined by the Plan, so those transactions qualify as party-in-interest transactions. Fees paid directly by the Plan for the investment management services were approximately \$15,000 for the year ended December 31, 2024. The fees are paid by the Plan and qualify as a party-in-interest transaction. The Company also absorbs costs related to various administrative and investment advisory services on behalf of the Plan.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8. Tax Status

The Plan is intended to be a qualified trust under Section 401(a) of the Internal Revenue Code (IRS) and is subject to the provisions of ERISA. The original Plan is a prototype plan prepared and maintained by the Plan Trustee. The prototype plan received a determination of qualification from the IRS, dated August 19, 2020. The Plan administrator believes that the adopted and amended Plan continues to qualify and will remain exempt from federal income taxes under Section 401(a). Accordingly, no provision for income tax has been included in the Plan's financial statements.
