1. Plan Description

The following description of the Coldesi, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of Coldesi, Inc. (the "Company") who are age eighteen or older, and have completed three months of service. Nonresident aliens or residents of Puerto Rico are considered ineligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and was effective on January 1, 2001.
- b) *Contributions* – Each year participants may contribute to the Plan up to 90% of their annual compensation, subject to certain IRS limitations. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans ("rollover contributions").

Prior to April 1, 2024, the Plan had an automatic contribution arrangement, wherein all newly eligible employees were automatically enrolled on the first day of the month following the date that their eligibility requirements were met, unless an affirmative action was made by the employee prior to their entry date. The initial automatic deferral was 1% of pre-tax compensation. Effective April 1, 2024, a Plan amendment was made to remove the automatic enrollment arrangement. Newly eligible employees can enroll anytime, beginning on the first day of the month following the date that their eligibility requirements are met.

The Company, at its discretion, may make matching or nonelective contributions to the individual account of each employee annually. All Company contributions are invested as directed by the participants. Contributions are subject to certain limitations and eligibility requirements. For the year ended December 31, 2024, the Company made no contributions to the Plan.

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

- c) *Participants Accounts* – Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d) *Vesting* – Participant contributions and rollover contributions, plus actual earnings thereon, are 100% vested at all times. Participants vest in Company contributions based upon the following schedule:

- e) *Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Participants can only have three loans outstanding at a time, provided that only on "home loan" with a repayment period greater than five years may be outstanding at a time. The loan interest rate is set at 2 percent above the prime rate, as published in the Wall Street Journal on the 14th day of each month. Principal and interest is paid ratably through monthly payroll deductions. Loans are repayable within five years unless the loan is used for the purchase of a primary residence, in which case the loan may be repaid within a period of up to 30 years.

- f) *Payment of Benefits* – Upon termination of service, retirement, disability or death, participants may elect to receive either a lump-sum or equal installment payments, amount equal to the value of the vested interest in their account or rolled over into a qualified plan, subject to regulatory requirements. Participants may also receive partial distributions if age 59 ½ or older, or in the event of financial hardship. In-service distributions may not be less than \$500.
- g) *Forfeited accounts* – Forfeitures of nonvested balances may be used to pay Plan expenses, reduce Company contributions, or in some cases be reallocated to Participants. At December 31, 2024, no forfeitures were used for these purposes by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through October 2, 2025, which is the date the financial statements were available to be issued.

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, level 2 inputs consist of quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets in inactive markets; and level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust – The units of the common collective trust account is stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments. Individual participant accounts invested in the common collective trust account are maintained on a unit value basis.

6. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

7. Related Party Transactions and Party in Interest transactions

ADP is the Plan's recordkeeper and Reliance Trust is the trustee of the Plan. Recordkeeping and transaction fees of \$3,855 were paid to ADP in 2024.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by ADP Retirement Services ("ADP"). ADP obtained its latest opinion letter dated June 30, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
