## INDEPENDENT AUDITOR'S REPORT

**To the Plan Administrator of  
E-J Electric Installation Company Profit Sharing Plan**

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of E-J Electric Installation Company Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (financial statements).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the E-J Electric Installation Company Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan, effective December 29, 1943, and most recently amended and restated July 1, 2023, covering all eligible employees of E-J Electric Installation Company and its affiliates: E-J Electric T&D, LLC, E-J Energy, LLC, E-J Electric, LLC, E-J Energy Construction, LLC, E-J Drilling, LLC, E-J Technical Services, Inc., Rossi Electric Company, LLC (collectively, the “Company”), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan covers all employees of the Company, other than non-resident aliens, leased employees and certain union employees, who are age 18 years or older and have completed one year of service, as defined. Eligible employees enter the Plan as a participant January 1<sup>st</sup> coinciding with or next following satisfaction of the eligibility requirements. The Board of Trustees oversees governance of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.

#### **Contributions**

The Company may, at its discretion, make profit sharing contributions to the Plan. The Company’s contributions are invested at the direction of the Company in mutual funds. A participant will be eligible to receive an allocation of the Company’s discretionary contribution upon completion of one year of service and 18 years of age, as defined in the Plan document. The Company’s contributions will be allocated to each participant’s account based on the allocation group to which a participant is assigned to by the Company. For the year ended December 31, 2024, the Company made a profit sharing contribution of \$208,766. Employee contributions and rollover contributions are not permitted. Contributions are subject to certain statutory limitations.

#### **Participant Accounts**

Each participant’s account is credited with an allocation of the Company’s contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their accounts into various investment

options offered by the Plan. If no election is made by the participant, then the contributions are automatically invested in the Plan's Qualified Default Investment Alternative ("QDIA"). The Plan has elected the Fidelity Freedom Index Institutional Premium Fund series as its QDIA.

### Vesting

A participant's vested interest in his or her participant account is based on years of service as follows:

2	20%
3	40%
4	75%
5 or more	100%

In addition, a participant will become 100% vested in their account upon attainment of normal retirement age (as defined), death, or disability prior to termination of employment.

### Notes Receivable from Participants

Notes receivable from participants are not permitted, per the Plan document.

### Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a single lump sum payment equal to the value of the participant's vested interest in his or her account. The Plan allows for in-service distributions to employees who have attained age 59 ½.

### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,590 and \$23,592, respectively. These accounts can be used to reduce employer contributions or pay administrative expenses of the Plan. For the year ended December 31, 2024, \$25,840 of forfeitures were allocated to pay for administrative expenses.

## 2. SUMMARY OF ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Employer contributions from the Company are recorded in the year in which participant compensation is earned.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net change in fair value of investments.

## **3. CERTIFIED INFORMATION**

Certain information related to investments and other receivables disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and investments at contract value held at December 31, 2024 and 2023, and net change in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Life & Annuity Insurance

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2            Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

#### ***Pooled Separate Accounts***

Pooled Separate Accounts are not publicly quoted and are priced at net asset value (“NAV”). ASC 820 allows NAV per share to serve as a practical expedient to estimate fair

### 5. INVESTMENT CONTRACT WITH EMPOWER LIFE

In 2021, the Plan entered into a fully benefit-responsive group annuity contract with Great-West Life & Annuity Insurance Company of New York (now called Empower Life).

Empower Life maintains the contributions in the Empower Investments Fixed Account - Series I, which is a part of Empower Life's general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plans' ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$155,180 and \$63,762, respectively.

Certain events limit the Plan's ability to transact at contract value with Empower Life. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Either party to the group annuity contract may terminate the contract with at least 75 days advance written notice to the other party.

### **6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Alliant Insurance Services, Inc. (“Alliant”) is the contract administrator of the Plan, therefore certain transactions qualify as exempt party-in-interest transactions. Fees of approximately \$39,000 were paid to Alliant during the year.

Empower Life is the recordkeeper of the Plan, therefore certain transactions qualify as exempt party-in-interest transactions. Fees of approximately \$23,900 were paid to Empower Life during the year.

Empower Advisory Group LLC (“Empower Advisory”) is the investment manager of the Plan, therefore certain transactions qualify as exempt party-in-interest transactions. Fees of approximately \$4,200 were paid to Empower Advisory during the year.

### **7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### **8. TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect
