## INDEPENDENT AUDITORS' REPORT

To the Trustees, Plan Administrator and Participants of the  
Healthcare Access Maryland, Inc. Group Medical Plan 505:

### Opinion

We have audited the accompanying financial statements of the Healthcare Access Maryland, Inc. Group Medical Plan 505, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of benefit obligations and net assets available for benefits as of June 30, 2024, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the benefit obligations and net assets available for benefits of Healthcare Access Maryland, Inc. Group Medical Plan 505 as of June 30, 2024, and the changes in its benefit obligations and net assets available for benefits for the year ended June 30, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Healthcare Access Maryland, Inc. Group Medical Plan 505's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. DESCRIPTION OF THE PLAN

The following description of the Healthcare Access Maryland, Inc. Group Medical Plan 505 (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### General

The Plan is a health and welfare plan established by Healthcare Access Maryland, Inc. (the Organization), effective July 1, 2023. The Plan funds medical and prescription claims and acquires stop-loss reinsurance. The funding of premiums, claims and fees is through a trust (the Trust). The Plan is managed by trustees, which are primarily representatives of the Organization. The Plan also retained third party administrators (TPAs) to provide accounting and administrative services, as well as claims processing, certain insurances, and other ancillary benefits provided by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended and restated effective July 1, 2024 to add acupuncture benefits and increase deductible fees to comply with the IRS minimum deductible requirements.

#### Eligibility

The Plan provides medical and prescription benefits for all full-time employees (scheduled to work 30 hours or more per week) of the Organization and covered dependents in accordance with the Affordable Care Act (ACA). Covered dependents include an employee's lawful spouse, children under the age of 26, and other individuals as specified in individual insuring agreements covering specific benefits under the Plan. Employees are eligible to participate in the Plan on the first day of the month following their date of hire. Benefits are effective immediately for all covered employees. Former employees and their dependents are eligible for continued coverage for the number of months specified under the Consolidated Omnibus Budget Reconciliation Act (COBRA), if they so elect.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Contributions

The Plan provides for annual employee contributions, which are withheld each payroll period, to provide for a portion of the anticipated costs of providing medical and prescription benefits. Employee contributions are withheld on a pre-tax basis. Participants should refer to the Plan document for details of the premium amounts.

The Plan provides for the Organization to provide sufficient funds to cover claims, insurance premiums for excessive loss coverage and administrative costs in excess of participant contributions and claim recoveries. Any deficit in net assets over benefit obligations will be funded by the Organization and future participant contributions as needed by the Plan. If it is determined that there are excess collections at the Plan's year-end, these excess funds will be applied toward future Organization contributions paid on behalf of its employees during the Plan year, as allowed under ERISA.

#### Benefits

The Plan provides medical and prescription benefits for a variety of eligible services, as defined by the Plan. Such services include, but are not limited to, inpatient hospital services, inpatient and outpatient physician services, inpatient and outpatient surgery, emergency room services, medical supplies, prescription medication, ambulance services, physical therapy, inpatient mental health/substance abuse treatment and home health care. The Plan offers coverage under PPO and HMO plan options that participants can choose.

The Plan provides participants with various levels of coverage depending on the type of service rendered, as described in the Plan. Basic limits under the Plan are as follows:

Health benefits are payable after the satisfaction of an individual’s or family’s calendar year deductible. Benefits are paid at the coinsurance level until out-of-pocket expenses for eligible charges reach the annual maximum level noted above and at 100% thereafter.

The Plan provides for qualified beneficiaries to have prescription drug coverage under the Medicare Prescription Drug, Improvement and Modernization Act of 2003. Incurred but not reported claims and the changes in the benefit obligation have not been adjusted for any amount associated with the Medicare subsidy as the Plan is not directly entitled to such a subsidy.

The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). The participant is responsible to pay for the cost of the Plan and can extend coverage for up to 36 months depending upon specific circumstances.

#### **Stop-Loss Insurance**

The Organization maintains stop-loss agreements that provide for reimbursements of self-insured medical and prescription claims individually exceeding \$50,000 for participants covered under the Plan. Premiums for stop-loss insurance are included in premium payments in the accompanying statements of changes in benefit obligations and net assets available for benefits. Stop-loss refunds totaling \$58,343 have been netted with claims paid in the accompanying statement of changes in benefit obligations and net assets available for benefits.

#### **Prescription Rebates**

Prescription rebates are recorded in the period in which the rebates are received as rebates are not quantifiable or estimable until received. Prescription rebates totaling \$28,666 have been netted with claims paid in the accompanying statement of changes in benefit obligations and net assets available for benefits.

#### **Payment of Benefits**

Premiums paid are recorded as premium payments in the accompanying statement of changes in benefit obligations and net assets available for benefits. Claims payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable in the accompanying statement of benefit obligations and net assets available for benefit.

#### **Benefit Obligations**

Benefit obligations are comprised of three components: (1) claims that have been reported but not yet processed for payment; (2) claims incurred but not reported; and (3) premiums and fees due under insurance agreements but not yet paid. The claims incurred but not reported are determined by the Organization based on a review of third party administrator generated reports of claims paid subsequent to year-end.

The completion factor method is an established actuarial method and is based on claims history and claim trends. The analysis was done on a lag basis using claims incurred through June 30, 2024 and claims that were paid through the end of June 30, 2024. For the year ended June 30, 2024, management's calculation, which utilized more current claims data, resulted in higher than computed by the actuary reserve. Such adjustment

#### **Administrative Expenses**

Expenses incurred in the administration of the Plan are paid by the Plan and its participants, unless the Organization, at its discretion, elects to pay them. The Plan paid administrative expenses totaling \$195,073 for the year ended June 30, 2024. Expenses that are not paid by the Plan are excluded from the Plan's financial statements.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, benefit obligations and changes therein, liability for unsettled and incurred but not reported health claims, premiums due to insurers and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and benefit obligations and deductions from net assets and benefit obligations during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

Plan contributions are made and the benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

#### Subsequent Events

The Plan evaluated for disclosure any subsequent events through October 2, 2025, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure except as disclosed in Note 1.

### 3. INCOME TAXES

The Trust received a determination letter dated June 05, 2023, from the Internal Revenue Service that the Trust is tax exempt under Section 501(c)(9) of the Internal Revenue Code (the Code). As an employee welfare benefit plan and related taxable trust, the Plan and Trust are required to operate in conformity with the Code and ERISA. The Plan administrator believes the Plan and Trust are operating in conformity with the Code and ERISA.

The Plan's activities typically do not generate taxable income. During the year ended June 30, 2024, the Plan earned interest income of \$5,962 and recorded a provision for income taxes of \$1,648 that has been included in the Plan's financial statements.

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. The amount recognized is measured as the largest amount of benefit that is greater than 50% likelihood of being realized upon ultimate settlement. Given the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements.

The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of June 30, 2024.

The Plan is subject to routine audits by the IRS and the Department of Labor; however, there are currently no audits for any periods in progress.

### 4. PARTY-IN-INTEREST TRANSACTIONS

Administrative expenses paid by the Plan and its participants include fees and commissions paid to CareFirst Administrators, Benecon Group, LLC, and TriBridg e Partners for claims processing and benefit administration. The Organization provides certain accounting and administrative services to the Plan for which no fees are charged. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 5. PLAN TERMINATION

The Plan is dependent upon the Organization to fund benefit payments for participants. Although it has not expressed any intent to do so, the Organization has the right under the Plan agreement to terminate the Plan subject to the provisions of ERISA. Upon termination, the Organization and Plan will be responsible for any outstanding and previously incurred benefit claims.

### 6. FAIR VALUE MEASUREMENT

ASC 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement levels within the fair value hierarchy are based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024.

*Interest-bearing cash:* Valued at amortized cost, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date.
