Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Profit Sharing Plan and Trust of West Coast Paper Company, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Profit Sharing Plan and Trust of West Coast Paper Company's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Profit Sharing Plan and Trust of West Coast Paper Company and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Profit Sharing Plan and Trust of West Coast Paper Company's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Description of Plan

The Profit Sharing Plan and Trust of West Coast Paper Company (the Plan) is a multiple employer defined contribution plan sponsored by West Coast Paper Company (dba WCP Solutions). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan covers employees of West Coast Paper Company and Central Oregon Paper Company L.L.C. (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). West Coast Paper Company is the Plan's sponsor and serves as Plan administrator.

Eligibility – Employees who are not covered by a collective bargaining agreement, who are not leased employees, or who are not independent contractors are eligible to participate in the Plan and receive fixed company matching contributions on the first day of the calendar month following their hire date. Participants must attain 21 years of age and be employed as of the last day of the Plan year to receive the Company's profit sharing and discretionary contributions. Employees of Central Oregon Paper Company, LLC, are excluded from the fixed company matching contributions.

Contributions

Participant contributions – Participants may make voluntary pre-tax or after-tax Roth contributions of up to 100% of their eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified retirement plans. The Plan has an auto-enrollment feature whereby employees, upon becoming eligible, will be automatically enrolled by the Company to contribute 6% of eligible compensation unless the participant elects a different contribution percentage or files an election form to withdraw their participation from the Plan.

Employer contributions – The Company makes fixed matching contributions to the Plan equal to 50% of each eligible participant's eligible contributions, not to exceed 6% of the participant's compensation for that year. Therefore, the maximum matching contribution is 3% of a participant's annual eligible compensation. The Company may change or discontinue the matching contributions by amending or terminating the relevant provisions of the Plan. For the year ended December 31, 2024, the Company made matching contributions totaling \$1,257,895.

The Company may also elect to make discretionary matching and/or profit sharing contributions to the Plan. These contributions are allocated on a pro-rata basis based on a participant's contributions or based on eligible participants' compensation for the Plan year. For the year ended December 31, 2024, the Company made no additional discretionary matching contributions.

Contributions are subject to limitations established under the Internal Revenue Code (IRC).

Participant accounts – Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participant contributions and related earnings are 100% vested at all times. The Company’s profit sharing, discretionary and fixed matching contributions, and related earnings become 100% vested upon death, total disability, or termination of the Plan. Otherwise, vesting in the Company’s contributions is based upon years of service according to the following schedule:

<u>Years of Service</u>	<u>Vesting</u>
Less than one year	0%
One year	20%
Two years	40%
Three years	60%
Four years	80%
Five years or more	100%

Notes receivable from participants – A participant may borrow 50% of their vested account balance up to a maximum of \$50,000. The minimum loan amount is \$1,000. Loans are repayable through payroll deductions over periods ranging up to five years, unless the loan is used to acquire a principal residence, in which case the loan term may not exceed ten years. Loans are secured by the balance in the participant’s account, and participants are limited to one loan outstanding at any time. As of December 31, 2024, the interest rates on outstanding loans ranged from 4.25% to 9.50% with various maturity dates through September 2034.

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and used to reduce future company matching contributions or to pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$53,616 and \$64,362, respectively. For the year ended December 31, 2024, Company matching contributions were reduced by \$81,033 from forfeited nonvested accounts.

Payment of benefits – Upon termination of service due to death, disability, or retirement, a participant (or beneficiary) may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in a lump-sum amount or in other forms of payment, as described in the Plan document. Terminated participant accounts below \$5,000 are automatically distributed from the Plan in a lump sum.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation – Investments are reported at fair value. The Plan's custodian, Charles Schwab Trust Bank (the Custodian), certifies the fair value of all investments. If available, quoted market values are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits – Benefits are recorded when paid.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest and are classified as notes receivable. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event based on the terms of the Plan agreement.

Administrative expenses – The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Expenses paid by the Plan are generally allocated among the accounts of participants or may be paid from the forfeiture account. Loan and other transaction fees are excluded from the allocation and paid directly by the respective participants.

The Plan shares in management fee revenues generated within certain mutual fund investments. The shared revenues may be used to pay qualified investment and administrative expenses of the Plan or be allocated quarterly among the accounts of participants who hold the mutual funds that generate revenue sharing. For the year ended December 31, 2024, shared revenues totaling \$24,419 are included in other income and were used to pay administrative expenses during the year.

Benefits distribution payable – The benefits distribution payable represents benefits paid to participants subsequent to Plan year end that were initiated by participants as of December 31, 2024 and 2023 for \$0 and \$438,895 respectively.

Plan termination – The Company expects to continue the Plan indefinitely but reserves the right to terminate the Plan at any time, subject to the provisions of ERISA. Upon termination, the obligation of the Company to make contributions to the Plan shall cease and all amounts credited to the participants' accounts shall be fully vested. The Company may then direct the custodian to either distribute the funds to the participants or continue the Plan's trust, with distributions to be made pursuant to the Plan's provisions.

Subsequent events – The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Collective trust – Units held in the collective trust (CT) are valued using the NAV practical expedient as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of shares outstanding. The CT is subject to restrictions regarding transfer and withdrawal of assets including potential deferral of withdrawal requests by up to 12 months.

The CT can be redeemed daily, and there are no redemption restrictions or notice requirements.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Notes to Financial Statements

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

Note 6 – Certified Investment Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan has certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and dividends and interest reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) except for participant loans.

Note 7 – Party-in-Interest Transactions

Certain Plan investments are managed by the custodian of the Plan and an affiliate of the custodian; therefore, transactions with these entities qualify as exempt party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 8 – Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. These employee deferrals are related to the 2023 Plan year.
