To the Plan Administrator of the Live Nation
Entertainment, Inc. 401(k) Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Live Nation Entertainment, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Live Nation Entertainment, Inc. 401(k) Savings Plan (the "Plan") is provided for general information purposes only. PARTICIPANTS SHOULD REFER TO THE SUMMARY PLAN DESCRIPTION REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. General

The Plan is a defined contribution plan covering all eligible employees, as defined in the Plan, of Live Nation Entertainment, Inc. (the "Plan Sponsor" and "Company"), its participating subsidiaries and specified affiliates ("Employer"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

All employees classified as full-time, who are at least 21 years of age, are immediately eligible to participate in the Plan. All employees classified as part-time, who are at least 21 years of age, are eligible to participate in the Plan upon attaining one year of service and 1,000 hours.

B. Contributions

Each year, eligible employees, may contribute up to 50% of pretax annual compensation and/or Roth contributions, as defined in the Plan, subject to Internal Revenue Code (the "Code") limitations. Eligible employees may also make rollover contributions from other qualified defined benefit or defined contribution plans. The Company may in its discretion elect that each participating employer match a percentage of each eligible participant's pre-tax deferral contributions (excluding catch-up contributions) made to the Plan on a per payroll basis. In addition, the Company may make an additional discretionary matching contribution on behalf of all eligible employees who are employed on the last day of the Plan year. There was no additional discretionary matching contributions made for year ended December 31, 2024.

Contributions made by the employer on a participant's behalf are deposited in the Plan and generally allocated among investment funds in accordance with the participant's investment elections.

C. Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the amount of the participant's vested account at a particular time. A participant may generally elect to transfer investments from any investment fund to any other investment fund on a daily basis.

D. Administrative Expenses

Certain administrative expenses of the Plan are paid by the Employer or the Plan. The Plan was reimbursed \$676,998 of administrative expenses from the Trustee.

E. Vesting

Participants are immediately vested in their deferral contributions, rollovers plus actual earnings thereon. Vesting in the Company contribution portion of their accounts, plus actual earnings thereon, is based on years of service as defined in the Plan. A participant is not vested until after two years of service. A participant is 50% vested after two years of service and 100% vested after three years of service.

E. Vesting (Continued)

A year of service is defined as a period in which a participant earns 1,000 or more hours of service. Notwithstanding the foregoing, if a participant is employed by the Company on his or her normal retirement date (age 65), early retirement date, if applicable, the date he or she becomes disabled (as defined in the Plan), or the date he or she dies, his or her vested interest in Company contributions on such date accelerates to 100%.

F. Forfeiture of Benefits

If a participant terminates prior to vesting 100% in Company contributions, the forfeited balance will be used to reduce Company contributions or pay administrative expenses. At December 31, 2024 and 2023, the Plan had \$446,862 and \$437,364 respectively, of unused forfeitures. Forfeitures in 2024 totaled \$856,033; forfeitures used to reduce Company contributions and pay plan expenses in 2024 totaled \$688,111 and \$189,488, respectively.

G. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at available market financing rates and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence, in which case the maximum repayment period is 15 years. The plan administrator establishes the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with various maturities through August 2039.

H. Payments of Benefits

Upon termination of service due to death, retirement or early retirement, as defined in the Plan document, a participant may elect to receive a distribution of his or her vested account balance in a lump-sum amount. The Plan allows for hardship distributions, as defined in the Plan document. Withdrawals made by terminating participants are based upon the vested balance in their individual account at the time of termination and are recorded in the year of distribution.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Valuation of Investments and Income Recognition

The trustee manages the Plan's funds on behalf of the Plan and is responsible for keeping the related records. Upon enrollment in the Plan, participants may direct contributions to any investment in accordance with the available investment options and may change their investment options in accordance with Plan procedures.

C. Valuation of Investments and Income Recognition (Continued)

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are based on quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds, common stocks and money market funds are classified as Level 1 as their values are determined based on quoted market prices in active markets. Capital gains are recorded as interest and dividends. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

D. Insurance Company Guaranteed Interest Fund

Investments held by an employee benefit plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under a contract, plus earnings, less participant withdrawals and administrative expenses.

D. Insurance Company Guaranteed Interest Fund (Continued)

The Plan maintains a fully benefit-responsive group annuity contract with New York Life Insurance Co. through the Guaranteed Interest Fund. Contributions to the Guaranteed Interest Fund are maintained in an insurance company general account and credited for interest and charged for participant withdrawals and administrative expenses. New York Life Insurance Co. is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Guaranteed Interest Fund meets fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions to terms of the Plan.

NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and net investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedules were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 4 - INCOME TAX STATUS

The Plan obtained its latest determination letter dated October 17, 2012, in which the Internal Revenue Service stated that the Plan, as then designed was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently intended to be designed and operated in substantial compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - TERMINATION OF THE PLAN

Although they have not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan's termination, participants will become 100% vested in their accounts.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company or an affiliate. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investments that are exposed to risks such as interest rate, market fluctuations, and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2024, the plan administrator unintentionally did not remit \$27,982 of participant contributions and loan repayments within the time frame specified by the Department of Labor ("DOL"). Failure to remit such amounts within the designated time frame constitutes a prohibited transaction under DOL regulations. The Company has advised that the appropriate corrections will be made in 2025.

NOTE 10 - PLAN AMENDMENTS

During 2023, the Plan adopted the following amendments:

- To include Meadowbrook Amphitheatre Holdings, LLC as a participating employer in the Plan as of September 1, 2023.
- To automatically enroll eligible participants at a 3% deferral rate of compensation, with an annual increase of 1% up to a maximum of 6% as of January 1, 2024.
- To adopt the Securing a Strong Retirement ("SECURE 2.0") Act as of January 1, 2024.
- To add the following as participating employers into the Plan.
 - V Major, LLC as of January 1, 2024
 - The Core Entertainment, LLC as of January 1, 2024
 - Palm Tree Cre Artist Management as of January 1, 2024
 - Mercury Ballroom as of February 1, 2024
 - Bowery Ballroom as of February 1, 2024

NOTE 11 - SUBSEQUENT EVENTS

During 2025, the Plan adopted amendments to add the following as participating employers:

- Split Second Management, LLC, effective January 1, 2025.
- Timeline Management LLC, effective May 1, 2025.
- Lionfish Management, LLC, effective May 1, 2025.
- Postfontaine Holdings, LLC, effective October 1, 2025.

Management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued. Except as noted above, there were no other material subsequent events that required recognition or additional disclosures in these financial statements.
