**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Intradiem, Inc Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a contributory, defined contribution plan covering substantially all employees of Intradiem, Inc. (the “Company”), who are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). On April 1, 2024, the Plan Sponsor transitioned trustees and record keepers, and the Plan’s assets were transferred from Ascensus Trust Company (“Ascensus”) to Empower Retirement, LLC (“Empower”) as custodian and from Ascensus to Empower as record keeper.

**Contributions** - A participant may contribute up to the maximum that is allowed by law of compensation, as defined, as an authorized payroll deduction. The Plan allows participants to designate a portion or all of the deferral contributions at the time the deferral election is made as a Roth deferral contribution. Participants who have attained age 50 are eligible to make catch-up contributions before the end of the plan year. The Company may make matching contributions equal to a discretionary percentage, to be determined by the Company, of the participant’s salary reductions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The plan includes an automatic enrollment provision whereby participants are enrolled in the plan at 4% on the first day of the month after which they become eligible. Deferrals increase by 2% each year up to a maximum of 12%, unless the employee elects to not contribute or to defer at a different percentage. The Company has elected a Safe Harbor plan and matches 100% or the first 4% of compensation of a participant’s elective deferrals. In addition, the Company may, at its discretion, make a profit-sharing contribution to the Plan. The Company elected to make no profit-sharing contribution for the year ended December 31, 2024. Contributions from Plan participants and the matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Participant accounts** - Each participant’s account is credited with the participant’s contribution and Company matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account. Participants vest in employer contributions and the income earned thereon immediately on the participants effective date of participation.

**Notes receivable from participants** - Employees who have participated in the Plan may borrow against the vested portion of their account balance. The minimum amount of any loan is \$1,000, and the loan cannot exceed 50% of the vested portion of the participant’s account balance or \$50,000, whichever is less. One residence related loan and one other loan per participant may be outstanding at any time. Payments of principal and interest are made semi-monthly through payroll deduction. The loans are secured by the balance in the participant’s account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Vesting** - Participants are fully vested at all times in all amounts attributable to the employer Safe Harbor matching contributions and employee contributions and the income earned therein. Participants are 100% vested in the Company's profit-sharing contributions after six years of credited service.

**Payment of benefits** - On termination of service due to death, disability or retirement, a participant, or their beneficiary, may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or non-recurring partial payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Forfeitures** - Amounts that are forfeited due to a participant's termination of employment prior to vesting in company contributions made on the participant's behalf are used to reduce the required company contribution in subsequent periods or to pay plan expenses. The balance in the forfeiture account totaled \$11,663 and \$-0- as of December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Intradiem, Inc Retirement Savings Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized gains and losses on investments are included in the net appreciation in fair value of investments on the accompanying statement of changes in net assets available for benefits.

**Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded monthly. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If participant ceases to make loan repayments or becomes delinquent and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of benefits** - Benefits are recorded when paid. As of December 31, 2024, no benefits were due to participants who have withdrawn from participation from the Plan and requested a benefit distribution.

**Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 INFORMATION PREPARED AND CERTIFIED BY TRUSTEES**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Ascensus Trust Company ("Ascensus") and Empower Retirement, LLC ("Empower"), the trustees of the Plan, as complete and accurate, except for comparing such information certified by the trustees to information included in the Plan's financial statements and supplemental schedule:

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 2** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds and stable value funds:* Valued based on the share prices/net asset values ("NAV") reported on the plan summary reports for funds which are obtained directly from the fund house or other investment provider.

**NOTE 5 RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Empower, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Empower amounted to \$5,273 for the year ended December 31, 2024.

**NOTE 5 RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS (CONTINUED)**

Empower provides certain administrative services to the Plan pursuant to a Master Plan Service Agreement (“MSA”) between the Company and Empower. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative and investment advisory services to the Plan.

If the revenue received by Empower from such mutual fund service providers exceeds the amount owed under the MSA, Empower remits the excess to the Plan’s trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Empower for administrative expenses not covered by revenue sharing.

**NOTE 6 TAX STATUS**

The Company has adopted the Plan based on a volume plan submitter plan documented sponsored by Empower Retirement, LLC. Empower Retirement, LLC has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, that states that the form of the volume submitter plan is acceptable under Section 401 of the Internal Revenue Code (“IRC”). The plan administration believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Plan participants are 100% vested in their accounts at all times including in the event of plan termination.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

The net assets available for benefits per the financial statements agree with the net assets available for benefits per the Form 5500.

There are no reconciling differences in contributions received from participants between the financial statement and the Form 5500. Amounts allocated to withdrawing participants are recorded in the Form 5500 for benefits claims that have been processed and approved for payment prior to December 31, but not yet paid as of that date. No approved benefit claims existed at December 31, 2024, which were not paid.

**NOTE 10 DELINQUENT EMPLOYEE DEFERRALS AND LOAN REPAYMENT TRANSMITTALS**

During 2023, the Company erroneously failed to timely remit certain employee deferrals and loan repayments to the Plan aggregating \$32,421. These details were corrected as of December 31, 2024, at which time the Company had submitted the lost earnings on these 2023 delinquent deferrals aggregating \$103 to the affected participants in the Plan.

**NOTE 11 SUBSEQUENT EVENTS**

The Plan evaluated all subsequent events through October 13, 2025, the date the financial statements were issued.
