## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule of Assets Held at End of Year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Notes to Financial Statements Year Ended December 31, 2024

---

### 1. Description of Plan

The following brief description of KHS America, Inc., 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering substantially all employees of KHS America, Inc. and KHS America Holdings, Inc. (collectively, the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s custodian is Empower Trust Company, LLC (the “Custodian”), and the recordkeeper is Empower Retirement, LLC (the “Recordkeeper”). Officers act as trustees (the “Trustees”) of the Plan, Company management personnel administer the Plan internally, and FuturePlan by Ascensus is a third-party administrator of the Plan.

**Eligibility** - An employee who is at least eighteen years of age is eligible to participate in the Plan on the first day of the quarter coinciding with or next following the completion of three months of service. Certain employee classes are excluded from participation in the Plan, as defined.

**Contributions** - Participants have the option to contribute pre-tax and Roth contributions up to the annual limit established by the Internal Revenue Code (“IRC”). The Plan has a qualified automatic contribution arrangement (“QACA”) in which eligible employees are automatically enrolled to contribute 3% of their eligible compensation on a pre-tax basis, unless the employee opts out. This contribution amount automatically increases annually by 1% of eligible compensation, up to a maximum participant contribution equal to 6% of eligible compensation. A participant’s pre-tax and Roth contributions will be separately accounted for, as will the gains and losses attributable to each. Participants who reach fifty years of age before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts.

The Company makes a QACA basic employer matching contribution in an amount equal to 100% of the first 1% of contributed compensation and 50% of the next 5% of contributed compensation. The Company may also make a discretionary profit-sharing or additional matching contribution, neither of which were elected during the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan.

**Participant Accounts** - Each participant’s account is credited with the participant’s contributions, the Company’s contributions and an allocation of Plan earnings, and may be charged with an allocation of Plan expenses, as applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

**Notes Receivable from Participants** - Effective April 1, 2021, new notes receivable from participants are not permitted. Payments for existing notes receivable were deducted through after-tax payroll deductions. All outstanding notes receivable balances were secured by the vested balance in the participant's account and were repaid during the year ended December 31, 2024.

**Vesting** - Participants are immediately vested in their voluntary and discretionary employer contributions plus actual earnings thereon. QACA basic employer matching contributions plus actual earnings thereon vest according to a two-year cliff vesting schedule, as defined. Participants may also become fully vested upon reaching retirement age, if they become disabled while employed with the Company, or terminate employment due to death.

**Payment of Benefits** - Benefits are generally payable upon age 59.5, disability, death, retirement or termination of employment. Benefits equal to the participant's vested account balance may be paid to a participant or beneficiary by lump sum in most circumstances or rollover into a qualified plan, subject to regulatory requirements. Required minimum distributions are made to applicable participants in the absence of adequate distribution elections. Generally, if no longer employed by the Company, participants must either take a lump sum distribution or begin systematic, actuarially determined withdrawals by April 1 of the year following the year in which the participant turns 73 years of age. The Plan administrator may, without the participants' consent, distribute separated participants' account balances that are less than \$1,000 in a lump sum or transfer separated participants' account balances that are at least \$1,000 but less than \$5,000 into an individual retirement account. In-service distributions of rollover contributions may be taken at any time. Other in-service distributions, including hardship distributions, are permitted if certain criteria are met.

**Forfeitures** - Forfeitures by participants of unvested Company contributions are used to reduce future employer contributions and pay Plan administrative expenses. The forfeited unvested account balance totaled \$24,928 and \$11,316 as of December 31, 2024 and 2023, respectively.

**Current Legislation** - The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date, and any SECURE 2.0 amendments must be adopted by the Plan no later than December 31, 2026, although it may operate under the new provisions as required or elected prior to amending the Plan document. The Company is currently evaluating the impact of the remaining required and voluntary provisions of SECURE 2.0 on the Plan and its participants.

## 2. Significant Accounting Policies

**Basis of Accounting** - The Plan's financial statements are prepared on the accrual basis of accounting.

**Accounting Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees and 401(k) Committee determine the Plan's valuation policies utilizing information provided by the Custodian and the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the Plan year.

**Contributions Receivable** - Contributions from participants and any related employer matching contributions are recorded in the year in which the participant contributions are withheld from compensation. The Company recognizes an allowance for credit losses based on factors such as the age of the contribution receivable balance, historical experience, current economic conditions, and reasonable and supportable forecasts. There was no allowance for estimated credit losses as of December 31, 2023 as management deemed the outstanding contribution receivable balances collectible.

**Notes Receivable from Participants** - Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**Benefits Paid to Participants** - Benefits are recorded when paid.

**Expenses and Revenue Sharing** - The Company may pay certain administrative and operating costs of the Plan at no obligation to the Plan. Fees related to the administration of distributions, and certain other fees paid to service providers, are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses, such as management fees and operating expenses, are deducted from earnings recorded to net appreciation in fair value of investments.

The Plan has revenue sharing arrangements whereby certain investment managers return a portion of the investment fees to the Recordkeeper. These amounts are used by the Recordkeeper to offset the Plan's administrative expenses or to allocate to participant accounts, as defined, with any excess amounts held in an unallocated account to be used in future years. The unallocated account balance totaled \$31,994 and \$24,958 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, the Company used \$30,803 from the unallocated account to pay administrative expenses incurred by the Plan. Administrative expenses are presented net of revenue sharing earnings.

**Risks and Uncertainties** - Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contribution portion of their accounts.

**Subsequent Events** - The Company evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued, and no events have occurred through that date that would impact the financial statements.

### **3. Information Certified by the Custodian**

Certain information disclosed in the accompanying financial statements, notes and supplemental schedule related to the Plan's investments held as of December 31, 2024 and 2023, notes receivable from participants held as of December 31, 2023, and the related net investment gain and interest income on notes receivable from participants during the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian, a qualified institution.

### **4. Fair Value Measurements**

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**5. Tax Status**

The Company has adopted a pre-approved plan document from Ascensus LLC that received an Internal Revenue Service (“IRS”) opinion letter dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Party-in-Interest and Related Party Transactions**

The Plan paid both direct and indirect fees to the Recordkeeper or its affiliates, investment advisors, and a third-party administrator. Certain investment managers return a portion of the investment fees to the Recordkeeper, which are used to offset administrative expenses or to allocate to participant accounts, as defined. Transactions such as these, as well as notes receivable from participants, qualify as exempt party-in-interest transactions. The Company pays directly certain other fees related to the Plan’s operations.
