### Note 1: Description of Plan

The following description of the American Tel-A-Systems, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees, except interns and temporary employees, of American Tel-A-Systems, Inc. (the Employer) who are age 21 or older. Effective January 1, 2024, under SECURE Act 2.0, long-term part-time employees are now eligible to participate if achieving 500 service hours in the previous three consecutive years of service. Participants are eligible to make deferral contributions and receive discretionary Employer matching contributions after they have completed three months of service. Participants are eligible to receive Employer discretionary nonelective profit-sharing (if declared) after completing at least three months of service, provided they had 1,000 service hours during the plan year, and were employed by the Employer on the last day of the contribution period. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants are allowed to contribute, on a pretax or after-tax basis, up to 60% of eligible compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to roll over distributions from other qualified retirement plans. Participants direct the investment of contributions into various investment options offered by the Plan. The Employer may elect to make discretionary matching contributions or nonelective profit-sharing contributions, but did not elect to make any such contributions during the year ended December 31, 2024.

The Plan has an automatic enrollment feature which enrolls all eligible participants, except those who affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, until changed by the participant.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's discretionary matching contributions (if any), and allocations of the Employer's discretionary nonelective profit-sharing contributions (if any) and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

A participant is fully and immediately vested in their contributions and rollover contributions, plus actual earnings thereon. A participant is vested in the Employer's discretionary matching contributions and nonelective profit-sharing contributions plus actual earnings thereon according to a three-year cliff schedule, whereby they are 0% vested until credited with 3 years of service, after which they are 100% vested.

### **Note 1: Description of Plan (Continued)**

#### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loan terms range from one to five years, unless made for the purchase of a primary residence when the term may not exceed 10 years. Loans are secured by the participant's investment accounts and bear interest at rates ranging from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest payments are paid ratably through payroll deductions.

#### **Payment of Benefits**

Upon death, disability, retirement, or upon separation from service with the Employer, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or a series of installment payments. In-service withdrawals are permitted from deferral contributions in the event of financial hardship, as defined in the Plan. Participant account balances less than \$5,000 are distributable, in a lump-sum payment only, within 90 days to the participant upon termination of employment. Terminated participants are also allowed to withdraw any portion of their vested account as a partial benefit. The Plan also allows for in-service distributions upon reaching age 59½.

#### **Forfeitures**

Forfeitures of nonvested participant balances are used to reduce Employer contributions or to pay Plan administrative expenses. As of December 31, 2024 and 2023, there were no significant amounts available in the Plan's forfeiture account.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

### **Note 2: Summary of Significant Accounting Policies (Continued)**

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to the participant recordkeeping and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been changes in the methodologies used as of December 31, 2024 and 2023 for the stable value collective trust fund from Level 2 to investment assets measured at net asset value (NAV) as described below.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust fund:* Valued at net asset value ("NAV") provided by the plan administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. The fund is a stable value fund and its NAV is based on the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. There are no restrictions as to the redemption of this investment or unfunded commitments as of December 31, 2024 and 2023.

### Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

### Note 5: Party-in-Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company or its affiliate. Fidelity Management Trust Company is the Trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for recordkeeping and transaction services were \$1,794, netted with revenue-sharing amounts received of \$16,000 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### Note 7: Tax Status

The Employer adopted a nonstandard pre-approved plan document with an Internal Revenue Service notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
