## **Note 1. Description of the Plan**

The following description of ASM/CTI 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

### **General**

The Plan is a defined-contribution plan sponsored by Advantage Sintered Metals, Inc. (ASM) (Company) for the benefit of its employees who have completed at least three months of employment and are age 21 or older. A related employer who also participates is Contact Technologies, Inc. (CTI). Employees are eligible to participate in the Plan on the first day of each calendar month upon meeting eligibility requirements. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Members of management serve as the Plan trustees. Ascensus Trust Company (Ascensus) serves as custodian of the Plan. The Vanguard Group (Vanguard) serves as the recordkeeper of the Plan.

### **Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions up to the maximum percentage allowable by law. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants who have elected to make compensation deferrals may elect to increase, decrease, suspend or resume their salary reduction agreements at their discretion.

The Plan is a Safe Harbor 401(k) Plan, with employer matching contributions on 100% of participants' first 3% of eligible compensation, and 50% of the next 2% of eligible compensation, as calculated on a Plan Year basis. Employer matching and discretionary profit-sharing contributions outside of Safe Harbor contributions are not permitted. Contributions are subject to certain limitations.

### **Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation at any time.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after three years of credited service. The nonvested balance is forfeited upon termination of service.

### ***Notes Receivable From Participants***

The Plan Document includes provisions authorizing loans from the Plan to active, eligible participants. Loans are made to any eligible participant for any purpose. The maximum amount of a participant's loans is determined by the available loan balance restricted to 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account. Interest on the notes are 2% above the prime lending rate at the date of the loan. Principal and interest is paid ratably through payroll deductions unless the participant is paying the loan in full. The term of the loan may not exceed five years (except for loans for the purchase of a principal residence to which then the loan period may not exceed twenty-five years). Effective September 1, 2023, a participant may only have two loans outstanding at any time.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

### ***Payment of Benefits***

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of their account. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, there were no forfeited nonvested accounts held in the Plan. During 2024 and 2023, \$925 and \$427, respectively, of forfeited funds were used to pay Plan expenses.

### ***Plan Terminations***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### ***Subsequent Events***

Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. The Plan's interest in the collective trust is valued at NAV based on information using the financial statements of the fund at year end. The NAV is used as a practical expedient to estimate fair value. The investment may be redeemed daily and has no unfunded commitments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Tax Status***

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and custodial document sponsored by The Oldenburg Company, Inc. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the nonstandardized prototype document has a favorable opinion letter from the IRS. The Plan has been amended since the prototype received the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. Level 2 securities include the pooled separate accounts and are valued as described in Note 2. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan does not have any investments classified within Level 2 or Level 3 of the valuation hierarchy.

### **Note 5. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan holds cash equivalents issued by the Plan custodian. The Company provides certain administrative services at no cost to the Plan. The Plan paid \$13,084 and \$13,010 of administrative expenses to the custodian of the Plan during 2024 and 2023, respectively. The Company paid \$18,257 and \$14,802 of investment advisory and other service fees to various other parties-in-interest during 2024 and 2023, respectively.

### **Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 7. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions and loan repayments to the Plan, contributions of \$7,452 and \$127,807 and loan repayments of \$80 and \$2,032 were not remitted within the required time period for the years ended December 31, 2024 and 2023, respectively.
