## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
UFCW Local 342 Savings and 401(k) Plan

### Opinion

We have audited the financial statements of the UFCW Local 342 Savings and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). # UFCW LOCAL 342 SAVINGS AND 401(K) PLAN

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### NOTE 1. DESCRIPTION OF THE PLAN

**General** - The following brief description of the UFCW Local 342 Savings and 401(k) Plan (the Plan) provides only general information. Participants should refer to their Summary Plan Description for a more complete description of the Plan's provisions.

The Plan is a collectively bargained multiemployer defined contribution pension plan. The Plan provides retirement benefits to participants, who, during active employment, were covered employees of contributing employers having collectively bargained agreements with Local 342 of the United Food and Commercial Workers and its successors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Vesting** - Under current provisions of the Plan, a participant becomes eligible either on the date the participant's collectively bargained employer first becomes obligated to make contributions to the Plan on their behalf or the later of the participant reaching the age of twenty-one or the completion of one thousand hours of service in their first twelve months of the employment with the collectively bargained employer or in any plan year after the participant has begun employment.

**Contributions and Participants Accounts** - Contributions to the Plan are invested and allocated to the individual participant's accounts. During 2008 only employer contributions were permitted under the Plan, however, effective January 1, 2009, participant contributions were permitted if they were stipulated in the respective Collective Bargaining Agreement. Effective January 1, 2009, the Plan allows for participant directed investing under an investment agreement with John Hancock Retirement Plan Services. Participants are completely vested in their balance of employer contributions upon completion of three years of vesting service or attainment of normal retirement age while working in covered employment. After the three years have been attained, the participant's account will become non-forfeitable. Participant contributions to their own account balance through participant and/or rollover contributions are immediately vested.

Contributions to the Plan are invested, as directed by the participant, in various mutual funds, and a pooled separate account. Participants must evaluate their own investment goals and objectives and choose the mutual funds best suited to achieve those goals and objectives. Poor investment performance by the mutual funds selected by participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf.

Participant accounts are adjusted on each valuation date to reflect the effects of contributions, withdrawals, income, expense and realized and unrealized gains and losses that were applied to each investment fund or funds in which the participant had elected to invest in.

## **NOTE 1. DESCRIPTION OF THE PLAN (continued)**

**Benefits** - Benefits will be available upon the attainment of normal retirement age of sixty-five or three years participation, if later, termination of employment or the participant's death. Benefits are paid out, depending on the account balance and retirement age, in either a single lump-sum cash payment or a direct rollover distribution. Participants may also be eligible to take a hardship withdrawal. "Hardship" is defined as an immediate and heavy financial need of the participant, for which the participant lacks other available resources. Such withdrawals are subject to specific qualification requirements.

**Participant Loans** - Effective May 20, 2014, participants may obtain loans from the vested value of their account. The maximum that may be borrowed is the lesser of \$50,000 or 50% of their vested account balance. The minimum dollar amount of a loan available to the Participant is \$500. Generally, loans must be repaid within five years/sixty months, except in limited circumstances, such as the purchase of a principal residence, in which case repayment may be made over a period not exceeding ten years/120 months. Loan repayments may be made after termination until the earlier of the loan is paid in full or defaulted upon. The applicable interest rate that shall be assessed by the Plan against any loan incurred will equal the Prime Rate + 1 %. A Participant will be permitted to have two outstanding loans at any time. The repayment of any loan must be made in at least quarterly installments of principal and interest. Loan repayments will be withdrawn first from (a) Employer Contributions; (b) Pre-Tax Contributions; (c) Rollover; (d) Employer Matching Contributions. The loan will not be in default until the end of 90 days from the date the repayment was due or the Internal Revenue Service's statutory limit on loan defaults, whichever is greater.

## **NOTE 2. SUMMARY OF SIGNIFICANT AUDIT POLICIES**

**Method of Accounting** - The accompanying financial statements are prepared using the accrual basis of accounting.

**Investments** - Investments in the mutual funds are carried at fair value which generally represents quoted market prices or the net asset value of the funds as of the last business day of the fiscal year, as provided by the investment company. Short-term investments are carried at cost, which approximates fair value. Purchases and sales are recorded on a trade-date basis. Interest and dividends are recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Fully Benefit-Responsive Investment Contract** - Insurance company pooled separate account is carried at contract value which equals deposits made plus interest created under the terms of the contract less withdrawals.

**Contributions** - Contributions due and not paid at year end are recorded as contributions receivable. Employer contributions are accounted for as exchange transactions. The Plan also allows for employee contributions and rollover contributions from qualified plans. These contributions are accounted for as exchange transactions. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of December 31, 2024 and 2023, the allowance for credit losses was \$28,700 and \$4,900, respectively.

**NOTE 2. SUMMARY OF SIGNIFICANT AUDIT POLICIES (continued)**

**Benefit Payments** - Benefit payments to participants are recorded when paid.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Participant Loans Receivable** - Participant loans receivable is valued at unpaid principal balance plus accrued unpaid interest.

**Forfeited Accounts** - Forfeited non-vested accounts totaled \$192,661 during the year ended December 31, 2024 and \$175,806 during the year ended December 31, 2023. These accounts were used to pay Plan administrative expenses and/or restore previously forfeited balances in 2024.

**NOTE 3. PRIORITIES UPON TERMINATION**

Although it has not expressed any intent to do so, the Trustees have the right to terminate the Plan subject to the provisions of ERISA. Upon termination, each affected participant would become 100% vested in their account.

**NOTE 4. TAX STATUS**

The Plan obtained its latest determination letter on June 3, 2015 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(a). The Plan has been amended since receiving the latest exemption letter. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

## **NOTE 5. FUNDING POLICY**

The Plan is financed by employer and employee contributions. The employer contribution rates are specified in a collective bargaining agreement with employers. These contributions ranged from \$10 to \$862 per month for years ended December 31, 2024 and 2023. During December 31, 2024, fourteen employers made one-time lump sum contributions totaling \$1,229,309. During December 31, 2023, fifteen employers made one-time lump sum contributions totaling \$1,799,241.

Employee contributions are subject to limitations determined by the Internal Revenue Service.

## **NOTE 6. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

### Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

**NOTE 6. FAIR VALUE MEASUREMENTS (continued)**

For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2 or 3.

**NOTE 7. BENEFIT RESPONSIVE INVESTMENT**

The Plan invests in the New York Life Insurance Company's Pooled Separate Account Anchor Account I. This contract is a fully benefit-responsive single group annuity contract that has a fixed rate of interest.

The assets in the Pooled Separate Account Anchor Account I are primarily invested in fixed income securities owned by the New York Life Insurance Company. Contract value is the relevant measure for fully benefit responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Interest is accrued daily and credited monthly to the stable value account and the rates are guaranteed by New York Life Insurance Company to be no less than 0% before any deduction for expenses. The key factors that impact the crediting rate under the group annuity contract are the timing and magnitude of cash flows in and out of the separate account. The interest crediting rate may be reset no more frequently than daily and no less frequently than quarterly. The gross crediting rate allocated to the investment at December 31, 2024 and 2023 was 3.73% and 3.86% respectively.

**NOTE 7. BENEFIT RESPONSIVE INVESTMENT (continued)**

The contract provides certain restrictions, withdrawals for benefit payments at death, retirement, disability and termination of employment and for loans, hardship withdrawals or in-service withdrawals as permitted by the Plan at contract value. Participants may deposit and withdrawal on a daily basis at contract value. Transfers to other funds are also made at contract value, but these transfers may be subject to certain restrictions.

At the termination of the contract, the Plan may receive a book value distribution of the Plan's interest in the stable value account provided that twelve months written notice is given to the New York Life Insurance Company.

**NOTE 8. RELATED PARTY TRANSACTIONS**

The Plan has the following related entities:

- UFCW Local 50-627 Severance Pay Fund
- AMC & RFSEU Local 342 Welfare Fund
- AMC & RFSEU Local 342 Health Care Fund
- AMC & RFSEU Local 342 Group Legal Services Fund
- UFCW Local 342 Safety, Education, Cultural and Activities Fund
- UFCW Local 342

All of the above entities qualify as tax-exempt organizations. The entities listed above share common Trustees or officers with the Plan.

The Plan reimburses UFCW Local 342, AMC & RFSEU Local 342 Welfare Fund, and AMC RFSEU Local 342 Group Legal Services Fund for its portion of shared administrative expenses, which includes salaries and payroll taxes. The shared administrative expenses are allocated on a basis approved by the Plan's Trustees. Due to or from related entities on the Statements of Net Assets Available for Benefits represents the balance owed or receivable for these reimbursements as of December 31, 2024 and 2023, respectively. The reimbursed amounts for the years ended December 31, 2024 and 2023 were \$309,000 and \$1,034,105, respectively.

The Plan shares the cost of the UFCW Local 342 employee pension benefit withdrawal liability due to the Local 153 OPEIU Pension Fund based on a shared expense allocation agreement. The withdrawal liability was determined in March 2013 and reallocated in July 2015 and again in March 2024. The Plan has an allocated withdrawal liability of \$121,222 and \$74,196 for the years ended December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, the Plan made payments of its allocated portion totaling \$22,030 and \$13,959, respectively.

Certain plan investments are shares of mutual funds managed by Main Stay Investments, a New York Life Company. John Hancock Retirement Plan Services is the Trustee, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. These transactions have been denoted as such on the supplemental schedule of assets held at end of year.

The transactions above qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

**NOTE 9. RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments are exposed to various risks such as economic, interest rate, market and sector risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**NOTE 10. NONEXEMPT TRANSACTIONS**

There were certain employers who failed to remit employee deferrals for participant contributions within the time frame required by the Department of Labor (DOL). By DOL regulation an employer is required to segregate employee contributions from its general assets as soon as practicable but no later than fifteen business days after the end of the month in which amounts contributed by employees are withheld from their wages. Any remittances beyond that time are considered to be nonexempt or prohibited transactions by regulation. The total of these transactions was \$9,850 and \$1,637 during the years ended December 31, 2024 and 2023, respectively, which are included in the amount reported in the attached supplemental Schedule of Delinquent Participant Contributions.

**NOTE 11. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
