## INDEPENDENT AUDITORS' REPORT

To the 401(k) Committee

### AMTECH SYSTEMS, INC. 401(k) PLAN

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of **Amtech Systems, Inc. 401(k) Plan** ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). ### (1) Description of the Plan

The following description of Amtech Systems, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. **General** – The Plan is a defined contribution plan. The Plan was originally established January 1, 1988, by Amtech Systems, Inc. (the “Sponsor”). Domestic employees of the Sponsor and six of the Sponsor’s subsidiaries, Bruce Technologies, Inc. (“Bruce”), P.R. Hoffman Machine Products Inc. (“PR Hoffman”), Intersurface Dynamics, Inc. (“IDI”), BTU International, Inc., Entrepix, Inc. (“ENT”), and Advanced Compound Materials, Inc. (“ACMI”) are covered by the Plan. All employees that have completed 90 days of service are eligible to participate in the elective deferral and employer contribution portions of the Plan unless such employee is (1) less than 18 years of age or (2) a person classified by the Sponsor as an independent contractor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).
- B. **Contributions** – Each year, participants may elect to make pre-tax and/or Roth contributions up to 100% of eligible compensation as defined in the Plan, subject to certain limitations established by the Internal Revenue Service. Participants may also contribute amounts representing qualified distributions from other plans. Under the Plan’s automatic enrollment feature, newly eligible participants are automatically enrolled in the Plan, and 4% of the participant’s compensation is contributed on a pre-tax basis unless another election is made by the participant. The automatic contribution amount shall be automatically increased as soon as administratively feasible on or after each January 1 by 1% up to a maximum automatic contribution of 10%. Effective June 1, 2022, the Company increased the deferral rate under the automatic enrollment feature from 4% to 6% for eligible participants’ compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. The Sponsor may make a matching contribution equal to a percentage of employees’ 401(k) elective deferral contributions. The Sponsor may also make an additional discretionary matching contribution after year end to participants employed as of year-end. For the year ended December 31, 2024, the Sponsor made matching contributions equal to 60% of the employees’ eligible elective deferrals, up to 3.6% of the participants’ eligible compensation for each payroll period.
- C. **Participant accounts** – Individual accounts are maintained for each participant. Each participant’s account is credited with the participant’s contribution and allocations of the Sponsor’s contributions, and Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.
- D. **Vesting** – Participants are immediately vested in their pre-tax, Roth, and rollover contributions and actual earnings thereon. Vesting in the Sponsor’s matching contributions plus actual earnings thereon is based on years of service as follows:

- E. **Notes receivable from participants** – Participants may borrow against their vested account balances a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balances in the participants’ account and bear interest at a fixed rate based on the U.S. prime rate at the time the loan is distributed. Loans are expected to be repaid over a period of no more than 5 years, unless such loan is used to acquire the principal residence of the participant. Principal and interest are paid ratably through bi-weekly payroll deductions.

### (1) Description of the Plan (continued)

- F. **Payment of benefits** – Participants may withdraw their vested account balances in full or partial lump sums or installments upon retirement, disability or termination. Beneficiaries may withdraw vested account balances upon the death of a Plan participant. Participants may also withdraw all or a portion of their contributed account balances for specific hardship reasons subject to approval by the Plan administrator.
- G. **Forfeitures** – Forfeitures of non-vested Sponsor contributions can be used to pay Plan expenses and offset Sponsor contributions. As of December 31, 2024 and 2023, there were \$927 and \$0 of forfeited non-vested accounts. During the year ended December 31, 2024, there were forfeitures totaling \$77,516 used to reduce the employer matching contributions made by the Plan Sponsor.
- H. **Administrative expenses** – Recordkeeping and ancillary fees for distributions, loans and qualified domestic relations orders are paid directly by the participant who incurs the event. Plan expenses for general administration and recordkeeping of the plan can be charged to participant accounts but are generally paid by the Sponsor.
- I. **Plan termination** – Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### (2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** – The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. Accordingly, income is recognized when earned and expenses are recorded when incurred.

**Management's use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amount of net assets available for benefits and changes therein. Actual results may differ from those estimates.

**Investment valuation and income recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Risks and uncertainties** – The Plan provides for various investment fund options which in turn invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Payment of benefits** – Benefit payments to participants are recorded when paid.

**Subsequent events** – Plan management has evaluated subsequent events through October 10, 2025, which is the date the financial statements of the Plan were available to be issued.

### (3) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for investments.

*Mutual funds:* Valued at the net asset value (“NAV”) of shares held by the Plan at year end, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

*Pooled separate accounts:* Investments in sub-accounts of the Plan’s group annuity contract with Principal Life Insurance Company (U.S.A.) are valued at unit value, which is based on the aggregate fair value of the underlying assets in relation to the total number of units outstanding. Unit value is the equivalent of NAV, which is a practical expedient for estimating the fair values of these investments. Each of these investments may be redeemed daily with a notice period of one day. The Plan had no unfunded commitments as of December 31, 2024 or 2023.

*Common collective trusts:* Investments in common collective trusts are valued at the NAV of units of the collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Participant withdrawals will be paid promptly. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments as of December 31, 2024 or 2023.

The Plan's independent public auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### (5) Party-in-interest transactions

Amtech Systems, Inc. is the Plan sponsor and, together with its subsidiaries, provides all employer contributions to the Plan. Therefore, these transactions are party-in-interest transactions.

Certain Plan investments are held in funds managed by Principal, which also functions as the record keeper for the Plan; therefore, transactions with this party qualify as party-in-interest transactions. Fees for the year ended December 31, 2024 in the amount of \$27,649 paid to Principal qualify as party-in-interest transactions and are presented as administrative expense in the statement of changes in net assets available for benefits.

Revenue sharing payments are made from the total expenses paid by participants investing in the funds offered under the Plan. During the year ended December 31, 2024, the Plan received revenue sharing payments of \$53,725 from the investment fund managers which qualify as party-in-interest transactions and are presented as other income in the statement of changes in net assets available for benefits.

### (6) Income tax status

The Internal Revenue Service issued an opinion letter dated June 30, 2020, stating that the Plan was designed in accordance with the applicable Internal Revenue Code ("IRC") requirements as of that date. The Plan administrator and the Sponsor believe that the Plan is currently operating in compliance with the applicable requirements of the IRC and that the Plan was qualified, and the related trust was tax-exempt as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

### (7) Non-exempt transactions

The DOL's regulations require defined contribution plans to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets but not later than the 15<sup>th</sup> business day of the month following the month in which the participant contributions are withheld by the employer. For the year ended December 31, 2023, the Company failed to remit certain participant contributions totaling \$1,017 to the Plan in a timely manner constituting a lending of such monies to the Company. During 2024, Plan management used the DOL lost earnings calculator to estimate the lost earnings on these late contributions and determined them to be immaterial. The lost earnings were remitted to the Plan in January 2024.
