## Independent Auditor's Report

To the Plan Administrator  
Diversified Technical Services, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Diversified Technical Services, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

#### Note 1. Plan Description

The following description of Diversified Technical Services, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of Diversified Technical Services, Inc. (the "Company") who have three months of service and are age 21 or older. The Plan was adopted and became effective July 1, 1992. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Administration of the Plan Assets: The Plan is administered by the Company's Chief Operating Officer appointed by the Company's Board of Directors. The Plan's assets, which consist principally of mutual funds, are held by the custodian of the Plan. Contributions are held and managed by the custodian, which invests cash received, interest, and dividend income and makes distributions to participants.

Contributions: Participants in the Plan may make elective contributions based on a percentage of their total annual compensation or a fixed amount each per pay period, as limited by IRS regulations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Qualified discretionary matching and non-elective contributions are made at the discretion of, and in amounts determined by, the Company's Board of Directors. The qualified discretionary employer match is allocated to participants proportionate to their elective deferrals. The non-elective contributions are allocated to participants at the Company's discretion.

Participant Accounts: Each participant's account is credited with the participant's contribution, the Company's matching contribution, and an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's qualified matching contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after 4 years of credited service.

Notes Receivable from Participants: Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum total amount of all loans outstanding equal to the lesser of (a) one-half of the vested account balance or (b) \$50,000, reduced by excess of highest outstanding balance of loans during the 12 months ending the day before the new loan, over the outstanding balance of the loans on the day

of the new loan. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The loans are secured by the balance in the participant's vested account and bear interest at a rate of 8.25% to 9.75%, being Prime rate plus 1% per year. Principal and interest is paid ratably through semi-monthly payroll deductions. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default and it is not renegotiated in a manner acceptable to the plan administrator, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits: Participants are eligible for benefit payment upon termination of employment, disability, death, early retirement, and upon normal retirement after attaining age 59 ½. The plan also allows for in-service distributions for participants who have obtained retirement age and continue to be employed by the Company and are 100% vested in their accounts. A participant may elect to receive the value of the participant's vested interest in his or her account through a lump-sum distribution.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,974 and \$2,249, respectively. These accounts will be used to reduce future employer contributions. No funds have been paid from forfeited non-vested accounts for 2024, subsequent to year end.

Investment Options: Participants direct the investment of their accounts to selected investment funds as made available and determined by the Plan Custodian and adopted by the Plan Administrator. Participants may change their allocation in investment options at any time, via direct phone and internet access to the Custodian.

Administrative Expenses: Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Except for loan origination fees associated with notes receivables from participants, administrative expenses of maintaining the Plan are paid directly by the Plan.

Third Party Administrator: Effective May 17, 2024, Alliance Benefit Group of Houston replaced The Retirement Advantage as the Plan's third-party administrator.

Custodian: On December 26, 2024, the Plan transitioned its custodian services from John Hancock Life Insurance Company USA to Voya Retirement Insurance and Annuity Company.

#### Note 2. Summary of Accounting Policies

The significant accounting policies of the Plan are summarized as follows:

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on assets bought and sold as well as held during the year.

Contributions Receivable: Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Subsequent Events: The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

#### **Note 3. Information Certified and Provided by the Custodian**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the value of investments, cash, and notes receivables which were \$6,986,660, \$0 and \$52,378 as of December 31, 2024, and \$11,331,714, \$3,291 and \$87,081, as of December 31, 2023, respectively, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule. Investments, cash, and notes receivables as of December 31, 2024, and 2023, were certified by Voya Retirement Insurance and Annuity Company and John Hancock Life Insurance Company USA, respectively.

Voya Retirement Insurance and Annuity Company and John Hancock Life Insurance Company USA also certified to the completeness and accuracy of interest income of \$110 from guaranteed interest accounts, \$6,086 of interest income from notes receivable from participants and net appreciation in the fair value of assets of \$1,393,886, including gains and losses on investments bought and sold, as well as held during the year.

#### Note 4. Fair Value Measurements

The Fair Value Measurements and Disclosures Topic 820 of the FASB Accounting Standards Codification establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or the liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Insurance company guaranteed interest accounts:* Valued at fair value.

*Pooled separate accounts:* Valued at the net asset value (NAV) of shares, which is based on quoted prices for identical assets in active markets, held by the Plan at year end.

*Fixed investment fund:* Valued at the net asset value (NAV) of shares, which is based on quoted prices for identical assets in active markets, held by the Plan at year end.

*Mutual funds:* Valued at fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

#### Note 5. Partial Plan Termination

In July 2023, the Company lost a re-bid for the renewal of one of their major contracts, which resulted in 136 employees being laid off, 12 of which resigned in preparation of known layoff. Of those employees, 89 were plan participants. All plan participants were automatically considered 100% vested, despite years of service worked, as a result of this partial plan termination. For a defined contribution plan where all balances are fully vested prior to the partial termination and operations remain ongoing, the partial termination has no effect to the Plan's financial statements as a whole.

#### Note 6. Tax Status

The Internal Revenue Service has determined and informed the Plan by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

#### Note 6. Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

#### Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 8. Related Party Transactions

The Plan assets are managed by John Hancock Life Insurance Company USA (custodian through December 26, 2024) and by Voya Retirement Insurance and Annuity Company (custodian beginning on December 27, 2024) and therefore, the transactions with the custodian qualify as exempt party-in-interest. Commissions and administrative fees in the amount of \$46,746 were paid to the custodians for the year ended December 31, 2024.
