### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Austin Telco FCU Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Austin Telco FCU Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. **NOTE 1 DESCRIPTION OF PLAN**

The following brief description of Austin Telco FCU Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

**General**

The Plan is a noncontributory defined benefit pension plan established January 1, 2000. The Plan was amended and restated throughout the years to comply with tax legislation and most recently restated January 1, 2025.

The Plan covers substantially all employees of Austin Telco Federal Credit Union (Credit Union). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. Employees of the Credit Union who have one year of service and are at least 21 years of age are eligible to become participants in the Plan. Effective August 1, 2023, the Plan was amended to reduce the required age to 18. The Plan Trustees determine the appropriateness of the Plan's investment offerings and monitors investment performance.

**Pension Benefits**

Employees with 25 or more years of service who have reached the normal retirement age (65) are entitled to monthly pension benefits equal to 50% of monthly compensation. Monthly compensation will be the average monthly compensation for the most recent 10-year average preceding termination. Employees with fewer than 25 years of service receive a pro rata reduction in their benefits based on years of service.

The Plan permits early retirement for participants after age 60 and with five or more years of service. A reduced retirement benefit will result from early retirement. Employees will receive their pension benefits in the form of a 120-month certain and life annuity or a qualified joint and survivor annuity, or in any other form as agreed upon between the employee, the employer, and Standard Insurance Company (Standard), the Plan insurance company.

**Death and Disability Benefits**

If an active employee dies, a death benefit equal to 100% of the value of the employee's accumulated pension benefits is paid to the employee's beneficiary. If a retired employee dies at age 55 or older who has selected the 50% joint and survivor benefit, a death benefit equal to one-half of the value of the employee's accumulated pension benefits is paid to the employee's spouse. A participant who becomes disabled while employed is entitled to receive an amount that is equal to the accumulated pension benefit.

**Vesting**

Participants' vested Plan benefits are based on years of credited service as defined in the Plan agreement. Participants' Plan benefits vest in total such that a participant is 100% vested after five years of credited service.

**Vesting (Continued)**

Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Funding Policy**

Each year the Credit Union will contribute a sum of money necessary to fund the benefits specified by the Plan, subject to the Internal Revenue Service (IRS) full funding limit test. The amount of this annual contribution will be actuarially determined. Employees are not required to make contributions to the Plan. Minimum funding requirements of ERISA were met as of December 31, 2024 and 2023.

Although it has not expressed any intention to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make a number of estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated Plan benefits and changes therein at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Administrative Expenses**

Administrative expenses of the Plan are paid directly by the Credit Union and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

**NOTE 3 ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated Plan benefits are those future periodic payments, including lump sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated Plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. The accumulated Plan benefits for active employees are based on their average compensation during their previous 10 years of employment prior to the date as of which the benefit information is presented (the valuation date). Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from Plan assets are excluded from accumulated Plan benefits.

The actuarial present value of accumulated Plan benefits is determined by an enrolled actuary from Standard Insurance Company and is that amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuations as of December 31, 2023, were (a) life expectancy of participants (Pri-2012 White Collar Dataset Amount-Weighted Mortality with SOA MP - 2021), (b) retirement age assumptions (lesser of normal retirement age of 65 years, or where age plus service equals 85, but in no case less than age 60) and (c) investment returns of 7.00%.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits.

The computations of the actuarial present value of accumulated Plan benefits were made as of January 01, 2024. Had the valuation been performed as of December 31, 2023, there would be no material differences.

**NOTE 5 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (*Level 1*) and the lowest priority to unobservable inputs (*Level 3*). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the *Level 2* input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Separate Accounts:* Net asset values (NAV) and dividend rates per share are determined by Standard Insurance Company's fund company trading partners as of the close of business each day. The underlying mutual funds are traded daily on an active market. NAV is a readily determinable fair value and is the basis for current transactions.

*General Account:* Valued at contract value, which represents contributions made, less withdrawals and administrative expense, plus interest credited. Contract value approximates fair value.

**NOTE 6 PLAN TERMINATION**

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
- b. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations (discussed below).
- c. All other vested benefits (that is, vested benefits not insured by the PBGC).
- d. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Plan Sponsor and the level of benefits guaranteed by the PBGC.

**NOTE 7 TAX STATUS**

The IRS has determined and informed the Plan by a letter dated March 30, 2018, that the prototype adopted by the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RELATED PARTY TRANSACTIONS**

The Plan's investments consist of a group annuity contract issued by Standard Insurance Company. Standard Insurance Company is the insurance company as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

<b>Original Effective Date:</b>	January 1, 2000.
<b>Last Restatement:</b>	July 15, 2020.
<b>Subsequent Amendments:</b>	Amendment No. 1: Eligibility age has been lowered from 21 years to 18 years effective from August 1, 2023.
<b>Employee:</b>	Any person who is employed by the employer, other than a person whose terms of employment are established by a collective bargaining agreement and the agreement does not provide for participation in the Plan. An individual who performs services for the employer pursuant to an agreement between the employer and an employee leasing organization or a non-resident alien shall not be considered to be an employee.
<b>Participation:</b>	Employees are eligible to enter the plan following the completion of one year of service and attaining age 21. A year of service is earned for each plan year in which the participant works at least 1,000 hours. However, in the years of hire and termination, a year of benefit service will be prorated for actual number of hours worked less than 1,000. Effective August 1, 2023, eligibility age has been lowered from 21 years to 18 years.
<b>Benefit Service:</b>	The sum of the plan years during which a participant has at least 1,000 hours of service, plus his partial years of service at hire and termination.
<b>Vesting Service:</b>	The sum of the plan years during which a participant has at least 1,000 hours of service.
<b>Normal Retirement Date:</b>	The first day of the calendar month coincident with or next following attainment of age 65.
<b>Subsidized Early Retirement:</b>	At any time after attainment of age 60 and where age plus years of benefit service is at least 85, a participant may elect early retirement. In this case, the amount of the retirement benefit earned on the basis of service to date will not be reduced due to retirement prior to normal retirement age.
<b>Early Retirement Date:</b>	At any time after attainment of age 60 with 5 years of vesting service but before attaining subsidized early retirement, a participant may elect early retirement. In this case, the amount of the retirement benefit earned on the basis of service to date is reduced 5% per year or fraction of a year for each year preceding his normal retirement date.

## Appendix A - Summary of Principal Plan Provisions (cont.)

**Late Retirement Date:** Retirement may be postponed beyond the normal retirement date. Late retirement benefits will be the greater of (a) continued accrual of benefits, or (b) actuarial equivalent of the normal retirement benefit.

**Compensation:** The forms of income reported by the employer to the Internal Revenue Service for federal income tax purposes, including amounts contributed by the employer pursuant to a salary reduction agreement which are includable in the gross income of the participant under Code Section 125, 402(e)(3), 402(h)(1)(B), 403(b), or 457(b) and certain contributions described in Code Section 414(h)(2) that are picked up by the employing unit and treated as employer contributions. Please refer to the Plan Document for more details.

**Amount of Retirement Benefit:** The normal retirement benefit is equal to 50% of a participant's average monthly compensation reduced 1/25th for each year of benefit service less than 25 years accrued by the participant at normal retirement. The earned accrued benefit is a fraction of the normal retirement benefit multiplied by the actual years of benefit service earned to date divided by the potential years the participant would have accrued as of the participant's normal retirement date (or actual date of retirement if later).

Average monthly compensation shall mean the participant's final average 5 consecutive year average preceding termination. Effective January 1, 2003, average monthly compensation shall be the final average 6 consecutive years. Thereafter, an additional year shall be added to the average until 2007, when the most recent 10 consecutive year average preceding termination shall be used.

**Termination Benefit:** A terminating participant who has completed five years of service is entitled to receive a vested monthly benefit starting on his normal retirement date. The amount of the benefit is equal to the retirement income earned on the basis of service to date multiplied by the appropriate vested percentage from the following table:

<u>Years of Service</u>	<u>Vested Interest</u>
Less than 5	0%
5 or more	100%

### Appendix A - Summary of Principal Plan Provisions (cont.)

<b>Normal Form of Benefit:</b>	The normal annuity form is a monthly income payable as a 120-month Certain & Life Annuity. The automatic form to a married participant is a subsidized Qualified Joint and 1/2 Survivor Annuity. At the participant's option, retirement income may be paid on a certain and life basis, on a different joint and survivor basis, or as a lump sum.
<b>Optional Benefit Forms:</b>	<p>Election of an optional annuity form may be made at any time before retirement. When an optional form is elected, the amount of income is adjusted so the cost to the fund is the same as it would have been under the normal annuity form. Spousal consent is required for married participants to elect other than the automatic form. All forms are actuarially equivalent to the normal form of annuity.</p> <ul style="list-style-type: none"><li>&gt; Straight Life Annuity.</li><li>&gt; 100%, 66-2/3% or 50% Joint &amp; Contingent Survivor Annuity.</li><li>&gt; 60, 120 or 180 months Certain &amp; Life Annuity.</li><li>&gt; Single Sum Payment - For those who terminate prior to retirement, the lump sum option is restricted to amounts that do not exceed \$25,000.</li></ul>
<b>Death Benefit:</b>	In the event of a participant's death before retirement, the participant's beneficiary will receive a benefit equal to the present value of the participant's accrued benefit.
<b>Disability Benefit:</b>	A participant who becomes disabled while an employee is entitled to receive an amount that is equal to the present value of his accrued benefit.
