Notes to Financial Statements

NOTE 1 SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of Cincinnati Ballet Retirement Savings Plan (the "Plan") are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

Benefit Payments to Participants

Benefit payments to participants are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Related Party Transactions / Plan Expenses

Certain administrative functions are performed by the officers or employees of the Cincinnati Ballet (the "Plan Sponsor"). The Plan is not charged by the Plan Sponsor for the services of such officers or employees. Plan expenses for the trustee and certain other fees are paid in part by the Plan Sponsor. Expenses charged to the Plan totaled \$24,204 for 2024.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Subsequent Event Evaluation

The Plan Sponsor has evaluated events subsequent to the balance sheet date through October 13, 2025.

NOTE 2 DESCRIPTION OF PLAN

The following description of the Plan is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan. All employees of the Plan Sponsor, excluding part-time, temporary, and seasonal employees are eligible for the plan on the first of the month following the employee's date of hire and once they have attained the age of eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was restated on December 30, 2024 and a new plan document was in effect at December 31, 2024.

Contributions

With respect to employee contributions, each year participants may contribute up to 100% of pre-tax or post-tax annual compensation, as defined by the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 for 2024). The Plan permits catch-up elective deferrals for participants over 50 years of age subject to Internal Revenue Code limitations. Effective January 1, 2024, the Plan will make safe harbor employer contributions. In 2023, the Plan Sponsor had a discretionary matching contribution. The Plan Sponsor matches 100% up to the first 3% of the participant's compensation contributed as elective deferral contributions and 50% of the next 2% of the participant's compensation contributed as elective deferral contributions under the safe harbor matching contribution in 2024, and under the discretionary matching contribution in 2023. Total contributions in 2024 by the Plan Sponsor under the safe harbor matching provision were \$83,856. During 2024, the Plan Sponsor made non-elective discretionary contributions to collectively bargained employees in the amount of 5.5% of eligible compensation as defined in the collective bargaining agreement. Total contributions contributed in 2024 by the Plan Sponsor under this provision were \$65,714.

Rollover Contributions

Participants can contribute amounts representing distributions from other qualified defined benefit or contribution plans.

CINCINNATI BALLET RETIREMENT SAVINGS PLAN

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with allocations of (a) the participant's contribution, (b) the Plan Sponsor's contribution and (c) Plan earnings. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions. Additionally, employees are immediately vested in union non-elective contributions, and safe harbor contributions. Vesting in the Plan Sponsor's discretionary contribution is based on years of service as noted in the following schedule:

Payment of Benefits

Upon termination of service due to death, disability or retirement after age 62, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments.

In-service distributions are permissible for participants that have attained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their vested account balance.

In conditions of "financial hardship", a participant may apply to the plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Forfeited Accounts

For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$21,402 and \$12,188, respectively. Forfeitures can be used to pay for Plan fees or to reduce employer contributions. For 2024, \$-0- was used to pay for Plan fees and \$-0- was used to reduce employer contributions.

NOTE 3 PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

NOTE 4 INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The following information provided by Empower Trust Company, LLC, for the period January 1, 2023 through December 30, 2024 and Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, for December 31, 2024, the trustees of the Plan, was certified by them to be complete and accurate with respect to the following:

- (a) The assets held as of December 30, 2024 and December 31, 2023, as well as the transactions involving these assets for the year ended December 31, 2024.
- (b) The amount of investment income for the year ended December 31, 2024.
- (c) The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) for the year ended December 31, 2024.

NOTE 5 TAX STATUS

The Plan Sponsor has adopted an Empower Trust Company, LLC prototype plan for the period January 1, 2023 to December 30, 2024 which has received an opinion letter from the IRS dated November 14, 2022, and a Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company prototype plan for the period December 30, 2024 to December 31, 2024 which has received an opinion letter from the IRS dated June 30, 2020. The letter states that the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6 FAIR VALUE MEASUREMENTS

GAAP provisions for Fair Value Measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP provisions for Fair Value Measurements are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 6 FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

Mutual funds and money market. Valued at the net asset value ("NAV") of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 UNALLOCATED CASH IN TRANSIT

During 2024, the Plan changed service providers from Empower Trust Company, LLC to Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company received the funds on December 31, 2024, and re-invested the Plan's assets on January 27, 2025. As a result, the Plan's investment assets were in transit as of December 31, 2024.
