Notes to the Financial Statements

1. Description of the Plan

The following description of the Healthkeeperz, Inc. 401(k) Plan (the Plan) provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was originally established on March 1, 1999, and was restated July 1, 2022. Under Secure Act 2.0 voluntary provisions, the Plan elected to increase the force-out threshold from \$5,000 to \$7,000, effective January 1, 2024. The Plan covers all eligible employees of Healthkeeperz, Inc. (the Plan Sponsor and Administrator).

For the period of January 1, 2024 through January 31, 2024, the Plan's trustee and custodian was Reliance Trust Company (Reliance); the recordkeeper was ADP. Effective February 1, 2024, Principal Life Insurance Company (Principal) became the trustee, recordkeeper, and custodian. All assets were transferred from Reliance to Principal on February 1, 2024 (see Note 3).

Eligibility

All employees are eligible to participate and are automatically enrolled in the Plan. Employees are eligible for the employer match after one year of service. If an employee is a nonresident alien or is an independent contractor, they are not eligible to participate in the Plan.

Contributions

Participants may contribute up to the maximum allowable annual contribution as defined by the Internal Revenue Code (IRC). Participants are automatically enrolled in an elective deferral contribution of 1% of compensation, unless the participant elects a different percentage or elects not to make an elective deferral contribution. The first 2.5% of participant contributions are subject to a 50% employer match. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute any rollover contributions to which they are entitled from another qualified defined benefit or defined contribution plan.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and an allocation of Plan Sponsor's contributions, Plan earnings, and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants can direct the investment of their contributions, including rollover contributions, as well as employer matching contributions made on their behalf into the various mutual funds offered by the Plan. Participants may change their investment options at any time.

1. Description of the Plan, continued

Vesting

Participants are immediately vested in their contributions, including rollovers, plus actual earnings thereon. A participant is entitled to 100% of his or her account balance upon retirement, death or disability. Vesting in the Plan Sponsor's contribution portion of their accounts plus earnings thereon is based on years of credited service according to the following schedule:

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Generally, loan terms are limited to five years, unless the proceeds are used to acquire a home that will be the primary residence of the participant. The loans are secured by the vested portion of the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. The interest rates on the loans ranged from 4.25% to 9.50%. All loans may be prepaid at any time without penalty. Principal and interest is paid ratably through payroll deductions. Should a participant terminate employment (or be terminated by the Plan Sponsor), the outstanding principal balance of the loan plus accrued interest shall become due immediately.

Payment of Benefits

On termination of service due to disability or retirement, a participant will normally be paid in the form of a qualified joint and survivor annuity over the life expectancies of the employee and spouse. Lump-sum distributions or rollovers to other plans are also available. Death benefits are paid out no later than ninety days following the later of the close of the Plan year within which the participant dies or the close of the Plan year in which the request is received. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Those participants may elect to roll over distributions to other qualified plans or to individual retirement accounts. Hardship withdrawals are also permitted.

Forfeited Accounts

Forfeitures of employer matching contributions are used to offset future employer matching contributions or administrative expenses of the Plan. Forfeitures available to offset these future costs were \$0 and \$26,919 as of December 31, 2024 and 2023, respectively. During 2024, forfeitures totaling \$29,000 were used to pay employer matching contributions and administrative expenses.

1. Description of the Plan, continued

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Administrative Expenses

The Plan is responsible for its administrative expenses unless paid by the Plan Sponsor.

2. Summary of Significant Accounting Policies

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income from investments as well as from notes receivable is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation in the fair value of investments includes both realized gains and losses and unrealized appreciation.

Investment Valuation

All underlying investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year. See Note 4 for discussion of fair value measurements.

Notes Receivable from Participants

Notes receivable (participant loans) are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses had been recorded, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balance. Delinquent loans are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Subsequent events have been evaluated for accounting and disclosure requirements through October 9, 2025, which is the date the financial statements were available to be issued.

3. Information Prepared and Certified by Trustee

As noted above, effective February 1, 2024, Principal replaced Reliance as custodian to the Plan. The Plan's investment information included in this note and throughout the Plan's financial statements was prepared by or derived from information prepared by Principal, the current trustee to the Plan, and Reliance, the former trustee to the Plan, and furnished to the Plan Administrator. The assets of the Plan were transferred from Reliance to Principal during 2024. The Plan Administrator has obtained certifications from Principal from February 1, 2024 to December 31, 2024 and as of December 31, 2024 and from Reliance from January 1, 2024 to January 31, 2024 and as of January 31, 2024 and December 31, 2023, that asset information provided to the Plan Administrator by the current and former trustees related to the asset information is complete and accurate. The Plan Administrator has obtained certification from Principal and Reliance that such information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations or Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note and which appears throughout the financial statements and the ERISA-required supplemental schedules.

Principal and Reliance certified the fair value of investments held were \$2,711,120 and \$2,590,581 at December 31, 2024 and 2023, respectively. The trustees also certified notes receivable from participants of \$97,661 and \$124,662 at December 31, 2024 and 2023, respectively.

Principal and Reliance certified to the completeness and accuracy of \$267,118 of net realized and unrealized appreciation in the fair value of investments and \$11,896 of interest and dividends related to investments and \$10,428 of interest income on notes receivable for the year ended December 31, 2024.

4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets); Level 2 (not traded on an active market but for which market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual funds: These investment vehicles are valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Common collective trusts: Valued based on the net asset value (NAV) of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Pooled separate account: Valued at NAV per share based on quoted market prices of underlying investments.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with accounting standards, investments that are measured at fair value using the NAV practical expedient have not been classified as Level 1, 2 or 3 in the fair value hierarchy, but are included above to permit reconciliation of the fair value hierarchy tables to the amounts presented in the Statements of Net Assets Available for Benefits.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

5. Exempt Parties-In-Interest Transactions

As noted above, in January 2024, ADP was the recordkeeper of the Plan and beginning in February, Principal became the custodian and recordkeeper of the Plan. Administrative fees paid to both entities qualify as party-in-interest transactions. Administrative fees paid by the Plan totaled \$27,407 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. Should the Plan terminate, participants would receive benefits under the Plan based on their account balances accumulated to the date of the Plan termination and would become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.

7. Income Tax Status

The Plan uses a prototype plan document sponsored by Principal. An opinion letter was received from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

8. Prohibited Transactions

During the year ended December 31, 2024, participant withholdings in the amount of \$2,085 were not remitted within the appropriate time period by the Plan Sponsor. This transaction constitutes a prohibited transaction as defined by ERISA. The Plan Sponsor is aware of the occurrence and has taken the appropriate steps to correct the situation by implementing procedures to ensure all future remittances are completed within the prescribed time period.

9. Reconciliation to Form 5500

Certain receivables and the related income are recorded within the accrual based financial statements but are not reported in the Form 5500 until actually received or paid. Reconciliations of various items from the financial statements to the Form 5500 as of December 31, 2024 and 2023, are as follows:
