## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Medical Care 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the financial statements of Medical Care 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **1. DESCRIPTION OF THE PLAN**

The following description of Medical Care 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all employees, as defined in the Plan, of Medical Care, PLLC and Pine Palms Management LLC (collectively the "Company"), excluding leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan was established on January 1, 2017.

### **Plan Administration**

The Company has established a committee that is responsible for the general operation and administration of the Plan. The Company is the Plan Sponsor and a fiduciary of the Plan as defined by ERISA. The Trustee provides recordkeeping services to the Plan.

### **Eligibility**

Employees of the Company are eligible to become participants in the Plan through employee deferrals and receive employer nondiscretionary matching contributions after completing either 250 hours in the first three-month period or after 1,000 hours within one year. Participants also become eligible to receive employer discretionary contributions and nonelective safe harbor contributions upon eligibility in the Plan.

### **Participant Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

### **Employer Contributions**

The Company makes a nonelective safe harbor contribution equal to 4% of eligible employees' compensation. The Company may make a discretionary profit-sharing contribution. The discretionary profit-sharing contribution is made as a percentage of compensation with different rates for non-highly and highly compensated employees. Total employer contributions for the Plan years ended 2024 and 2023 were \$323,341 and \$319,137, respectively.

### **Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a stable value fund, broker link account, target-date retirement funds and various other mutual funds.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions (including rollovers) and allocations of (a) the Company's contributions and (b) plan earnings. Allocations are based on

participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

**Administrative and Investment Management Expenses**

Investment management fees are charged to the Plan and reduce the benefits available to participants. Investment management fees are allocated among the participants.

**Parties-in-Interest**

There were no prohibited transactions between the Plan and parties-in-interest as defined by ERISA.

**Vesting**

Participants are vested immediately in their voluntary contributions, rollover contributions, safe harbor matching and profit-sharing contributions, plus actual earnings thereon.

**Payment of Benefits**

On termination of service, death, disability or upon reaching retirement age, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Upon severe hardship, in accordance with Plan provisions, participants may withdraw amounts from their participant contribution account.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document.

**Subsequent Events**

The Plan's management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**3. CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock Life Insurance Company, the trustee of the Plan.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the accounting standards are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

*Pooled separate accounts:* Based upon net asset value (NAV) as a practical expedient. The NAV of a pooled separate account is based on the market value of its underlying investments. The pooled separate account's NAV is not a publicly quoted price in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investments offered under the separate subaccounts in which the Plan participates as of December 31, 2024 and 2023, consist of mutual funds, collective investment trusts and exchange-traded funds.

#### **5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Company is the administrator of the Plan and as such executes the normal duties associated therewith. Costs incurred for audit, legal and other administrative functions are paid by the Company on behalf of the Plan. There were no financial transactions recorded between the Company and the Plan other than contributions made by the Company to the Plan. The Plan invests in funds managed by John Hancock Life Insurance Company. John Hancock Insurance Company acts as contract holders and recordkeepers for those investments, as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

#### **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contribution.

#### **7. TAX STATUS**

The initial effective date of the Plan was January 1, 2017. Effective January 1, 2022, the Plan was amended and restated and adopted the CCH Incorporated dba FT William Com (the "TPA's software package provider") Nonstandardized Preapproved Profit-Sharing Plan with CODA. The Internal Revenue Service determined and informed TPA's software package provider by a letter dated June 30, 2020, that the TPA Preapproved Plan, as then designed, was in accordance with applicable sections of the IRC. The Plan has not filed for its own determination letter. Although the Plan has not been amended since the pre-approved determination letter was issued, therefore, the Plan administrator and the Plan's tax counsel believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

The Plan recognizes tax loss contingencies when it is probable that a liability has been incurred and the amount of the loss can be reasonably estimated. The amount recognized would be subject to estimates and management's judgment with respect to the likely outcome of each uncertain tax position. Although the tax years ending December 31, 2021 through December 31, 2024, remain open for examination by various taxing authorities, it is management's opinion that no significant uncertain tax positions remain open at December 31, 2024.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
