Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of California Overland, Ltd. Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of California Overland, Ltd. Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

1. Plan Description and Summary of Significant Accounting Policies

The following description of the California Overland, Ltd. Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General Information

The Plan is a defined contribution 401(k) plan which was established on September 1, 2013. The Plan covers substantially all employees (other than union employees, leased employees, and non-resident aliens) of California Overland, Ltd. and CA Overland Solutions, Ltd. (collectively, the Company) who have attained the age of 21 and have completed the required employment term. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Administration

The Custodian of the plan's assets is John Hancock USA. The Plan is administered by the trustees of the Plan along with plan sponsor personnel designated by the trustees. The trustees and designated personnel have the authority to control the operation, management and administration of the Plan.

Participation

All employees over age 21 (other than union employees, leased employees, and non-resident aliens) who have completed 60 days of service are eligible to make salary deferral contributions to the Plan. Once eligibility requirements have been met, an eligible employee can enroll on the first day of the next month.

The Plan includes a provision for automatic salary deferrals. Each participant will have 4% of eligible compensation contributed to the Plan as an employee deferral, unless a different deferral rate is elected by the participant. Elective deferral contributions may be changed or stopped on any date.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Contributions

Each year, participants may contribute up to the maximum allowable amount not to exceed the limits of Internal Revenue Service (IRS) Code Section 401(k) on a pre-tax or after-tax (Roth) basis, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions in any amount up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants direct the investment of their account into various investment options offered by the Plan.

Each year the Company may make a discretionary matching contribution to eligible employees. All employees enrolled in the Plan are eligible for matching contributions. Matching contributions were 50% of each employee's contributions up to 2% of eligible wages for the years ended December 31, 2024 and 2023. Participants direct the investment of employer contributions allocated to them into various investment options offered by the Plan. The Plan does not include a provision to allow the plan sponsor to make profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's elective deferrals, employer matching contributions and an allocation of Plan earnings and expenses. Allocations of Plan earnings are based on the valuation of the investments held in each participant's account. Participants' accounts are valued on a daily basis. The benefit each participant is entitled to is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their elective deferral contributions and rollover contributions. Full vesting in Company matching contributions plus earnings thereon is based on a three year cliff schedule. One year of service is any Plan year in which the employee worked at least 1,000 hours. Participants are 0% vested in Company matching contributions until three years of service, at which point participants become fully vested. Participants are also fully vested upon reaching age 65, upon death or upon permanent disability.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants become 100 percent vested in their accounts.

1. Plan Description and Summary of Significant Accounting Policies (Continued)

Forfeited Accounts

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan agreement, represents a forfeiture. Forfeitures are used for paying reasonable Plan expenses, the restoration of participants' forfeitures and/or reducing the employer's contribution to the Plan. Forfeitures totaled \$20,537 and \$7,700 for the years ended December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures in the amount of \$30,414 were used to reduce employer matching contributions and no forfeitures were used to pay plan expenses. No forfeitures were used to reduce employer matching contributions or pay plan expenses during the year ended December 31, 2023. At December 31, 2024 and 2023 there were unallocated forfeitures of \$1,190 and \$14,158, respectively, available to be used to reduce employer contributions and/or plan expenses.

Payment of Benefits

Upon termination of employment, disability or reaching normal retirement age, participants or their beneficiary(ies), where applicable, may receive the value of the accrued vested benefit in the form of a lump sum payment or partial payments or may elect to defer the distribution in accordance with Plan guidelines if the balance in the participant's account exceeds \$5,000. Distributions due to the death of the participant are paid in the form of a lump sum payment or over extended payments to beneficiaries in accordance with the Internal Revenue Code. Balances less than \$5,000 may be distributed in the form of a lump sum payment and may be distributed by the plan administrator to an IRA set up for the benefit of the participant with or without the election of the participant.

The Plan allows for hardship withdrawals from the elective deferral portion of the participant's account, including Roth deferral contributions and in certain situations such withdrawals may be made from the employer matching contribution portion of the participant's account. The Plan also allows for in-service distributions of all fully vested accounts if the participant has reached the age of 59 and ½ years old.

Benefit payments are recorded upon distribution to participants.

Notes Receivable from Participants

The Plan does not allow for participants to borrow from their fund accounts.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Investment Valuation and Income Recognition (Continued)

All purchases and sales of securities have been recorded on a trade-date basis. Income is recorded as earned. The increase or decrease in the fair value of investments represents the net difference between the current value of securities held at the beginning of the year or cost of securities purchased during the year and the current value of securities held at the end of the year.

Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan. Expenses paid by the Plan are included in the statement of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2024 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

2. Certification of Investments

The Trustees of the Plan appointed John Hancock USA (John Hancock) as Custodian of the Plan's assets. John Hancock has supplied the Plan Administrator with a certification as to the completeness and accuracy of Plan non-interest bearing cash and investments aggregating \$6,222,634 and \$5,225,020 as of December 31, 2024 and 2023, respectively, and the related investment income of \$688,740 and \$564,902 for the years then ended. Such amounts and all related financial data are included in the accompanying financial statements and supplemental schedule of assets (held at end of year) based on the certification from John Hancock.

Under the terms of the Custodial agreement, the Custodian manages investment funds on behalf of the Plan. The Custodian has been granted non-discretionary authority concerning the purchases and sales of the investment of the investment funds.

3. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although not based upon quoted prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Party-in-Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are considered prohibited transactions under ERISA unless a specific exemption exists. John Hancock is the Custodian of a portion of the Plan's assets and manages certain Plan investment transactions; therefore, the transactions qualify as party-in-interest transactions and are indicated as such on the supplemental schedule of assets (held at end of year). However, the transactions are not considered prohibited transactions as ERISA regulations provide for a specific exemption for such transactions.

Additionally, certain employees of the Company provide certain accounting and administrative services to the Plan for which no fee is charged.

5. Plan Tax Status

The Plan has adopted a prototype plan document, which has received an opinion letter from the Internal Revenue Service stating that the plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan's informational returns are subject to examination by the appropriate regulatory authorities as of December 31, 2024, and the Plan's federal informational returns generally remain open for a period of three years.

6. Reportable Transactions – Delinquent Participant Contributions

In 2023, it was determined that \$6,820 of employee deferral contributions were not remitted to the Plan within the time period prescribed in the Code of Federal Regulations during 2022. These contributions were remitted to the Plan during 2022 and the related lost earnings were remitted to the Plan during 2023.

7. Risk and Uncertainties

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
