Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Gallagher Sharp 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of the Gallagher Sharp 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of Gallagher Sharp (the "Company") who have attained age 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Company's Finance Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions:

Participants may make pre-tax or Roth contributions in any amount from 1% up to 100% of their eligible compensation as defined by the Plan, subject to certain limits imposed by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also provides that participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make catch-up contributions, subject to certain IRS limitations. The Plan provides for an Eligible Automatic Contribution Arrangement, whereby the Company will automatically withhold 6% of eligible compensation for each pay period for eligible participants unless participants elect different deferral rates or elect not to participate in the Plan.

The Company may make discretionary contributions as determined by the Company's Finance Committee. The Plan also includes a provision whereby the Company's Finance Committee will determine whether to make a safe harbor contribution of 3% of employee compensation to all employees who meet eligibility requirements. Eligibility for Company contributions is completion of one year of service defined as a minimum of 1,000 hours in a 12-month period following date of hire. Entry dates to the Plan for Company contributions are the first and seventh month of the Plan year and employees must be employed on the last day of the Plan year in order to receive Company contributions. Included in Company contributions are amounts necessary to satisfy IRS top-heavy requirements, and employees may receive such amounts even if such employees fail to complete the number of hours of service required by the Plan for an allocation of other Company contributions.

Participant Accounts:

Each participant's account is credited with the participant's contribution, any Company contribution, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note 1. Description of Plan (Continued)

Notes Receivable From Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate at the time of loan issuance. Principal and interest is paid ratably through payroll deductions.

Vesting:

Participants are vested immediately in their contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portions of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service (0% in year one, 20% each year thereafter), or in the event of death, disability, or attaining early retirement age or normal retirement age as defined by the Plan.

Payment of Benefits:

Upon termination of service due to death, disability, retirement, or separation of service from the Company, a participant is entitled to receive a distribution of his or her vested account balance in the form of a lump-sum payment, installment payments, or an annuity. A participant may receive an in-service distribution if he or she experiences undue financial hardship or upon attainment of age 59½.

Forfeited Accounts:

Any forfeited non-vested accounts may be used to reduce future employer contributions or pay Plan expenses. At December 31, 2024 and 2023, there was \$8,813 and \$17,326, respectively, of unutilized forfeited non-vested accounts. During 2024, \$27,662 of forfeitures was utilized to reduce employer contributions, which was netted with the employer contribution receivable at December 31, 2023.

Note 2. Summary of Significant Accounting Policies

- A. **Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.
- B. **Investment Valuation and Income Recognition** – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee and insurance company. Empower Trust Company, LLC, is trustee of the Plan, and the Plan's insurance contracts are issued by Massachusetts Mutual Life Insurance Company ("MassMutual") and certified by Empower Annuity Insurance Company of America.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note 2. Summary of Significant Accounting Policies (Continued)

B. Investment Valuation and Income Recognition (Continued):

On December 31, 2020, Empower Retirement LLC acquired the retirement business of MassMutual. Following an initial transition period, Empower Retirement LLC became the sole administrator of the Plan's contract during 2021. Empower Annuity Insurance Company of America is an affiliate of Empower Retirement LLC. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividend income is recorded when received. There is no significant difference between this methodology and the accrual basis of accounting for the periods presented. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

C. Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the plan document.

D. Administrative Fees – Fees of the Plan are paid by the Company or the Plan at the discretion of the Company. In addition, certain transactions and account maintenance fees are charged to the affected participants. Fee credit payments are made from excess revenue generated by the Plan through fund revenue or fees that are made available to the Plan. The Company monitors the payments received by the Plan service providers to ensure that they are used properly for qualifying Plan purposes. During the year ended December 31, 2024, \$63,163 of fee credit payments was utilized to offset administrative fees of the Plan.

E. Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

F. Benefit Payments – Benefits are recorded when paid.

G. Subsequent Events – The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested and receive a total distribution of their account.

Note 4. Unaudited Information

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received certifications from Empower Trust Company, LLC, and Empower Annuity Insurance Company of America for insurance products issued by MassMutual, acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of December 31, 2024, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024 and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note 5. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data

Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for plan assets measured at fair value:

- The fair value of investments held in registered investment companies is determined based on their quoted closing market prices in active markets for identical investments, and is classified as Level 1.
- The fair value of investments held in the pooled separate accounts is based on their reported net asset value ("NAV"). The NAV is based primarily on observable inputs and the market value of the underlying investments, and is classified as Level 2.
- Included within the self-directed brokerage accounts are cash and cash equivalents, common stocks, unit investment trusts and registered investment companies. Common stocks, unit investment trusts and registered investment companies are valued at the closing price reported on the active market in which the individual investments are traded, and are classified as Level 1. Cash and cash equivalents are classified as Level 1 investments.

Note 5. Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Group Annuity Contract

Investments in the SAGIC Diversified Bond I meet the fully benefit-responsive investment contract criteria and are, therefore, reported at contract value as determined and certified by Empower Annuity Insurance Company of America. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. All transactions within this contract are executed at contract value including full liquidation of the fund.

Note 6. Group Annuity Contract (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on several factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula and are reset annually as determined by the issuer.

The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 7. Income Tax Status

The Plan has adopted a prototype plan document. This plan document has obtained an opinion letter dated November 14, 2022 from the IRS in which the IRS stated that the document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Note 8. Party-in-Interest Transactions

Certain Plan investments issued by MassMutual are held by Empower Annuity Insurance Company of America as custodian. In addition, administrative expenses were paid to the Plan trustee or its affiliates during the year ended December 31, 2024. These transactions qualify as party-in-interest transactions.

Note 9. Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
