Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Greenleaf Foods SPC 401(k) Profit Sharing Plan & Trust (Plan 002)** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is/are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following brief description of the Greenleaf Foods SPC 401(k) Profit Sharing Plan & Trust (Plan 002) (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a Section 401(k) defined contribution plan with salary deferral provisions, which was established on April 1, 2016. The custodian of the Plan is Great-West Trust Company, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was formerly known as the Field Roast Grain Meat Company 401(k) Plan, and effective January 1, 2020, was changed to Greenleaf Foods, SPC 401(k) Profit Sharing Plan and Trust (Plan 002).

Effective January 1, 2019, Maple Leaf Foods USA, Inc., an affiliated company, became a participating employer of the Plan. All eligible participants of the Maple Leaf Foods USA Retirement Plan became eligible participants of this Plan at that time. As a result, Greenleaf Foods, SPC resolved to merge Plan (001) into Plan (002) and transferred the assets from Plan (001) to Plan (002).

Effective January 1, 2020, Greenleaf Foods, SPC, an affiliated company, became a participating employer of the Plan. All eligible participants of the Greenleaf Foods SPC 401(k) Profit Sharing Plan & Trust (Plan 001) became eligible participants of this Plan (Plan 002) at that time.

All employees of Greenleaf Foods, SPC and Maple Leaf Foods USA, Inc., other than union employees, leased employees, and non-resident aliens, who have six months of service, as defined in the Plan Document, and are age 21 or older, are eligible to participate in the Plan.

Contributions – Pre-tax or post-tax deferred savings contributions in the form of salary reductions by participants are allowed. The amount contributed is determined by the participant, subject to statutory limitations. The Plan has an automatic deferral feature to the Plan, whereby eligible participants will have 4% of their compensation deferred each pay period unless the participant makes a contrary election. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor matching contribution equal to 100% of the first 4% of participant's eligible compensation. The Company may make a discretionary nonelective contribution to the Plan. No such contribution was made in 2024.

1. **Description of Plan** (cont'd)

Participants' Accounts – Each participant's account is credited with the participant's contributions and Company matching contributions, and gains and losses from the investment funds elected. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – A participant is fully vested in participant contributions, employer safe harbor matching contributions, plus actual earnings, gains and losses thereon, at all times. Discretionary nonelective contributions, and the employer matching and profit sharing contributions from the former Greenleaf Foods, SPC 401(k) Profit Sharing Plan and Trust (Plan 001) that were merged into this Plan during 2020 vest on a five-year graded vesting schedule according to the following schedule:

Future discretionary nonelective contributions for participants from the former Maple Leaf Foods USA Retirement Plan are not subject to the vesting schedule above.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prime rate, as defined, plus one percent, and were between 4.25% and 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – A participant's account balance may be withdrawn upon retirement, death, disability, or termination of employment as defined by the Plan. Benefits are payable in a single lump-sum amount. In-service withdrawals from transfer accounts, distributions after age 59 1/2 and hardship distributions are also allowed by the Plan.

1. **Description of Plan** (cont'd)

Plan Termination – Although the Company has not expressed any intent to terminate the Plan, it may do so at any time. The termination of the Plan is subject to the provisions of ERISA. In the event of Plan termination, all account balances as of the date of termination shall be payable to the participants and beneficiaries.

Forfeited Accounts – At December 31, 2024, forfeited non-vested accounts total \$8,197 (\$7,741 at December 31, 2023). These accounts can be used to pay administrative expenses, allocated as an additional employer contribution, or reduce future employer contributions. During the year ended December 31, 2024, the Plan used \$26 from forfeited non-vested accounts to reduce the employer contribution.

2. **Summary of Significant Accounting Policies**

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4 for discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (cont'd)

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to processing notes receivable and distributions are charged directly to the participant's account and are included in administrative expenses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, and are included in administrative expenses. Allocations are based on account balances. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events – The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

3. Certified Investments

The participating employers of the Plan, acting in their capacity as the Plan administrator, have elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedules, that was prepared by or derived from information prepared by Empower Trust Company, LLC, the custodian of the Plan, and furnished to the Company. The Company has obtained certifications from the Custodian as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, that such information is complete and accurate.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Level 1 – Valuations are based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Level 2 – Valuations are based on quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; and model-derived valuations whose significant inputs are observable.

Level 3 – Valuations are based on unobservable inputs for the asset or liability that reflect the reporting entity's own data and assumptions that market participants would use in pricing the asset or liability. These unobservable inputs are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of valuation methodologies used for investments measured at fair value on the statement of net assets available for benefits, and the classification of such investments pursuant to the valuation hierarchy.

Money market funds and mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These assets are categorized in Level 1 of the fair value hierarchy.

5. Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by Empower Trust Company, the custodian of the Plan's assets. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan paid certain expenses related to Plan operations which were not covered by revenue sharing. The total paid to Empower Trust Company, LLC, was \$47,119. The Company pays directly any other fees related to the Plan's operations.

6. Tax Status

The Plan has adopted the Empower Retirement, LLC Defined Contribution Pre-Approved Plan. The Internal Revenue Service has determined and informed Empower Retirement, LLC, by a letter dated November 14, 2022, that the Defined Contribution Pre-Approved Plan is designed in accordance with applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Delinquent Participant Contributions

Delays in remitting contributions to the Plan constitute prohibited transactions. Related excise taxes will be paid by the Company. The Plan had late deposits in 2019, 2020 and 2024. Corrections for these late deposits are pending.
