Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 and 4 of the financial statements, is complete and accurate.

1. *Description of plan*

The following description of the Burch Oil Company, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution, contributory, profit-sharing plan covering all eligible employees of Burch Oil Company, Inc., Burch Oil Company of Charles County, Inc., Burch Propane, LLC and former employees of Hughesville Corner Express, LLC (collectively the "Companies"). Employees are eligible to participate in the Plan upon completing one year of credited service (including 1,000 hours during the Plan year) and attaining age twenty-one or older. Plan entry is allowed on the earlier of January 1 or July 1, subsequent to meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute to the Plan up to 100% of pretax annual compensation, as defined, up to the maximum amount permitted under the Internal Revenue Code (\$23,000 for 2024). In addition, participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 for 2024. Participants may also elect to make Roth deferrals under the Plan. Effective January 1, 2022, participants may also elect an in-plan Roth conversion of their eligible contributions. Amounts representing distributions from other qualified defined benefit or contribution plans are also permitted as contributions. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Companies' contributions to the Plan are at the discretion of the Companies' management. Only those participants who are employed by one of the participating Companies on the last day of the Plan year are eligible for an allocation of the Companies' contributions. Certain participants may be eligible for an allocation of the Companies' contributions subject to certain exceptions.

Participant accounts - Each participant's account is credited with the participant's contributions and allocations of (a) the Companies' contributions, (b) Plan net earnings, and (c) forfeitures of terminated participants' non-vested accounts, and is charged with an allocation of expenses and investment losses, if any. Allocations are based on participant compensation, as defined, or account balances, as provided for in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting - Vesting of the participants' accounts is based on years of continuous service as follows:

Notes receivable from participants - Participants may borrow from their vested benefit accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or (b) 50% of the participant's vested account balance. Note terms range from 1 to 5 years, or up to 30 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and incur interest at ½% to 2% above the prime rate in effect on the date of the loan, as determined by the Plan trustees. Interest rates on participant notes ranged from 5.25% to 10.5% at December 31, 2024 and 2023. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of benefits - Participants who are employees of the Companies are entitled to 100% of their account balance at age 65, or earlier in the event of death or disability. Upon termination of employment, participants whose vested account balance is more than \$5,000 may have their vested account balance distributed to them in a single, lump-sum payment or partial withdrawals or installments, but only with respect to minimum required distributions. Participants who have separated service with the Companies and whose vested account balance is less than \$5,000 may have their vested account balance involuntarily distributed to them in a single, lump-sum payment, in the year subsequent to their separation from service.

Forfeited accounts - As of December 31, 2024, the balance of the forfeiture accounts was \$3,259 (\$82,825 at December 31, 2023). During 2024, forfeitures totaled \$13,864. Investment gains on forfeited funds aggregated \$562 and \$1,560 for the years ended December 31, 2024 and 2023, respectively. Forfeited funds of \$93,560 were used to offset employer contributions in 2024 (none in 2023). There was \$433 paid for fees from forfeited funds during the year ended December 31, 2024 (\$2,886 in 2023).

2. Accounting policies

Basis of accounting - The accompanying financial statements are presented on the accrual basis of accounting and present net assets available for benefits and changes in those assets.

2. *Accounting policies (continued)*

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of investments - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Payment of benefits - Benefits are recorded when paid.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest, if any. Participant loans which, under the provisions of the Plan, are deemed delinquent are reclassified as distributions.

Income recognition - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net increase in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Secure Act 2.0 - In December 2022, Congress passed the Consolidated Appropriations Act of 2023 which contains over 90 new retirement provisions with varying effective dates through 2027. Since the Secure Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the Plan documents accordingly. Certain provisions became effective in 2024 and additional provisions will become effective thereafter. There is no material impact to the Plan's 2024 financial statements. Certain amendments were made to the Plan, effective January 1, 2025.

Subsequent events - The Plan has evaluated subsequent events through October 9, 2025, which is the date these financial statements were available to be issued. All subsequent events requiring recognition as of December 31, 2024, have been incorporated into these statements.

3. *Investments (unaudited)*

At December 31, 2024 and 2023, the Plan's investments were held by the custodian. The Plan's financial information included in the financial statements is based on information certified by the custodian as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

During 2024, the Plan's investments (including investments bought, sold and held during the year) appreciated in value by \$554,321.

4. Fair value measurements (unaudited)

Authoritative accounting guidance sets forth a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Level 3 inputs are used only when Level 1 or Level 2 inputs are not available for specific assets. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. When Level 1 inputs are unavailable, the Plan uses Level 2 inputs. No Level 3 inputs were needed to determine fair value.

At December 31, 2024 and 2023, the fair value of the mutual funds and exchange traded funds are based primarily on the underlying securities the funds holds, which have observable Level 1 and Level 2 inputs. While the underlying asset values are quoted prices, the net asset value of a portion of the mutual funds is not publicly quoted.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Risks and uncertainties

The Plan provides for various investment options including mutual funds, exchange traded funds and a money market deposit account. Such investments are exposed to interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of investments in mutual funds. The Plan has offered Plan participants investment options in various investment vehicles as a means of reducing the effects of such risks.

Funds held in the money market deposit account are insured by the FDIC, by participant, subject to FDIC aggregation rules for other retirement accounts held by each participant at Schwab Bank and as maintained by the Plan's recordkeeper.

6. Related party transactions

The Company pays all of the Plan's administrative expenses and certain investment expenses, with the exception of loan and distribution fees, which are deducted from the associated participant's account. Plan related fees paid or accrued during 2024 by the Company amounted to approximately \$126,000.

The Plan's investments consist of pooled separate accounts and an investment contract with an insurance company, all of which are funds managed by Charles Schwab Trust Bank. Under ERISA, such transactions qualify as party-in-interest transactions.

7. Plan termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

8. Tax status

The Plan is operating under an adoption agreement of a non-standardized prototype plan structured by its third-party administrator. The Internal Revenue Service has reviewed the terms of the prototype plan and has indicated by a letter dated January 12, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to its terms and conditions; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Interim amendments have been applied to the Plan to be in compliance with several recently enacted laws, including the CARES and SECURE Acts.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a tax liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021, generally three years after the Plan filed its Form 5500.
