### Note 1 – Description of the Plan

The following description of the Aurora Organic Dairy Corp. 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan, which went into effect August 29, 2003, that is generally available to all employees of Aurora Organic Dairy Corp. (the "Company", "Plan Sponsor," or "Plan Administrator") and Participating Employers (collectively, the "Employer"). The Plan excludes union employees; nonresident aliens; and reclassified employees. Employees become eligible to participate in the Plan upon attainment of age 21 and completion of three months of service. Eligible employees may enter the Plan on the first day of the month coincident with or following the date they meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

**Contributions.** The following types of contributions are allowable under the Plan:

- Salary Deferral Contributions – Participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan document, subject to limitations. Participants may also contribute a percentage of their after-tax compensation and designate it as a Roth deferral contribution. A participant's total salary deferral contributions cannot exceed \$23,000 (\$30,500 if age 50 or over) in calendar year 2024.
- Employer Safe Harbor Matching Contributions – The Employer makes a safe harbor matching contribution to eligible participants each Plan year equal to 100% of a participant's salary deferral contributions that do not exceed 3% of their compensation, plus 50% of a participant's salary deferral contributions in excess of 3% but not in excess of 5% of the participant's compensation.
- Discretionary Additional Matching Employer Contributions – The Employer may make additional matching contributions to eligible participants each Plan year. Such contribution is limited to 6% of eligible compensation. For the year ended December 31, 2024, the Employer did not make an additional discretionary matching Employer contribution.
- Discretionary Employer Nonelective Contributions – The Company may make a discretionary nonelective contribution to eligible participants who have completed 501 hours of service during the Plan year (with certain exceptions for participants who die, become disabled, or attain normal retirement age during the Plan year) based on a uniform percentage of a participant's compensation (pro-rata) allocation method. No such contribution was made for the Plan year ended December 31, 2024.
- Rollover Contributions – Certain amounts distributed to eligible participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants. The total annual additions to a participant's account may not exceed the lesser of \$69,000 or 100% of the participant's compensation in calendar year 2024.

### Note 1 – Description of the Plan (continued)

**Investment Options.** Participants may currently direct their investments into various mutual funds and any investment offered through the Plan's self-directed brokerage account ("SDBA").

**Participant Accounts.** Each participant's account is credited with the participant's contributions (salary deferrals and rollovers, if any) and an allocation of (a) the Employer's contributions (safe harbor matching, discretionary additional matching, and discretionary nonelective, if any), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 or (ii) 50% of their vested account balance. Loan terms range from 1 month up to a maximum of 5 years (a longer term up to 15 years is available if the loan is being used to acquire a principal residence). The loans are secured by the balance in the participant's account and bear a rate of interest equal to the prime rate plus 1% at the date the loan is granted as determined by the Plan administrator. Principal and interest payments are paid ratably through payroll deductions.

**Payment of Benefits.** Benefits to participants or beneficiaries generally are payable as a lump sum, installments, or partial distributions equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. A terminated employee with a balance of less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Additionally, participants may request in-service withdrawals of their rollover contributions account, upon attainment of age 59½, for a qualified reservist distribution, upon a deemed severance of employment, or for a financial hardship, as defined, if certain criteria are met.

**Vesting.** Participants are immediately vested in their salary deferral contributions, rollover contributions, Employer safe harbor matching contributions, and related earnings thereon. Discretionary Employer nonelective and additional matching contributions are subject to a six year graded vesting schedule, whereas participants become 20% vested after completing two years of service and in 20% increments for each year thereafter. Additionally, employed participants become 100% vested in their accounts upon attainment of normal retirement age and termination or partial termination of the Plan.

**Forfeitures and Unallocated Asset Accounts.** When certain terminations of Plan participation occur, the non-vested portion represents a forfeiture. Forfeitures are used to restore previously forfeited accounts, to pay administrative expenses of the Plan, or used to reduce Employer contributions. During 2024, forfeitures of \$4,511 were used to reduce Employer contributions. The Plan also maintains an unallocated asset account. The balance in the forfeitures and unallocated asset accounts was \$172 and \$3,332 as of December 31, 2024 and 2023, respectively.

### Note 2 – Summary of Significant Accounting Policies

**Use of Estimates and Basis of Accounting .** The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition .** The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions.** Participant contributions and the related Employer matching contributions are recognized in the period in which participant contributions are withheld from compensation.

**Notes Receivable from Participants .** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Benefits Payments.** Benefits are recorded when paid.

**Administrative Expenses .** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Included in administrative expenses are recordkeeping, investment advisor, and other fees. Additionally, certain investment related expenses are included in investment income.

### Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds and money market funds (including those held in the SDBA) are valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.
- Common stock and exchange traded funds ("ETFs") held in the SDBA are valued at the closing price reported on the active market on which the securities are traded.
- Corporate bonds held in the SDBA are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or partial termination, affected participants will become 100% vested in their accounts.

### Note 6 – Tax Status

The Plan Sponsor has adopted an Empower Retirement LLC Non-Standardized Pre-Approved Profit Sharing Plan (“pre-approved plan”). The pre-approved plan received an opinion letter from the IRS on November 14, 2022, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code (“IRC”). Although the pre-approved plan and the Plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 8 – Party-In-Interest Transactions

The Plan's trustee, Empower Trust Company, LLC; the Plan's SDBA custodian, Charles Schwab Trust Bank; the Plan's recordkeeper, Empower Retirement; the Plan's investment advisor; the Plan's auditors; the Plan's external legal counsel; the Employer; and Plan participants are all parties-in-interest to the Plan. Additionally, the Plan maintains notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

### Note 9 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the statements of net assets available for benefits. As of December 31, 2024 and 2023, there was one investment which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

### Note 10 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 17, 2025, which is the date the financial statements were available to be issued.

Effective April 1, 2025, the Plan document was amended to modify the Plan's eligibility from 3 months of service to 1 month of service for employees with a commencement date after April 1, 2025.
