## **1. Description of Plan**

The following description of Epting Distributors, Inc. Employees' Retirement Savings Plan (the "Plan") provides only general information. Participants may refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan sponsored by Epting Distributors, Inc. (the "Company"). The Company is the trustee of the Plan.

Eligibility to participate in the Plan is based on completion of 1,000 hours of service with the Company during a period of twelve consecutive months. Employees may enter the Plan beginning on the January 1st or July 1st immediately following or coinciding with the date eligibility was achieved. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

### **Contributions**

Participants may contribute any percentage of their pre-tax compensation to the 401(k) portion of their account and any percentage of their after-tax compensation to the Roth 401(k) portion of their account, subject to contribution limitations specified by law. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans.

The Company makes matching contributions equal to 100% of participant contributions up to 3% of the participant's first \$50,000 of qualifying compensation, plus an additional amount equal to 50% of participant contributions that exceed 3% and do not exceed 5% of the participant's qualifying compensation. The Company may also make discretionary qualified non-elective and discretionary profit sharing contributions. The Company made discretionary profit sharing contributions of \$126,000 and \$119,000 during the years ended December 31, 2024 and 2023, respectively. No discretionary qualified non-elective contributions were made during the years ended December 31, 2024 and 2023.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, Plan earnings or losses, and an allocation of administrative expenses paid by the Plan. Participants direct their contributions into various investment options offered by the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **1. Description of Plan (continued)**

### **Vesting**

Participants are immediately vested in their salary deferrals and qualified non-elective contributions. Vesting in the Company's matching and discretionary profit sharing contributions is based on years of continuous service. Participants are 20% vested in the Company's discretionary matching and profit sharing contributions after two years of service with additional vesting of 20% for each of the next two years, and are 100% vested after five years of service.

### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are collateralized by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50% as of December 31, 2024. Loan terms are limited to five years, except for loans made for the purchase of a primary residence. A participant may have no more than one note due to the Plan at any time. Principal and interest are paid ratably through payroll deductions.

### **Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may, subject to certain conditions, elect to receive their vested portion of Plan assets under several payout options specified in the Plan's documents. Subject to certain conditions, a participant may receive hardship withdrawals from his or her balance in the Plan while employed. Participants who have attained 59½ years of age are permitted to withdraw all or part of their vested accounts as in-service distributions.

### **Forfeitures**

Participants withdrawing from the Plan with non-vested employer contributions in their account forfeit their share of non-vested contributions and earnings thereon. The Plan's provisions allow these amounts to be used for administrative expenses of the Plan or to reduce any employer contributions. During the years ended December 31, 2024 and 2023, approximately \$16,000 and \$12,000, respectively, in forfeited non-vested accounts were used to reduce employer contributions. No forfeited non-vested accounts were used to reduce administrative expenses of the Plan during the years ended December 31, 2024 and 2023. Unallocated forfeited non-vested accounts totaled approximately \$2,000 and \$1,000 at December 31, 2024 and 2023, respectively.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in discretionary employer matching and profit sharing contributions.

### **Plan Amendments**

Effective October 1, 2024, the Plan was amended to allow participants to make Roth contributions, initiate in-Plan Roth rollovers, and initiate hardship withdrawals using Roth contributions.

### **Reclassifications**

Certain prior year amounts have been reclassified to conform to the current year presentation.

## **2. Summary of Significant Accounting Policies**

### **Financial Statement Presentation**

The Plan's policy is to prepare its financial statements using the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States. Under the Plan's accounting policy, contributions and investment income are recorded as received and expenses are recorded when paid.

### **Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### **Participant Notes Receivable**

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Delinquent participant loans are classified as distributions.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Risks and Uncertainties**

The Plan's investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for plan benefits – modified cash basis. Actual results could differ from those estimates.

### **Payment of Benefits**

Benefits are recorded when paid.

## **3. Custodian Certifications**

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023 related to investments, participant notes receivable, net appreciation in fair value of investments, and interest and dividends, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Plan's custodian, Matrix Trust Company.

#### **4. Fair Value Measurements**

Financial assets are reported at fair value and are classified and disclosed within a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of valuation methodology that are unobservable. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan's mutual fund investments and money market fund were valued using Level 1 inputs, based on quoted net asset values of the shares held by the Plan.

The Plan's investments also include the Galliard Stable Return Fund Class C, which is a collective trust that invests in Galliard Stable Return Fund Core, a collective trust that invests in a variety of fully benefit-responsive investment contracts. Galliard Stable Return Fund Class C is valued at net asset value ("NAV") of units of the accounts. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held less the account's liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the trust, the account provider reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations are carried out in an orderly business manner.

The methods used to measure fair values may produce amounts that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair values of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Party-in-Interest Transactions**

Fees paid by the Plan for custodial, recordkeeping, and investment advisory services amounted to approximately \$34,000 and \$29,000 for the years ended December 31, 2024 and 2023, respectively. The Plan also has participant notes receivable. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transactions rules of ERISA.

## **6. Tax Status**

The Plan is a non-standardized profit sharing plan designed to be in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The non-standardized profit sharing plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (the "IRS") determined that the plan documents and related trust are designed in accordance with applicable sections of the IRC. Although the non-standardized profit sharing plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

During 2024, operational errors were discovered relating to employee contributions that resulted in an underpayment of contributions to the Plan. Additionally, the Plan failed one of the compliance tests, as required by the IRS, which requires the Plan to make a corrective distribution to retain its tax-exempt status. Management has determined that the errors do not have a material impact on the Plan's 2024 financial statements. Management expects to fully correct the 2024 operational errors and make the corrective distributions in 2025 in order to preserve the Plan's tax-exempt status. This includes possible corrective filings with the IRS or the Department of Labor.

The Plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified as of December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any open tax periods in progress.

## **7. Subsequent Events**

Management evaluated events and transactions after December 31, 2024 through October 9, 2025, the date the financial statements were available to be issued, for subsequent events.

A discretionary profit sharing contribution of \$128,000 was paid to the Plan subsequent to year end.

No other subsequent events were noted.
