NOTE 1 – DESCRIPTION OF PLAN

The following description of the OCI Holdings 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of OCI Holdings, LLC (the Company, Plan Sponsor, or the Employer) who meet certain eligibility criteria. The Plan has been amended to include Pathfinder Pediatric Homecare, Inc., Ortho-Tek, Inc., Compliant Billing & Collections, Inc., and the Missing Peace Autism Therapy Center, LLC as participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees of the Company are eligible to participate in the Plan, as well as receive discretionary matching contributions and discretionary non-elective employer contributions upon attainment of twenty-one years of age and completion of one consecutive month of service.

Contributions: The Plan allows participants to contribute up to 100% of their annual compensation, subject to certain limitations of the Plan and the Internal Revenue Code (IRC). The Plan permits participants to direct their elective deferrals to investments, at their discretion, in any combination of funds prescribed by the plan trustees.

The Plan provides an automatic enrollment provision in which all newly eligible employees are enrolled to contribute 6% of their annual salary, unless the participant made an affirmative election otherwise. Contributions are automatically invested in a fund designated by the Plan Administrator based on the age of the employee until changed by the employee. The Plan also includes an automatic escalation provision in which participants are subject to an annual deferral rate increase of 2%, until their deferral rate reaches 10% of eligible compensation. Participants may elect to discontinue their participation in the automatic deferral rate increase at any time.

The Company may make a discretionary matching contribution. The Employer evaluates the match annually and can modify the percentage at its discretion. For the year ended December 31, 2024, the Company did not make a discretionary matching contribution to the Plan. The Company, at its sole discretion, may also make an additional non-elective contribution to be allocated among all Plan participants in the same proportion that each participant's compensation bears to the total compensation of all participating employees for the year. For the year ended December 31, 2024, the Company did not make an additional non-elective contribution to the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions, employer contributions and actual earnings and losses thereon. Allocations of Plan earnings, forfeitures, and Plan expenses are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions and actual earnings and losses thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after three years of continuous service. Participants are also fully vested upon attainment of age 65, death, total and permanent disability or termination of the Plan. Participants are considered to have completed one year of service for vesting purposes upon completion of 1,000 hours of services at any time during the plan year.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Forfeited Accounts: Forfeitures are held by the Plan to determine if amounts should be restored to terminated participants. Forfeitures may be used to pay plan expenses or to reduce employer contributions. There were no forfeitures to report as of December 31, 2024 and 2023.

Notes Receivable from Participants: Participants may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance, excluding Roth contributions. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Principal and interest is paid ratably through bi-monthly payroll deductions for a period not to exceed five years, unless they are used to purchase a primary residence, in which case the Plan Administrator may permit terms up to thirty years. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the current prime rate at the time of the loan. Notes receivable are measured at the unpaid principal balance plus any accrued but unpaid interest. The Plan allows for participants to have two outstanding loans. Notes receivable in default must be paid before another loan may be issued. Delinquent loans are treated as distributions based upon ERISA, Internal Revenue Service (IRS), and Plan document provisions.

Benefit Payments: The Plan provides for normal retirement benefits upon termination of service due to death, disability, or attainment of retirement age. The normal retirement age is the date a participant reaches the age of 65. Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount in cash or as a rollover equal to the value of the participant's vested interest in his or her account or installment payments. Participants may make withdrawals from their account for hardship purposes as defined by the plan document.

In-Service Withdrawals: Participants may elect disbursement of all or part of their vested account balance upon attainment of age 59 ½.

Hardship Withdrawals: Hardship withdrawals from the Plan are permitted from participant accounts. All hardship withdrawals must comply with rules relating to hardships, which are uniformly applicable to all participants.

Plan Termination: Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

Administrative Expenses: Administrative expenses consist of fees for recordkeeping and other administrative services. Some fees are deducted from participant accounts in accordance with the Plan documents for services received. Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Expenses that are paid by the Company are excluded from these financial statements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP). The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Interest-Bearing Cash: Interest-bearing cash may include bank demand deposits accounts, money market accounts and all highly liquid debt instruments purchased with a maturity of three months or less. The Plan's cash balances may at times exceed federally insured limits. The Plan has not experienced any losses in these accounts and believes it is not exposed to any significant risk with respect to cash and cash equivalents.

Investment and Income Recognition: The Plan's investments are reported at fair value as reported by the trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The cost of investments used in determining realized and unrealized gains and losses is based upon average cost. Net appreciation in the fair value of investments consists of both realized and unrealized gains and losses on the Plan's investments.

Fair Value Measurements - Definition and Hierarchy: The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board Accounting Standards Codification 820 (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available.

The hierarchy is broken down into three levels based on the reliability of inputs as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.

Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement. A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

Risks and Uncertainties: Investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amount reported in the accompanying financial statements.

Payment of Benefits: Benefits are recorded when paid.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Interest-Bearing Cash: the carrying amounts of such instruments approximates fair value due to their short maturity (Level 1).

Mutual Funds: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded (Level 1).

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Ascensus LLC, Equitable Advisors, and Sanctuary Advisors LLC are service providers to the Plan and, therefore, fees paid to these providers qualified as party-in-interest transactions. Some administrative expenses of the Plan are paid directly by the Company. Notes receivable from participants also qualify as party-in-interest transactions

NOTE 6 – TAX STATUS

The Plan is qualified under the provisions of the Internal Revenue Code (IRC) and is not subject to federal and state income taxes. Participating employees are not subject to federal and state income taxes on employer contributions, or on income accruing to their accounts, until they receive distributions from the Plan. The IRS issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended since date of the opinion letter, Plan management believes that the plan is qualified and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor or Internal Revenue Service, however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
