## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Preferred Employer Plan for Envios de Valores La Nacional Corp.

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Preferred Employer Plan for Envios de Valores La Nacional Corp., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Preferred Employer Plan for Envios de Valores La Nacional Corp. (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A) GENERAL

The Preferred Employer Plan for Envios de Valores La Nacional Corp. is a multiple employer plan administered by Fiduciary Wise, LLC ("plan administrator"). Envios de Valores La Nacional Corp. (the "Company") is the adopting entity of the Plan. The Plan was established on January 1, 2021 and is a voluntary, safe harbor, defined-contribution savings plan covering eligible employees who are at least 21 years of age and who have completed three months of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code ("Code").

B) CONTRIBUTIONS

Participants may elect to contribute to the Plan a portion of their compensation, as defined by the Plan, on a pre-tax or after-tax (Roth) basis, subject to Internal Revenue Service ("IRS") limitations. Additionally, participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contribution). Catch-up contributions are permitted for participants who are 50 or older during the Plan year. The total maximum allowable contribution per participant to the Plan directly from the participant was \$23,000 for the fiscal Plan year, not including additional catch-up contributions allowed for participants over the age of 50, which were \$7,500.

The Company funds safe harbor matching contributions equal to 100% of the first 4% of participants eligible compensation. The Company made safe harbor matching contributions of approximately \$161,000 for the year ended December 31, 2024. The Company may also make additional discretionary, profit-sharing contributions to Plan participants employed on the last day of the Plan year. Discretionary, profit-sharing contributions, if made, are based on gross compensation for eligible participants as a percentage of total compensation of all participants eligible to share in the profit-sharing contributions. There were no discretionary or profit-sharing contributions made during the year ended December 31, 2024.

C) PARTICIPANT ACCOUNTS

Each participant's account in the Plan is credited with the participant's contribution, an allocation of any Company contributions and the Plan's earnings and charged with benefit payments and an allocation of the Plan's losses and administrative expenses. Plan earnings and losses are allocated based upon account balances while contributions are credited based upon elective deferrals and compensations, as defined. Administrative expenses are charged directly to the accounts of the participant who incur those fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

D) INVESTMENT OPTIONS

Participants may direct their elective contributions, rollovers, if any, as well as Company contributions to the Plan in a variety of investment options as more fully described in the Plan document. Participants may change their investment options and deferral percentages at their discretion.

E) VESTING

Participants are immediately vested in their contributions, the Company’s safe harbor matching contributions, plus actual earnings thereon. Vesting in employer discretionary and profit-sharing contributions plus actual earnings thereon is based on years of continuous service. Vesting in the Company’s discretionary matching and non-elective contributions is as follows:

Participants are 100% vested, regardless of years of service, when they reach normal retirement age, are totally and permanently disabled, or death occurs.

Benefits are payable on termination of service due to retirement, termination, disability or death. Participants or their beneficiaries may elect to receive a lump-sum distribution, equal installments or partial withdrawals as defined in the Plan document. Eligible participants may also make hardship withdrawals, as defined.

G) NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding balance of loans in the past 12 months or 50% of the value of their vested account balance immediately before the request to borrow funds. Loans must have a definite repayment period not to exceed five years, unless the loan qualifies as a home loan. The notes are secured by the vested balance in the participant’s account and bear interest at a fixed rate similar to a bank’s rate for a comparable personal loan. Participants may only have one loan outstanding at any one time. Loan repayments are made through payroll deductions and are credited to the participant’s 401(k) account.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

H) FORFEITED ACCOUNTS

Pursuant to the Plan, forfeited non-vested accounts may be used to pay Plan expenses or reduce employer contributions. At December 31, 2024 and 2023, the Plan had no remaining forfeitures and no forfeitures were processed during the year ended December 31, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

A) BASIS OF ACCOUNTING

The Plan's financial statements are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America for employee benefit plans.

B) USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

C) INVESTMENT VALUATION AND INCOME RECOGNITION

Investments of the Plan are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amounts participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividend and interest income are recorded by the trustee in the period earned. Net realized and unrealized appreciation or depreciation in fair value of investments consists of the change in unrealized appreciation or depreciation and the realized gain or loss on the sales of investments during the year. Acquisition costs are included in the cost of investments purchased and sales are recorded net of selling expenses. Investments are self-directed by the individual Plan participants.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

D) NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. During the year ended December 31, 2024, approximately \$13,000 in participant loans were recorded as benefit payments.

E) PAYMENT OF BENEFITS

Benefits are recorded when paid.

F) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

G) ADMINISTRATIVE EXPENSES

The Plan agreement allows for the Company to absorb a significant amount of the Plan's administrative expenses and are therefore excluded from these financial statements. During the year ended December 31, 2024, approximately \$41,000 in administrative expenses were incurred by the Plan.

H) RECENT ACCOUNTING PRONOUNCEMENTS

The Company evaluates new accounting pronouncements for relevance and impact on the Plan's financial statements. Management does not expect that timely adoption of new pronouncements will have a material impact on the Plan's net assets available for benefits.

I) RECLASSIFICATION

Certain accounts in the prior-year financial statements have been reclassified for comparative purposes to conform with the presentation in the current-year financial statements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

J) MANAGEMENT REVIEW OF SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 9, 2025, the date when the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. During 2024 and 2023, Level 1 and 2 inputs were available and therefore used. No level 3 inputs were used by the Plan.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds - Mutual funds are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

Collective investment trusts – Collective investment trusts (“CIT”) are valued daily based the Plan’s units in the underlying investments held in the trust.

NOTE 4 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a traditional fully benefit-responsive investment contract with Nationwide Life Insurance Company with a balance of \$80,763 and \$102,746 as of December 31, 2024 and 2023, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issue is contractually obligated to repay the principal and specified interest rate that is guaranteed by Nationwide Life Insurance Company. The crediting rate is established for a three-month period of time.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent upon the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its financial obligations may be affected by future economic and regulatory developments.

The contract does not have a maturity date and is in force until all monies are distributed and no further payments are required. The contract does not require the Plan to distribute at contract value at some specified future date. In addition, the participant can request a lump sum distribution with an adjustment made for market value or an installment payout at contract value over a specified period of years.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan, (2) the establishment or activation, or material change in, any Plan investment fund, or (3) an amendment to the Plan or change in the administration or operation of the Plan, including the removal of a group of employees from the Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan is not aware of any events that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with participants.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to suspend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 - TAX STATUS

The Plan has adopted a non-standardized pre-approved profit-sharing plan, which has obtained a favorable IRS opinion letter on June 30, 2020, in which the IRS stated that the form of the Plan was acceptable under Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believe that the Plan is qualified and the related trust is tax-exempt. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are fully benefit-responsive investment contracts managed by Nationwide Trust Company, the appointed custodian of the Plan's assets as of December 31, 2024 and 2023. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants are also considered party-in-interest transactions.

NOTE 8 - FIDELITY BONDING

The Company maintains a fidelity bond of \$250,000 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA. The policy has a provision whereby loss coverage is increased to the minimum required by ERISA up to the \$500,000 limit.
