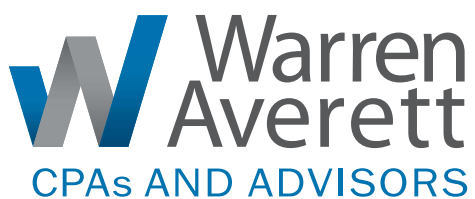

## INDEPENDENT AUDITORS' REPORT

To the Board of Directors  
Troutman Pepper Defined Contribution Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Troutman Pepper Defined Contribution Plan (the Plan) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

**1. DESCRIPTION OF PLAN**

The following description of the Troutman Pepper Defined Contribution Plan (f/k/a Troutman Sanders LLP Cash or Deferred Profit-Sharing Plan) (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the provisions of the Plan.

The Plan is a defined contribution plan covering all partners and non-partner employees of Troutman Pepper and is subject to the provisions of the Employee Retirement Income Security Act of 1974, (ERISA) as amended. The Plan, established effective January 1, 1972, provides retirement, disability, termination and death benefits.

Effective July 1, 2020, Troutman Sanders LLP acquired all of the assets and liabilities of Pepper Hamilton LLP. In connection with the acquisition, Troutman Sanders LLP was renamed Troutman Pepper Hamilton Sanders LLP (the Partnership or Plan Sponsor).

**Administration**

The Partnership's Retirement and Disability Committee (the Committee) serves as the Plan administrator. The Policy Committee of the Partnership, after receiving joint recommendations from the Chair and Managing Partner, appointed the members of the Committee. Vanguard Fiduciary Trust Company (Vanguard) serves as trustee of the Plan.

**Eligibility**

All regular full-time or regular part-time: (1) Common Law Employees, as defined, (2) individuals employed by Corporate Partners, as defined, and (3) Partners, as defined, are eligible to make deferral contributions to the Plan as of the first day of the month following 30 days of service with the Partnership. Eligible participants, as defined, are automatically enrolled in the Plan with a default contribution rate of 3% of his or her basic compensation, as defined. Discretionary employer contributions are allocated to those employees (other than non-partner attorneys and principals) who: (1) complete two years of service; (2) complete at least 1,000 hours of service, as defined, in each of those two years and in the Plan year; and, except for employees who die, become totally or permanently disabled, or attain normal retirement age during the Plan year, (3) are actively employed on the last day of the Plan year.

The eligibility requirements for partners to participate in the Plan for purposes of sharing in the profit-sharing contributions made by the Partnership are the completion of at least 1,000 hours of service, as defined, and, except for partners who die, become totally or permanently disabled, or attain normal retirement age during the Plan year, are employed on the last day of the Plan year.

**Contributions**

Each year, the Partnership may, at its sole discretion, make a profit-sharing contribution equal to a percentage of eligible employees' compensation to the Plan, not to exceed the maximum amount deductible from its income for such year as set forth in the Internal Revenue Code (the IRC). Participants may make tax-deferred contributions subject to limitations of the IRC.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also elect to make after-tax Roth contributions also subject to IRC limitations. All partners, as defined, have mandatory profit-sharing contributions to the Plan. These contributions are based on a formula, which is based on the partner's projected taxable income. These contributions are withheld evenly from March through December from each partners' distribution or draw and deposited in an interest-bearing account, which is a general asset of the Partnership. The contribution is then allocated to the Plan in January of the following year. Once contributed to the Plan, the assets are immediately subject to the investment direction of the participants.

**Participant Accounts**

Participants may direct their investments into a variety of common collective trust and mutual funds.

Each participant's account is credited with the participant's contribution, allocation of the Partnership's contribution and Plan earnings. With respect to the Partnership's contributions, allocations are based on each participant's compensation. With respect to Plan earnings, allocations are based on account balances, as defined. Each participant's benefit to be provided is the total of the participant's vested account balance.

**Notes Receivable from Participants**

A participant may have no more than two loans outstanding at any time. All loans must be repaid within five years, except those used to acquire or construct a principal residence, which must be repaid within 15 years. The maximum loan that will be made to a participant is \$50,000, reduced by the participant's highest outstanding loan balance under the Plan during the prior 12 months. In no event, however, shall a participant's outstanding loan balance exceed 50% of the present value of the participant's vested accounts under the Plan. The minimum amount of any loan made to a participant is \$1,000. The interest rate will bear a reasonable rate of interest as prescribed by current lending rates at the time the loan is granted. Principal repayments and interest are repaid by a participant via payroll and are credited to the participant's account.

**Vesting**

Participants are immediately vested in their voluntary tax-deferred contributions, their voluntary after-tax Roth contributions and Partnership contributions and the earnings thereon.

**Benefit Payments**

Benefits are payable to the participant or beneficiary at the time of retirement, disability, termination or death. The Plan also allows for in-service withdrawals due to hardship or upon reaching normal retirement age, as well as in-service withdrawals of rollover funds at any time. Benefit payments are made either in a lump sum, periodic installments or a combination of the two.

**Plan Termination**

Although it has not expressed any intent to do so, the Partnership reserves the right to terminate the Plan at any time subject to the provisions of ERISA by action of its Committee. Upon termination, participants will remain 100% vested in their accounts.

These accounts, which are nonforfeitable, will continue to accrue investment earnings until benefits are paid in accordance with the terms of the Plan.

**Administrative Expenses**

Certain of the Plan's administrative expenses are paid by the Partnership. Expenses not paid by the Partnership are paid by the Plan. The Plan also uses a revenue credit account whereby funds are utilized to pay administrative fees. For the year ended December 31, 2024, the Plan paid approximately \$93,000 in fees through the revenue credit account. As of December 31, 2024, and 2023, the balance in the revenue credit account is approximately \$61,000 and \$114,000, respectively.

**Income Tax Status**

The Plan has received a determination letter from the Internal Revenue Service (IRS), dated August 2, 2022, stating that the Plan, as designed, is in compliance with the applicable requirement of the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended subsequent to receipt of the determination letter; however, the Committee believes the Plan is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America (GAAP) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with GAAP.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates that may affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on an ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**3. INFORMATION CERTIFIED BY TRUSTEE**

Certain information related to investments from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee of the Plan.

**4. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, *Fair Value Measurements (ASC 820)*, defines fair value, establishes a framework for measuring fair value and requires additional disclosures about the use of fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.
- Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are observable as of the reporting date. These inputs include quoted prices for similar assets in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued based on quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end.

*Common collective trust funds:* Valued at NAV (as a practical expedient) as determined by the issuer based on fair market value of the underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. PARTY-IN-INTEREST TRANSACTIONS

As of December 31, 2024 and 2023, Vanguard served as the Plan trustee, respectively. The Plan paid fees to both providers in the respective years and held investments with affiliates of the trustees. As such, these, transactions qualify as party-in-interest transactions. In addition, the Plan holds investments managed by the trustee, which also qualify as party-in-interest transactions.

## 6. SUBSEQUENT EVENTS

Effective January 1, 2025, Troutman Pepper Hamilton Sanders LLP, a Georgia limited liability partnership, acquired certain assets and liabilities of Locke Lord LLP, a Delaware limited liability partnership. In connection with the acquisition, Troutman Pepper Hamilton Sanders LLP was renamed to Troutman Pepper Locke LLP and the Plan renamed to the Troutman Pepper Locke Defined Contribution Plan. Effective September 2, 2025, the Locke Lord LLP Retirement Savings Plan merged with and into the Plan.

Management evaluated subsequent events for the Plan through September 29, 2025, the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure under FASB ASC Topic 855, *Subsequent Events*.
