## Notes to Financial Statements

---

### Note 1: Plan Description

The following description of Integrated Financial Settlements, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Integrated Financial Settlements, Inc. ("IFS"), Arcadia Settlements Group, Inc. ("ARC"), JMW Settlements, LLC ("JMW"), and Structures Settlements, Inc. ("SSI"), (collectively, the "Company" or the "Employer"), who are age eighteen or older.

The Plan is subject to the provisions of the Employee Retirement Income Security Act ("ERISA"), as amended. The Plan is administered by an Employee Benefits Administrator Committee (the "Plan Administrators") comprised of persons appointed by the Company. The Plan Administrators are responsible for oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitor investment performance.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions to elect in the future.

#### Contributions

Each year, eligible participants may elect to make pre-tax and after tax contributions of their annual compensation, as defined in the Plan, up to a maximum amount adjusted annually by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined compensation plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation. The contribution rate increases annually by 1% up to a maximum of 5%.

The Company may make discretionary matching contributions to plan participants as determined by the Company annually. For the year ended December 31, 2024, the Company approved a discretionary matching contribution equal to 2% of participant's eligible compensation, as defined. In addition, the Company may make a discretionary profit sharing contribution to plan participants. There were no discretionary profit sharing contributions during 2024.

### Note 1: Plan Description (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, and an allocation of the Company's discretionary profit sharing contributions and plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions and Company discretionary matching contributions, plus actual earnings thereon. Vesting in the Company discretionary profit sharing contributions is based on years of service. Participants vest at a rate of 20% per year after two years of service. Participants become fully vested after six years of service. Participants also become fully vested upon death, disability, or normal retirement age.

#### Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at current market rates, as defined by the Plan, ranging from 4.25% to 10.50% at December 31, 2024, determined at the date of the loan. All loans must have a definite repayment schedule, generally not exceeding five years. Principal and interest is paid ratably through biweekly or semi-monthly payroll deductions.

#### Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments as defined by the Plan. If the participant's account balance is below \$5,000 (\$7,000 effective January 1, 2024), the participant will receive a lump-sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### Forfeited Accounts

At December 31, 2024 and 2023, there were no forfeited, nonvested accounts. These accounts may be used to pay administrative expenses or used to reduce future Company contributions. In 2024, there were no unallocated accounts used to reduce Company contributions and pay administrative expenses.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments, other than the fully benefit-responsive investment contract (FBRIC), are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The FBRIC is reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments and administrative expenses.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

### Note 3: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments, fully benefit-responsive investment contract, and notes receivable from participants held at December 31, 2024, and net appreciation of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by The Standard Insurance Company ("The Standard"), the Trustee of the Plan. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Minnesota Life Insurance Company, the former Trustee of the Plan.

### Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

***Mutual Funds Held in Pooled Separate Accounts:*** Fair value of mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts. The underlying mutual funds held in the pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

***Self-Directed Brokerage Account:*** Accounts primarily consist of the mutual funds and common stocks that are determined by obtaining quoted prices on nationally recognized securities exchanges.

### **Note 5: Fully Benefit-Responsive Investment Contract** (Continued)

**Traditional Guaranteed Investment Contract:** The Plan holds a fully benefit-responsive investment contract with Minnesota Life Insurance Company at December 31, 2024 and 2023. Minnesota Life Insurance Company maintains the contributions in its general account and guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated annually based upon contract provisions, and it may not be less than 1.50%. Minnesota Life Insurance Company's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include plan termination, plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which The Standard may terminate the contract. Examples of circumstances which would allow The Standard to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, The Standard could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

### **Note 6: Related-Party Transactions and Party-in-Interest Transactions**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. The Standard is the Plan's Trustee. Transactions with The Standard qualify as party-in-interest. Fees paid by the Plan to the Trustee for administrative expenses and investment management services totaled \$70,604 for the year ended December 31, 2024. The Plan also holds a fully benefit-responsive investment contract which was issued by the Minnesota Life Insurance Company, which constitute party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### Note 8: Tax Status

The Plan has adopted a non-standardized pre-approved plan with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
